Mr. Margulies said that the church would welcome any funding, but a reduced amount would need be supplemented by fundraising. Ms. Ciesla asked how urgent the project was and if it could wait until next year. Mr. Margulies stated that the window is not an emergency situation, but the longer it waits, the more work it could potentially need.

Mr. Margulies stated that the roof project is fairly urgent. The Township plans to do something with the building in the future, but they have no specific plans yet. Mr. Tierney noted that it is up to the Board to determine if the extent of public use/accessibility is sufficient. Ms. Smolha noted that the blacksmith shop has a metal roof and if painted, they can last quite a while. Mr. Margulies said that they would like to replace the roof instead of spending money on painting when it will eventually get thrown away; the current roof was only intended to be temporary. Ms. Neumann inquired about the masonry in the request. Mr. Margulies said that is masonry work near the top that couldn't be repaired until the roof is replaced.

Ms. Neumann is recommending Van-Nest Hoff-Vannatta receive full funding. Mr. Tierney's only concern is that painting of the barn is considered maintenance, which is not eligible for funding. Most of the request is for labor for the barn door project. The doors themselves are being donated.

Ms. Ciesla recommends that Union Station receive \$100,000.00, instead of the 50% amount of \$75,000.00.

There was discussion regarding which projects to prioritize for building envelope and stabilization to weather proof them from further deterioration and how to split up the balance of funding.
