MINUTES: The October 6, 2014 minutes were reviewed. Mr. Tersigni motioned, seconded by Mrs. Demeter, to approve the minutes as presented. Motion carried.

CORRESPONDENCE:

A letter from Bonnie Butler, the Mayor of Franklin Township was sent to Mr. Tierney to inform him that the township is awaiting delivery of a Green Acres sign to be installed at the property, upon receipt. Ms. Miller has agreed to meet with her.

An email from Mike King of Phillipsburg was shared with the Committee (see attached). Mr. King sent a letter to the local newspaper and to the Board of Chosen Freeholders regarding the importance of preserving open space. The Committee reviewed and acknowledged receipt of the letter.

2014 MCCTFC Grant Funding Recommendations: 2014 Chairman Fineran thanked Mr. Tierney, his staff, and all of the Committee members for being a very active and dedicated group of participants.

Mr. Tierney distributed a spreadsheet with the grant balance after fully-funding the Vass House project for \$18,000 at the last meeting, along with the original funding requests and 60/40% revision requests for the remainder of eligible applicants. If all of the remaining projects are funded at the lowest percentage possible, there would still be an approximate \$60,000 shortfall.

Mr. Cartabona suggested that Frelinghuysen Township's request be reduced by 25% (\$68,750), since they were the only applicant who did not reduce their original request of \$275,000. That would eliminate the \$60,000 shortfall and the remainder of the funding could go to Mount Bethel Church.

Ms. Demeter asked what happens if one or more Committee members don't agree with the proposed funding recommendations or if there are specific projects that members feel should <u>not</u> get funded at all. Mr. Tierney explained that the Committee can take a poll to see what projects they do or do not want to fund and make up the shortfall that way. Recommendations are determined by majority vote.

Mr. Cartabona motioned, seconded by Ms. Miller to request a straw poll, by show of hands to see if there are any projects that members do not want to fund at all. Mr. Fineran asked by show of hands, how many members feels that a project should not receive funding (seven members raised their hands).

Since a majority of the members have at least one project that they do not want to fund, a roll call for each remaining project will be done to determine which projects will NOT receive any funding.

The balance of \$148,378.65 in MCCTFC funds will be rolled over to 2015.

Mr. Cartabona expressed his concern that no open space projects were funded this year; that open space isn't forever. It gets purchased and developed and can affect future opportunities.

Mr. Tersigni said that if open space parcels get purchased and developed into a commercial property and can help taxpayers. Historic preservation is the main focus now; he feels that there is already a lot of open space.

Chairman Fineran will stated that the rules for funding projects were sent out and the Committee had plenty of time to review them.

Mr. Tierney noted that several members' terms are expiring on March 25, 2015. Chairman Fineran thanked Desiree Denker, Ellen Demeter, Timothy Bodine, and Todd Tersigni for their participation on the Committee. Recruitment letters will be sent out in January for those membership slots.

The next meeting is scheduled for April 6, 2015.

Ms. Smolha noted that this is the first year, in the ten years she has been on the Committee, that no open space projects were funded. The Committee did not cheat open space.

There being no further business, Ms. Demeter made a motion, seconded by Mr. Cartabona to adjourn the meeting at 8:34 p.m.
