Meeting Minutes June 19, 2014

The regular monthly meeting was held at the office of the Department of Land Preservation, 500 Mt. Pisgah Avenue, Oxford, New Jersey. The meeting was called to order by Chairman Schnetzer at 7:32 p.m. An announcement was read as required by the Open Public Meetings Act, N.J.S.A. 10:4-6-21.

Chairman Schnetzer led the Pledge of Allegiance.

Memorialization of Certification of Commercial Farm

Randy & Laura Hoff, Castle Ridge Farm, BL 26, L 19, Harmony Twp. Site Specific Hearing — Mr. Warren swore in Mr. Hoff and asked him to state his name and address. Mr. Hoff replied that his name was Randy Hoff and he lived at 732 Ridge Road in Phillipsburg, NJ. Mr. Hoff stated to the Board that he wanted to put in an indoor equine riding area over the existing outdoor equine riding area so that they could ride horses year round. Ms. Willever asked Mr. Hoff about parking areas, seepage pits and manure storage. Mr. Hoff replied that both the lots on the map were existing parking lots, that the seepage pits are recharged and are at least 20 feet or further away from the building and that the manure storage is block storage composted and spread twice a year on the hayfield. Chairman Schnetzer asked if there were any further questions that the Board may have for Mr. Hoff. No more questions were posed by the Board. Chairman Schnetzer asked for a motion. Ms. Willever made a motion to approve the construction of the 180' L X 27' H X 80' W with an 8' W x 40' L porch totaling 14,800 square feet equine indoor riding area as long as all health and safety codes were met. Mr. Gourniak seconded the motion.

Mr. Hoff asked about getting a letter from the Board to the zoning officer stating his approval pending the memorializing of the Board's action this evening at the next meeting. Mr. Tierney stated that he would prepare a letter. Chairman Schnetzer advised Mr. Hoff that the township has 45 days after the approval of the resolution to appeal the CADB's decision if they wish.

Kenco 8-Year Farm Termination, BL 1 L 16, Liberty Twp. 17 acres — Doug Kenny of Kenco Land Partnership, LP in Great Meadows had entered into the 8 Year Program in 1998 and renewed again in 2006, but has decided to not renew the agreement for another eight years and instead terminate his agreement in the program. Mr. Gourniak made a motion to accept the termination of Kenco, BL 1 L 16, Liberty Twp. from the 8-Year Farmland Preservation Program. Mr. Menegus seconded the motion.

CADB Farmland Applications

Tasevski – BL 39 L 5, Franklin Twp., 88.7 gross acres – This application meets the minimum eligibility criteria of 25 tillable acres or 50% of the land whichever is less and has a County rank score of 65.83. There are 51.81 tillable acres used for corn, wheat & soybeans and 28.08 acres of woodland, with Prime Soil consisting of 62.35 acres and 22.86 acres of Statewide soil. There are two barns and one garage on premises to be preserved. The landowner is taking a 1.5 acre non-severable exception area for future SFR. There will need to be a ROW driveway easement to adjoining Lot 11, a gas line easement and a Category One Stream located on Pohatcong Creek. This farm is located in the Highlands Planning Area and in the Southeast project area.

Mr. Gourniak made a motion to approve the Tasevski County Farmland Application and for submission to the SADC for preliminary Green Light Approval. Mr. Gourniak seconded the motion.

Estate of Mary Kinney, BL 6 L 1 Knowlton Twp. & BL 508 L 7, Blairstown Twp., approx. 34 acres – The
potential buyer of the property has asked that the 1.5 acre exception area be located on the hill. The current
landowner has approved the change in the location.

Mr. Gourniak made a motion to approve the relocation of the exception area to the hill on the Estate of Mary Kinney County Farmland Application. Mr. Bodine seconded the motion.

— Sam & Jean Race, BL 16 L 42, White Twp. approx. 85 gross acres — Mr. Tierney stated the SADC disagreed with the chronological events of the application. Mr. Tierney stated that the CADB would need to rescind the application and approve of a new application dated June 18, 2014 and that this would be acceptable to the SADC and they requested a new application and Schedules A-C with current date and signatures and that they would keep everything else the same and that it did not need to be reappraised and the application could continue on in the process. This farm is awaiting CMV.

Mr. Gibbs made a motion to rescind the 2013 Sam & Jean Race County Application. Mr. Gourniak seconded the motion.

Oberly Farmland Application, BL 95 L 2 & 2.06, Pohatcong Twp. & BL 97 L 5, Alpha Borough, approx. 91 acres – Mr. Tierney stated some projects had fell through at the State and that it freed up 5 million dollars for the State for direct purchases. Oberly's application ranked very high and the SADC would like to purchase it directly and would like the CADB, and Pohatcong and Alpha's support in doing so. Mr. Menegus made a motion to support the Oberly Farmland Application for SADC Direct Application purchase. Mr. Bodine seconded the motion.

Mr. Tierney stated that there will be no cost-share from the County, the SADC will pay 100% of the development easement on the farm.

MUNI PIG Balance Discussion – Mr. Tierney state that the municipalities are at risk of losing their 2009 and 2011 grant balance funding from the SADC and that they may be reallocated to other municipalities in other counties. They are at risk due to lack of applications. Mr. Tierney inquired with the State about reallocating the municipality money to the County. The SADC did not agree with that suggestion for reallocating the funds. The 2013 grants are safe.
