Meeting Minutes August 21, 2014

The regular monthly meeting was held at the office of the Department of Land Preservation, 500 Mt. Pisgah Avenue, Oxford, New Jersey. The meeting was called to order by Chairman Schnetzer at 7:35 p.m. An announcement was read as required by the Open Public Meetings Act, N.J.S.A. 10:4-6-21.

Chairman Schnetzer led the Pledge of Allegiance.

CADB Application Approval -

• RLL Enterprises, LLC – BL 51 L 4, Franklin Twp., approx. 50.67 gross acres – This application meets the minimum eligibility criteria of 25 tillable acres or 50% of the land whichever is less and has a County rank score of 61.48. There are 29.88 tillable acres used for hay and 16.6 acres of woodland, with Prime Soil consisting of 30.18 acres and 19.34 acres of Statewide soil. There are no structures on the premises to be preserved. The landowner is taking a 1 acre non-severable exception area for future SFR. The Musconetcong River UNT, Category One Stream is within the property and boundary line. This farm is located in the Highlands Planning Area and in the Southeast project area.

Mr. Baduini made a motion to approve the RLL Enterprises, LLC County Farmland Application on the condition of the access of driveway from Halls Mill Road to the exception area and for submission to the SADC for preliminary Green Light Approval. Mr. Menegus seconded the motion.

Cericola Farm - to be discussed in Executive Session.

Round Hill Farm – Blairstown & Hardwick Twp. – This is one of the Ridge & Valley Conservancy farms that they have asked the County to take ownership of the development easement. The landowner has merged a .79 acre pasture that is not preserved into the preserved piece. The landowner is asking for approximately \$3,000 for the additional acreage. Ms. Campbell stated that the lot line adjustment to add the additional acreage might be a violation of the deed of easement.

The CADB asked how this was allowed by the township on a preserved piece of property. The CADB members discussed the costs of getting an appraisal, getting a new title policy, etc. would likely cost the County more than the \$3,000 that the landowner is requesting. The members discussed that the landowner donate the acreage since it was done after preservation. Mr. Gourniak made a motion to recommend to Mr. Tierney that they find an alternative solution and that

the CADB is not interested in paying the added acreage without an updated appraisal value. Mr. Baduini seconded the motion.

Drainage Issues – Mr. Tierney stated that the some preserved farms are having drainage issues and that the County Engineer has asked for some remedy. Mr. Tierney has referred the landowners to Dan Mull of NRCS to develop or update their conservation plans to address the problems. Mr. Tierney noted, however, that if a landowner is not cooperative, the CADB may wish to consider enforcing deed of easement provisions in order to protect the soils on preserved farms. The Board members suggested that Mr. Tierney contact both Warren County Soil District and NRCS for assistance with this issue.

SADC SSAMP Checklist – The Board members, Mr. Tierney and Ms. Campbell looked over the documents and discussed some of the items listed. Ms. Campbell stated that the list was a suggestion and would depend on each individual case on what would be needed for submittal of the SSAMP Hearing.

Mr. Menegus informed the Board that Maureen Heritage's 186 acre farm in Franklin Twp. is up for sale and that maybe the County reach out to her about preservation.

Ms. Campbell informed the Board that Harmony Twp. is having a public auction on the first Tuesday of September regarding a 5 year farming lease on the Sakele and Denjoe preserved farms.

Mr. Gourniak made a motion to offer Mr. Cericola \$6,000/acre on the 30.5 acre application. The CMV is \$5,750. Mr. Menegus seconded the motion.
