The Board of Chosen Freeholders of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on February 11, 2020 at 7:00 p.m.

The meeting was called to order by Director Gardner at 7:06 p.m., and upon roll call, the following members were present: Freeholder Jason Sarnoski, Freeholder James Kern, III, and Freeholder Richard Gardner. Also attending were County Administrator Alex Lazorisak, County CFO Kim Francisco and County Counsel Joe Bell. County Engineer Bill Gleba was absent.

Following the flag salute, Mr. Gardner read the following OPEN PUBLIC MEETINGS ACT (Open Public Meetings Act, Chapter 231, P.L. 1975) statement: ADEQUATE NOTICE OF THIS MEETING OF FEBRUARY 11, 2020 WAS GIVEN IN ACCORDANCE WITH THE OPEN PUBLIC MEETINGS ACT BY FORWARDING A SCHEDULE OF REGULAR MEETINGS OF THE BOARD OF CHOSEN FREEHOLDERS TO THE WARREN COUNTY CLERK, THE STAR-LEDGER, AND DAILY RECORD AND BY POSTING A COPY THEREOF ON THE BULLETIN BOARD IN THE OFFICE OF THE BOARD OF CHOSEN FREEHOLDERS. FORMAL ACTION MAY BE TAKEN BY THE BOARD OF CHOSEN FREEHOLDERS AT THIS MEETING. PUBLIC PARTICIPATION IS ENCOURAGED. With a large number of the public in attendance, Mr. Gardner provided some parameters before opening up the floor to public comments. He correctly assumed that most individuals were interested in item E-3 on the agenda, a Resolution Declaring the County of Warren a Second Amendment County. He asked that each person keep his/her comments to three minutes or less. He asked for people to behave in an orderly fashion and clearly state their names for the record.

# PUBLIC COMMENTS (AGENDA ITEMS ONLY)

Anna Babitsky of Independence asked if the 2A resolution was intended to override New Jersey gun laws. Mr. Gardner said no; it was merely a statement by the county saying we believe in the Constitution as it was drafted. It doesn't change the law. In that case, Ms. Babitsky asked, why put this resolution on paper? Mr. Sarnoski said from his perspective, this is reaffirming his commitment to the Constitution of the United States, which as a Freeholder, he has taken an oath to uphold. "This is something that I believe very strongly in, our Second Amendment rights, and I believe that the State of New Jersey continues to infringe upon," he said, adding he specifically opposed Assembly Bill 6003, currently before the NJ State Assembly.

Ms. Babitsky said as a non-gun owner, she felt this was infringing on her rights. She asked if the Freeholders were familiar with the Facebook group named 'Warren County NJ 2A Sanctuary'. She said it has been sparking a lot of hate, and she was fearful. "I moved here two years ago from New York State, where I never had to deal with issues like this," she said, and wondered if she made a mistake in moving here. She left a printout of some of the activity on the Facebook page, as she thought the Board should be aware of it.

Aaron Hyndman of Hackettstown welcomed all visitors to Warren County, saying we take pride in the way we conduct ourselves. We can disagree very respectfully and passionately, and he encouraged all visitors to do the same. While the title of the 2A resolution appeared on the agenda, Mr. Hyndman thought copies of the full resolution should have been made available to the public, or should be read into

the record, so people know what they are actually commenting on. Lacking that, he thought the item should be tabled until the Freeholders were "properly prepared to debate this for the public," said Mr. Hyndman. He thought this was a waste of time, particularly when there was an important White Township Planning Board meeting happening right now.

"Nothing on a Freeholder agenda is up for debate," Mr. Sarnoski said, "This isn't a debate we're having with the residents of Warren County." He explained these are resolutions on an agenda set by the Freeholders, to be voted on by the Freeholders. Members of the public are free to comment and state their feelings, but it's not a debate. Mr. Hyndman continued to press his point, saying, "You guys are doing this all wrong," adding Freeholder Kern was striving for transparency, and there was no PDF link to the resolution on the website. He thought this matter was not appropriately transparent and that it was improper to have public comments when people don't know what they are commenting about.

Susan Yetter of White Township said she had 30 years of experience in the telecom industry, as well as having sat on various county and municipal boards. She wanted to take emotions out of the conversation. She said she thought guns were old technology. "If you think the government wants to take your guns, and the way to protect yourself is have a militia, you're wrong," she said. Ms. Yetter said the federal government was buying commercial personal cell phone data, with apps collecting data about us and can pinpoint our location. "While we are sitting talking about the Second Amendment, our Fourth Amendment privacy rights are crumbling," she said. If the reason for this proposed 2A resolution was to protect our Constitutional rights, Ms. Yetter asked if the Board was willing to take the time to adopt other resolutions, such as our right to privacy. She submitted a draft resolution regarding the Fourth Amendment. "But I really would like for you guys to focus on Warren County issues because this is what we elected you for, and this is why we vote," she said.

Matthew Davis of Washington Township read from a prepared statement, saying for the past 20 years he has experienced many threats to his ability as a free citizen to own and bear arms. He said some of it is rhetoric, some is not, such as owning property that was once legal becoming illegal with the stroke of a pen. "New Jersey has increasingly infringed on many of my rights, but I'm here to ask for help in giving me a voice in concerting my lost Second Amendment rights," he said. Mr. Davis continued on to provide historical examples and reasoning for his opinion that his Godgiven rights were being infringed, and that he supported the resolution under consideration by the Freeholders.

Carolyn Cerbone of Belvidere said she grew up in this area, shot her first shotgun at age 11, and was taught gun safety by her grandparents on their Warren County farm. Having moved to Morris County at one point, she said she moved back to raise her children here, since it was a safe community. Ms. Cerbone thought if the Freeholders truly wanted to inspire change in the gun laws, they should run for Assembly or write our Assembly members. She thought this resolution was strictly symbolic, a waste of taxpayer time and money, and she was opposed to it.

Loren Hamblin of White Township picked up on Ms. Cerbone's point; that we should be writing to our state legislators. "Well, that's exactly what this resolution is doing," he said. Further, he said, if someone is negligent with firearms, that is not a Second Amendment issue.

John Betts of Lopatcong asked which Constitution of the United States we were discussing. Unincorporated? United States of America Corporation? Prior to 1781? He thought that should be defined, yet failed to verbalize whether he was for or against the proposed resolution.

Jeff Devine of Hackettstown said he supported the resolution as a law-abiding gun owner and lifelong Boy Scout. He said he owned a variety of firearms and was no longer sure whether or not he was breaking a law, as they are rapidly changing. "I am not the problem," he said, "We are safe, we are law-abiding." He said the criminals are not abiding by these laws.

Daniel Walton of Hackettstown asked Mr. Devine how this resolution was supposed to help him. Mr. Sarnoski admonished him to address the Freeholders, not other members of the public. Mr. Gardner said he felt this would send a message to State government, and he personally felt the State was "wrong-headed" on this issue.

Mr. Sarnoski read aloud the last two declarations of the resolution: The Board of Chosen Freeholders hereby expresses its intent to uphold the Second Amendment rights of the citizens of Warren County and its intent that public funds of the County not be used to restrict Second Amendment rights or to aid in the unnecessary and unconstitutional restriction of the rights under the Second Amendment of the citizens of Warren County to bear arms; and The Board of Chosen Freeholders hereby declare Warren County, New Jersey, as a "Second Amendment/Lawful Gun Owner County."

Mr. Sarnoski said the thought the Board was expressing its intent and its feelings on the Second Amendment, the rights of individuals under the Constitution, and conveying these feelings to State legislators.

Mr. Walton asked about mental illness as it related to gun purchases, asking if that was a Second Amendment right. Mr. Gardner said that was a complex issue, and this doesn't change the law. Mr. Lazorisak said the County cannot create a law that would prompt a State law; the Freeholders don't have that type of control.

Joan Kearney of Washington Borough said there was no hate being promulgated on the 2A Facebook page, despite what Ms. Babitsky had said. Ms. Kearney said the first right of every human being is the right of self-defense. "Without that right, all other rights are meaningless," she said, adding that this is an inalienable right that is older than the Constitution, which existed prior to government. She said citizens must have a way to protect themselves. She went on to cite case law, and provide further examples of why she was in favor of this resolution, including the potential for abuse of red flag laws.

William Hayden of Sussex County introduced himself as a Second Amendment advocate who has been making the rounds urging counties and towns to enact these resolutions "To send a strong message to Trenton: Enough," he said. He said New Jersey does not honor the Second Amendment. Mr. Hayden said he had participated in the recent gun rights rally in Richmond, VA, and no one was hurt. He said he same weekend in Chicago, home of very strict gun laws, 66 people were shot, 12 of whom died. "We're not asking for the laws to be changed; we know this is not the venue. But we feel that if enough towns and counties sign on, it will stop," he said.

Jody Becker of Hackettstown voiced his support for the resolution. As a law enforcement officer, he said he had more rights than ordinary citizens with regard to firearms. "I don't understand why I have the right to bring a firearm out with me in order to protect my family, myself, or the other people in whatever venue that I am in should something happen, but the person next to me, who may have violated no laws at any point in their life... they don't have that same right," he said. He understood this resolution was mainly symbolic, but agreed with others that we need to send a message to Trenton.

Alex White of Washington Township thanked the Freeholders for the opportunity to speak. He said he was in high school in 2010 when his school district decided to take action to have a school resources officer in each school. He said he

was the victim of a crime recently, and fortunately, police arrived in time. "If that person decided they wanted to enter my house and do more than what they did do, I wouldn't be here to talk about this," he said.

Bill Timmann of Easton, PA said he was a business owner in Washington Township and grew up in Phillipsburg. He voiced his support for the resolution, using the example of getting between and bear and her cub as a valid reason to carry a firearm. He said New Jersey needs to remove illegal laws from its books.

Iris Perrot of Washington Borough said she appreciated hunting, culling the herd, and that deer on the roads is a big problem. "You want to own a gun, own a gun," she said. She asked the Freeholders if they thought people with mental health issues, or criminals, should own guns. Mr. Gardner said this is where it gets complex, these individuals need to be vetted out. Ms. Perrot agreed, and began talking about an FBI case in which a white supremacist was running guns in Phillipsburg. Mr. Sarnoski said, "So they were illegally handling firearms; they weren't doing anything legal. So when we say we are a lawful gun owner county, they're not who we're talking about."

Ms. Perrot said the group that's pushing this agenda from Virginia is right of the NRA, and is on the list of extremist groups. "I am all for the Second Amendment," she said, "but support the First Amendment, the Second, Third, Fourth... it matters." Mr. Sarnoski said, "This isn't about a group, this is about our Constitutional rights." It is about the United States of America, the people of Warren County, and the Freeholder Board.

Mr. Gardner said, "You've made a point; extremist groups have no place in society, but that's not what we're here for." Ms. Perrot said there are some serious characters out there. She appreciated the sense of community here, and hoped the care for the residents was something the Freeholders were looking out for. Mr. Sarnoski said we are advocating through the proper channels to uphold our rights, we aren't advocating for breaking the law.

Donna Fox of Franklin Township said when she moved to Warren County in the 1970s, she was fearful of firearms and could appreciate the concerns as a mother and grandmother. But she made it her business to learn about firearms and how to use them. "To understand the law now is almost impossible," she said. Ms. Fox said with all due respect to the police, her township is covered by State Police, and she was concerned about the response time if a break-in should occur while she is home alone.

Lori Ciesla of Lopatcong said her husband and father were hunters and law-abiding gun owners. New Jersey has some of the strictest gun laws, and most hunters respect that, though the quickly changing regulations are difficult to keep up with. She thought it was important for the Freeholders to send the message that we are in support of our Constitution. She cited Supreme Court case law in which it was ruled that the Second Amendment did protect our individual rights to bear arms; not just as a militia. However, she said Justice Scalia at the time said prohibiting felons and the mentally ill from not having them is not unconstitutional, it actually is to protect everybody. "So when you're saying you're protecting the Second Amendment, that's all that comes with it. Nobody's advocating that mentally ill people have them or felons or anything like that," she said.

Ms. Ciesla said when politics becomes very polarized, sometimes we go too far in either direction. It was her understanding that New Jersey was being sued by the federal government. Just as Mr. Lazorisak said, the county cannot establish any laws that supersede state laws; neither can the state make a law that supersedes any kind of constitutional ability of the federal government. She thanked the Freeholders for making this statement, and hoped Trenton would listen.

Responding to an earlier comment about a hunter being a threat to someone's dog, Ms. Ciesla advised calling the Division of Fish & Wildlife. She said they have a police force and have no tolerance for that.

Robert Prunick of Pohatcong said he moved to this area 15 years ago from Hudson County, to be in a less populated area. He said has run into three bears and three rabid raccoons, and it took the police a long time to respond. So he decided to obtain a firearms identification card. "Which, by the way, now they ask for a medical release for your medical history, including your mental history," he said, and also check your fingerprints. He said they make sure there are no crimes on your record. "We need to make a stand to tell New Jersey that we're not going to stand for this," he said. "If I don't have my arms with me, how can I protect myself?" he asked.

Charlotte Brown of Blairstown said she supported this resolution for many reasons, including the right to put food on the table and protect herself. And as a collector, with things changing so rapidly, it was hard to know whether or not she was committing a crime when she goes to the shooting range.

Tamara Trinneer of Hackettstown introduced herself as a mother of four children, a wife, and someone who has been involved with Girl Scouts her whole

life. She said her husband was a member of the National Guard for 14 years, and her stepfather served in the Marines for two tours of Vietnam and was a lifelong gun collector. He moved to Pennsylvania to escape New Jersey's strict gun laws. "I fully support this measure; I feel Trenton has ignored Warren County for years, flip their noses at us and how we live out here," she said. She recalled when half the boys in Hackettstown High School would leave early on the first day of hunting season, having brought their guns safely in their trucks to school. "Of course that's not going to happen now, but it's just showing how it's changed so much over the years," she said. Ms. Trinneer said she was fearful of doing something wrong, resulting in a knock on the door with someone wanting to go through her house and take away their guns. That's how it all begins, she said, until we have no freedoms left. She continued, talking about scouting, gun safety courses, and the way she has raised her children to respect firearms.

Emil Brissom of Phillipsburg said he was opposed to this resolution and asked the Board not to pass it. He said the statements that New Jersey does not respect the Second Amendment was a matter of opinion. There are other personal opinions out there. He thought the majority of Warren County constituents would not be in favor of this resolution.

Leonard Vasile of Lopatcong said he was a legal gun owner and supported the resolution.

Paul Fox said he was a legal Warren County gun owner who supported the Second Amendment and the resolution under consideration, and thought people should be concerned about government infringing upon our rights.

Ron Gardner of White Township (no relation to Freeholder Gardner) said he was a lifelong New Jersey resident who moved to Warren from Hunterdon 18 years ago. He said he has been an EMT, helped train NRA students as a firearms instructor, and is an Eagle Scout. He had a lifelong history of his family supporting government, and thought the Freeholders were doing an exceptional job. He fully supported the resolution standing up for our rights.

Logan Timmann of Easton, PA approached the Board in his Boy Scout uniform, introducing himself as a member of Troop 51 of Phillipsburg and a sophomore at Easton Area High School. He said he feared each day that someone would bring a gun to school and that the adults in the school would not be able to protect him. There is only a sign that says no guns are allowed. He thought this put a target on each person's back.

# **RESOLUTION 76-20**

On motion by Mr. Kern, seconded by Mr. Sarnoski, RESOLUTION DECLARING THE COUNTY OF WARREN A SECOND AMENDMENT COUNTY.

Mr. Sarnoski said we have had a great back-and-forth here tonight, and thanked everyone for their decorum. He thought the level of discourse here went far above what he has seen in other venues. He was a little disappointed that some individuals who opposed his point of view had already departed. Mr. Sarnoski said he had the utmost respect for everyone who stands up and expresses their points of view.

He said he was a little upset at the assertion that this was not an open board. "I'm sure we have room to grow, and we always have room to be more open on this Freeholder Board, and we are doing that," Mr. Sarnoski said. However, he said this agenda was posted early last week on our website, and anyone who wanted a copy was free to call the office to obtain one. He said the language in this resolution was very

similar to others that are being passed throughout the state. He felt it was untrue and unfair to say people did not have the opportunity to view the resolution ahead of time. He said he answers his phone when it rings.

The son of a police officer, Mr. Sarnoski said his father taught him how to handle a gun, and the great responsibility of owning a gun. But gun owners also have rights. "That's what makes this country great, that this country gives us rights to own firearms. In many countries, people don't have that right," he said. We are seeing restrictions on legal gun ownership going deeper under the Second Amendment. He said this resolution reflected his own feelings on legal gun owners.

Mr. Sarnoski read aloud the following excerpts from the resolution: The Warren County Board of Chosen Freeholders desires to express its deep commitment to the rights of citizens of Warren County to keep and bear Arms; and, the Warren County Board of Chosen Freeholders desires to express its intent to stand for Second Amendment rights and to oppose, within the limits of the Constitution of the United States, any efforts to unconstitutionally restrict such rights, and to use such legal means at its disposal to protect the right of the citizens to keep and bear arms, including through legal action, the power of appropriation of public funds, and the right to petition for redress of grievances.

"This is the process we have in this country when we disagree with our leadership," Mr. Sarnoski said, "We don't say we're not going to follow the law, we don't say we're going to break the law, we say we're going to address the laws we don't agree with through petition. And that's what we are doing here."

Mr. Sarnoski said he did not believe the Freeholders were wasting time or money on this endeavor; he thought this was their job, and felt that if the majority of Warren County residents thought this was wrong, they would not reelect him. "That's how I get my feedback," he said, and believed most Warren County residents would approve of this resolution, and that was why he supported it.

Freeholder Kern echoed Mr. Sarnoski's comments regarding the high level of decorum this evening. He did, however, agree that Mr. Hyndman had a point in terms of transparency, and thought the Board could be doing a better job. He said people should have the opportunity to see what we are voting on. "They can obtain it, but I think it should be more accessible, so I will own that and I agree with that," he said, pointing to a report he would delve into more detail later in the meeting.

Regarding crime, Mr. Kern said Warren County's crime rate per 100,000 is

8.3; the United States is 22.7. "So just to be clear, I think Warren County is a very safe place to live," he said, adding as a lifelong resident, he was acquainted with his neighbors and first responders, and felt safe here. "I think we all should feel safe here," he said.

"New Jersey has some of the strictest gun laws in America, there's no question about that," Mr. Kern said. He thought we had reached a point where we have politicians who want to pass laws to get headlines. In the resolution, he cited Assembly Bill 6003, proposed before the New Jersey General Assembly, which requires every gun owner to purchase \$50,000 of liability insurance. He said the minimum amount of automobile insurance required in NJ is \$15,000 per occurrence, \$30,000 for people. So this is saying everyone who is driving a car needs less insurance than people who are guaranteed in the Constitution to have a gun. "Are there some areas where there needs to be some regulation and discussion? Of course," Mr. Kern said. But he thought it was time to step back and remember this is our Constitution, these are the laws of the land, this is the oath we took when we were all sworn in. "I support this resolution because this is our way of symbolically telling Trenton – our legislators – how we feel as a county, and I'm proud to support this," said Mr. Kern.

Freeholder Director Gardner recalled one of the public comments regarding crime in Chicago. Some of the toughest gun laws out there are not preventing criminals from accessing guns. "They're going to do it, regardless," he said. "The law-abiding citizen in this state is now forfeiting his rights. That's not acceptable," said Mr. Gardner. He remembered the era when guns were taken to school. There was never a problem, because young people were taught gun safety by their parents. He said any time you pick up a weapon, it is a very serious matter. Mr. Gardner thought the State of New Jersey was eroding our rights. "I have to support this to make a statement, and our legislators need to know: Stop putting forth feel-good measures that do not accomplish anything for society," he said. Along with his colleagues, Mr. Gardner expressed appreciation for the civility this evening.

#### REPORTS AND COMMENTS

County Counsel Joe Bell said he had two items for discussion in Executive Session: W.M. v. County of Warren, and the Selective Insurance Company case.

County Engineer Bill Gleba was absent.

County Planner Dave Dech had no report.

County CFO Kim Francisco had one more update to the budget; a memo from Office of Emergency Management revealed that the fire tower had to be inspected this year, necessitating an increase of \$12,500 to the OE line. This includes certification.

County Administrator Alex Lazorisak brought the Board's attention to the latest personnel vacancy report, which contained nothing unusual.

Warren County Technical School requested scheduling its Board of School Estimate meeting for March 25, 2020, 6:30 p.m. The Freeholders approved.

# FREEHOLDER COMMENTS

Mr. Kern distributed the "much awaited" Transparency and Technology Task Force recommendations to his fellow Freeholders. This Task Force, which Mr. Kern formed in February of 2019 with the goal of improving the County's transparency and technology, was comprised of a mix of the following county staff, officials and private citizens: Shawn Buskirk, Human Services Director; Art Charlton, Public Information Director; Lori Ciesla, former Lopatcong Council President; Holly Mackey, Warren County Clerk; Mike Petruzzellis, Communications Center Technical Services; Christine Rusin, Chief Creative Officer of Parashoot Productions; Bob Side, Warren County Information Systems Director; and Harry Zikas, former Alpha Borough Mayor.

Mr. Kern quickly highlighted the four main recommendations in the summary, arrived at partially due responses to a survey distributed to the municipalities:

- 1) A new website
  - a. Attached were survey responses, and a proposal from a web vendor, vetted by Mr. Sidie and Mr. Charlton, as well as the rest of the Task Force.
- 2) Increased social media usage
  - a. Mainly thanks to Mr. Charlton, in addition to Facebook, the County is now more active on Twitter, has an Instagram page and YouTube channel.
  - b. The County's Social Media Policy should be revised
  - c. The Freeholders should consider adding an employee to assist with utilization of these platforms.
- 3) Video-recorded meetings
  - a. Local medial no longer attends or reports on Freeholder meetings
  - b. Citizens sometimes record the meetings themselves

- c. The County did video tape meetings in the past
- d. A poll of other counties' procedures was included
- 4) Paperless meeting/posting documentation
  - a. Meeting documents should be posted online in addition to the agenda
  - b. Freeholders should utilize technology to strive toward using less paper
  - c. Other counties' procedures included
- Mr. Sarnoski said he didn't disagree that we could do better, "But it's not inaccessible, and I was never trying to hide anything... I have no desire to hide anything that this Freeholder Board does," he said.
- Mr. Gardner said he could see a lot of time and work went into this report, and he looked forward to examining it in detail.
- Mr. Sarnoski asked to what extent were these recommendations budgeted for in the 2020 budget. Mr. Kern said so far only the immediate action item the new website which would take a good six to eight months to implement. Once that is up, we can move forward with the other items.
- Mr. Kern thanked the Task Force for all its work, particularly Mr. Charlton, for "working outside the box and experimenting on a lot of these new technologies," he said. "That's where the residents are, that's where our constituents are, and we need to be able to communicate to them," Mr. Kern said.

On a different topic, Mr. Kern noted the prior weekend was the 100<sup>th</sup> Anniversary of the 19<sup>th</sup> Amendment, which gave women the right to vote. He proposed presenting a proclamation to County Clerk Holly Mackey, as the highest female elected official in Warren County, and invite female elected officials. Someone from the audience suggested the League of Women Voters should be invited as well.

Mr. Sarnoski reported having attended the Washington Business Improvement District's awards reception the prior week, which was well attended, and he noted the organization has really come a long way over the years. Business is picking up in the Borough and the group is working hard to advocate for the businesses.

In other economic development news, Mr. Sarnoski said the 69<sup>th</sup> Annual Horse Show is coming to Warren County, and plans to stay. He said this is a very prestigious event. Members of our Economic Development Committee have already met with the organizers, and we look forward to working with them in the future. He expected more information to follow.

Mr. Sarnoski said he continued to work with the NJDOT on our CR 519/Route 57 intersection, and expected to be able to provide an update at the next Freeholder meeting.

The following evening, February 12, Mr. Sarnoski said there was meeting scheduled in Franklin Township regarding its rezoning proposal. He wasn't going to be able to attend, but suggested someone on the Freeholder Board reach out to them to explain options for farmland preservation. While zoning and land use is in the hands of the municipalities, we want to try to mitigate negative effects of development in our region as much as possible. Even though the Freeholders are taking action through transportation studies, economic development studies, and our master plans, Mr. Sarnoski thought we should be proactive to make sure municipalities are aware there may be other options available.

Mr. Gardner said he was unable to attend, but had been a member of the Franklin Township Planning Board for 17 years and was familiar with the piece of property in question. He said there would be major hurdles to overcome before it could be developed (C-1 water course, among other issues), and expected a couple of environmental groups would be represented at the meeting. "It is a concern," he said.

For his own comments, Mr. Gardner made a public service announcement regarding the Spotted Lantern Fly, which was a big topic at the recent Ag Convention. He provided a hotline: 1-833-223-2840. Aside from that, he said the Ag Convention was a great success with many outside vendors. Agriculture is still the third-largest business in New Jersey, being leading producers of cranberries and blueberries. Interestingly, Mr. Gardner said, we are the only state that elects the people from the State Board of Agriculture. The Secretary of Agriculture answers to the state board, not to the government.

Mr. Gardner thanked the public for its participation and comments. "Both pro and con, it doesn't matter, you have your First Amendment rights, and that's what we want people to do," he said.

# **CLOSING PUBLIC COMMENTS**

John Betts of Lopatcong said with all this warehousing coming in, he hoped some valuable ratability comes out of those properties. He thought there was far too much tax burden on tenants and landlords.

Daniel Walton of Hackettstown asked about the procedure for submitting a resolution for consideration by the Board of Chosen Freeholders. He was told to email the County Administrator.

Joe Thomas of Liberty Township said the west end of Mountain Lake Road (CR 617) where it meets Route 519 has numerous holes and patches, and is tough on the fire trucks. He requested someone come out and take a look at it for repair.

Lori Ciesla of Lopatcong thanked the Freeholders for assembling the Technology and Transparency Task Force. She hoped the recommendations in the report would be implemented, with the biggest issue being the website, which is difficult to maneuver, especially on a phone. She said when she was elected to Lopatcong Township Council, its website and social media presence was also lacking. Once upgrades were implemented, including video recording meetings, it really helped in terms of keeping people informed and having an accurate record out there. Mr. Sarnoski thanked her for her service on the committee.

County CFO Kim Francisco asked whether the budget could be introduced at the next meeting. If so, he needed a final decision on the levy to complete his cap calculations. The Freeholders needed a little more time to come to a consensus.

There were no questions or comments from the press.

**WHEREAS,** the Second Amendment of the United States Constitution reads: "A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed," an individual right affirmed by the United States Supreme Court and;

WHEREAS, the State of New Jersey was the first state to ratify the Bill of Rights, including the right to keep and bear arms, and the New Jersey Supreme Court has recognized it as a fundamental rights of its citizens; and,

WHEREAS, certain legislation introduced in the State Legislature, and certain legislation introduced in the current session of the United States Congress could have the effect of infringing on the rights of law abiding citizens to keep and bear arms, as guaranteed by the Second Amendment of the United States Constitution; and.
