The Board of Chosen Freeholders of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on February 26, 2020 at 7:00 p.m.

The meeting was called to order by Director Gardner and upon roll call, the following members were present: Freeholder Jason Sarnoski, Freeholder James Kern, III, and Freeholder Richard Gardner. Also attending were County Administrator Alex Lazorisak, County CFO Kim Francisco, County Counsel Joe Bell and County Engineer Bill Gleba.

Mr. Sarnoski said we don't see this level of dedication from employees very much these days. Speaking to Mrs. Budd, he said, 40 years is such an accomplishment, and shows your love not only for your job, but for the county, your community, and the people you work with. It is appropriate to honor our dedicated employees, and Mr. Sarnoski said he has only heard good things about Sue Budd. "Thank you from the bottom of my heart," he said.

Mr. Kern echoed the sentiments of Mr. Sarnoski, marveling at such a long career, but said it didn't surprise him, as Mrs. Budd and her family have given so much to Warren County. He could tell that she instilled certain values in her family, as she cares so much about our area. While she would no longer be working here, Mr. Kern was confident that Mrs. Budd would still remain very involved. "All the best, and congratulations again," Mr. Kern said.

Mr. Gardner said it was an honor to bestow this proclamation. "She's got that stick-to-it attitude because she's a homegrown farm girl," he said. Mrs. Budd has shown much dedication and touched many lives over the years, which was a tribute to her wonderful personality, Mr. Gardner said, and he was happy to be a part of this tribute.

Mrs. Budd accepted the proclamation with gratitude, thanking the Freeholders, her family and everyone she had worked with over the years. "I will miss you," she said.

Some of Mrs. Budd's coworkers said a few words, including Colleen Miller, who said it was a pleasure to work with Sue for seven plus years. She said a person's wealth is measured by how much they are loved and respected, so Mrs. Budd is very wealthy indeed, and was going to be missed.

Regina Fitzpatrick said she had worked with Sue Budd for 32 years, and referred to her as an "amazing" and "phenomenal" woman. She urged her family to take good care of her.

Aging & Disabilities Services Director Lakshmi Baskaram said she had not been in her position very long, but it was apparent after a short time that Mrs. Budd was born with a work ethic that cannot be taught. She thanked her very much for setting such a fine example.

Human Services Department Director Shawn Buskirk said she had worked with Sue for 31+ years, and everyone in the department would miss her.

Co-worker Sharon Green said Mrs. Budd was a very good listener and it was great to bounce ideas off of her.

PROCLAMATION 92-20

Mr. Kern said it was remarkable that it has been merely 100 years that women have had the right to vote. Referring to himself as a bit of a history buff, Mr. Kern delved a bit deeper into New Jersey's history, where there had been substantial contention. The state legislature tried to block the vote because they knew it would eventually pass. In the election following the amendment's passage, voter turnout increased 81 percent. At the time, Assembly republicans were in favor of passing the amendment, and in turn won 59 of 60 seats. The one seat won by the democrats was in Warren County, because this county also supported the 19th Amendment. A Hackettstown Assemblyman retired, and a Belvidere legislator won that seat.

Mr. Kern said he had been surrounded by a number of strong women throughout his life who encouraged him to get involved in government. One of those women was present this evening: former Pohatcong Township mayor Mary Van Lieu, who is still serving as Councilwoman. "I know there's a lot more than we can do by encouraging more people to get involved," he said, "But it's a great honor to pass this proclamation," said Mr. Kern.

Mr. Sarnoski said he had done a bit of research himself, and imparted that the first female Congresswoman, Jeannette Rankin of Montana, was elected prior to the amendment's passage in 1916. He said that shows the dedication that women have, and what they put into their communities even when they didn't have the same rights their peers had. "To have this and mark this occasion and to remember how far we've come as a society is just so important," said Mr. Sarnoski. He was glad to celebrate this, and thanked Mr. Kern for bringing it forward.

"It just seems strange, quite frankly, that it took so long," Mr. Gardner said, marveling that an effort begun just after the Civil War took 53 years to come to fruition in Congress. It was an honor to recognize this. He, too, had been surrounded by many strong women, including his own late mother. "She'd do whatever it took," he said. "I certainly believe in the ERA, that's for sure," Mr. Gardner said.

Present to accept the proclamation were the following current and former female elected officials: Holly Mackey, Warren County Clerk; Washington Borough Councilwomen Ethel Conry and Josephine Noone; Mary Van Lieu, Pohatcong Township Councilwoman and former Mayor; Lori Ciesla, former Lopatcong Township Council President; and Ellen Nerbak, former Mansfield Township Committeewoman.

Ms. Ciesla said it was truly amazing that it's been 100 years, and interesting that Sue Budd had been working here for 40 of those years. We've come a long way. She said it takes both men and women to effectively run our governments and boards, and encouraged all to get involved on any level, even as a volunteer. "Just be a part of it," she said, and urged everyone to vote.

Ms. Nerbak said this was wonderful and when she started out in 1993, there were very few women serving as elected officials. "We've come a long way," she said.

Ms. Van Lieu said her dear friend, Rose Toth, became the first woman on Pohatcong Township Council in the early 1990s and was a mentor to her. With her encouragement, Ms. Van Lieu became the township's first female mayor. She said

unfortunately, it is still difficult for women to serve in this capacity.

Ms. Conry said she was the first African American to be voted into office in Warren County, in Washington Borough. She said she has been serving for eight years. "Well, one year I sat out – because of a man," she said, and her remark was greeted with laughter. She was currently serving as Deputy Mayor, which was a privilege, and also a privilege to be here today, she said.

Ms. Noone said she serves on Washington Borough Council with Ms. Conry, and five of seven seats there are held by women. "We represent our whole community," she said, and thanked the Freeholders for the recognition.

Warren County Clerk Holly Mackey expressed gratitude to the Freeholders as well. She said she began her political career by being the first female elected to White Township Committee, eventually serving as mayor. In her new role as County Clerk and this being a presidential election year, she emphasized the importance of voting. It is a right, a privilege and an honor that is denied to many in other countries. "I wish more people would do it," she said, "Getting involved, running for office, putting yourself out there." "I want to count lots and lots of votes," Ms. Mackey concluded.

After photos and applause for this group, an additional copy of the same proclamation was presented to members of the League of Women Voters of Warren and West Morris counties. In attendance were Megan Davis, Marge Royle, Kelly Shea and Josephine Noone. Chair Megan Davis thanked the Board for the recognition on this 100 year milestone, and said it was very important to get involved and set an example for future generations. "I think we can all agree that democracy works best when everybody is given a fair and equitable voice in that process," she said.

Kelly Shea thanked the Freeholders very much. Adding a bit more to the history lesson, she said Women's Suffrage became the League of Women Voters, and encouraged the audience to go online and learn about their local league. "I would love to see more women in government throughout the county," she said, "and even on the Freeholder Board." She was assured that three women have indeed served on the Warren County Board of Chosen Freeholders (Irene Smith, Susan Dickey and Anne Stone).

REPORTS AND COMMENTS

County Counsel Joe Bell said there were a couple of matters to be discussed in Executive Session regarding cases involving W.M. and Selective Insurance.

County Engineer Bill Gleba provided a few NJ DOT-related updates. He reported that the Route 94 Bridge in Blairstown was now reopen. The Route 173 Bridge in the Greenwich/Pohatcong area was anticipated to be open sometime in March. Mr. Gleba had plans to attend a couple of public information centers; one in Oxford regarding replacement of the Furnace Brook Bridge, and one in Hackettstown concerning work to be done at four intersections in that area.

Members of Mr. Gleba's staff was to meet with Blairstown Township officials the following day regarding a movement to take out the Paulina Dam on East Crisman Road.

County Planner Dave Dech provided an update on Census activities. A packet will be going out to all employees, encouraging them to spread the word. Signs and posters have been printed and are being distributed and posted throughout the county in both English and Spanish. Advertisements have been placed in *The Warren Reporter* and on Lehigh Valley Live. He has met with local Complete Count committees in Washington Borough, Hackettstown and Phillipsburg, which have been deemed hard to count communities. Soon, an ad will appear on Warren County shuttles encouraging people to take the Census. He said this was a good, team effort that was coming together very well. He thanked the Public Information Department, Aging & Disabilities Services Division, Human Services Department and local nonprofits for joining in the effort.

A public information session occurred this evening in Hackettstown regarding a drainage culvert on the Washington Secondary that does not meet the 286,000 pound requirement to allow railroad cars to cross it. The NJTPA has commissioned a study to identify areas that need replacement. The preferred alternative is to replace the concrete slab that it goes over. It was his understanding that there was very limited participation in this session.

A training session is being conducted for municipal recycling coordinators on March 11 to help them understand how to fill out reports properly. As mentioned in

one of Mr. Dech's previous reports, Warren County's recycling numbers appear to be lagging, and the theory was that inaccurate reporting was the reason.

A special Planning Board meeting was scheduled for March 30 to talk about transportation issues with municipal officials.

County CFO Kim Francisco had no report.

County Administrator Alex Lazorisak had only the most recent vacancy report. He said there was nothing out of the ordinary, but it is that time of year to plan for seasonal workers in the Engineer's Office.

FREEHOLDER COMMENTS

Mr. Sarnoski had no report.

Mr. Kern spoke of the recent fire in the Delaware Water Gap on the Warren County side, and said all first responders did a tremendous job. He said it appeared the cause was at least partially due to Gypsy moths on dry wood. "Fortunately, no one got hurt," he said.

Mr. Gardner asked Mr. Sarnoski if there was any recent news regarding the rock wall mitigation project along Route 80. Mr. Sarnoski said no; the DOT seems reluctant to meet with us any more on the matter. Mr. Dech said there will be another meeting in the spring or summer for the public, but the DOT does not appear to want an indepth work session with local officials, which he thought would be more productive. "I think it's an extreme waste of the public's money," Mr. Gardner said. He thought it was going to be a very unsightly thing against the backdrop of the Delaware Water Gap.

Mr. Gardner's final item was that he had recently met with the Foodshed Alliance, which is trying to work with Ridge and Valley Conservancy on the Sustainable Agriculture Enterprise (SAgE) program, trying to reach out to people interested and qualified to pursue organic farming but may not own property, to make preserved farmland accessible to farmers at affordable long-term leases. He said there seemed to be a growing interest in this regard.

There were no closing comments from the public, nor any questions from the press.

CELEBRATE 100TH ANNIVERSARY OF WOMEN'S SUFFRAGE

WHEREAS, the year 2020 marks the 100th anniversary of the ratification of the 19th Amendment to the United States Constitution, guaranteeing and protecting women's right to vote; and

WHEREAS, this centennial offers an opportunity to commemorate a milestone of democracy; that the right of citizens of the United States to vote shall not be denied or abridged by the federal or state governments on account of gender; and

WHEREAS, in 1867 New Jersey residents Lucy Stone and Harry Blackwell organized the New Jersey Woman Suffrage Association (NJWSA), devoted to gaining women's suffrage; and

WHEREAS, although the 1912 state referendum on woman's suffrage was soundly defeated in the New Jersey Legislature, a corner was turned for the New Jersey suffrage movement; and

WHEREAS, in 1913 an automobile rally led by "General" Rosalie Jones traveled through New Jersey on the way to Washington D.C., in a Suffrage Parade of over 8,000 marchers with many New Jersey women including event organizer Alice Paul; and

WHEREAS, in 1915 a second suffrage constitutional referendum was pursued in New Jersey, New York, Pennsylvania, and Massachusetts with active campaigns by many suffrage organizations, including the "Passing of the Torch of Liberty" via tug boats on the Hudson river from New York to New Jersey, but was defeated in all four states in October 1915; and

WHEREAS, in 1917 New Jersey suffragists Allison Turnbull Hopkins, Julia Hulburt, Beatrice Reynolds Kinkead, and Minnie D. Abbott picketed in front of the White House as part of the Silent Sentinels and subsequently were arrested and imprisoned; and

WHEREAS, on June 4, 1919 congress passed the 19th Amendment guaranteeing all American women the right to vote; and

WHEREAS, on February 9, 1920, New Jersey became the 29th state to ratify the 19th Amendment granting women the right to vote; and
