*These minutes were approved by the Board of Chosen Freeholders on May 27, 2020. Full texts of resolutions appear at the end of this document.

The Board of Chosen Freeholders of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on May 13, 2020 at 7:00 p.m.

Due to social distancing directives, this meeting was being conducted without any members of the public in attendance. The public had the opportunity to listen to the meeting, and participate if they chose, via telephone.

The meeting was called to order by Director Gardner and upon roll call, the following participants were present in the room: Freeholder Jason Sarnoski, Freeholder Deputy Director James Kern III, Freeholder Director Richard Gardner, County Counsel Joe Bell, County Administrator Alex Lazorisak, County CFO Kim Francisco and Deputy Freeholder Clerk Holly Luberto. Participating via telephone were County Engineer Bill Gleba, County Planner David Dech and County Health Officer Peter Summers.

County CFO Kim Francisco explained that we are not doing this to exceed the county tax levy limits, nor the cap. "Our tax levy is not going up one cent this year," he said. This is a routine banking provision; this allows us to bank the money that we didn't use and carry it over on paper for next year in case we need it.

Mr. Francisco reiterated that the tax levy would remain the same as last year, \$69,999,000, with no increase from 2019. Overall, the county budget is going up about \$600,000, but that difference is being made up by utilizing funds from surplus. "We're not using a dangerous amount of surplus to artificially keep it low," he said, "We're

very happy to be able to safely keep the levy flat."

Regarding the Library budget, Mr. Francisco said this is the fourth year in a row with no tax increase. This budget is \$4,386,000.

The Open Space budget also remains the same, at \$2,800,000, a rate of 2.5 cents.

There were no questions or comments from the public.

Mr. Francisco said this year's Capital Ordinance authorizes \$10,942,562 in capital improvements, with all projects being fully funded without incurring debt. "We are a pay-as-you-go county, and a save-as-you-go county," he said. Over the years, we have saved money for not only customary road resurfacing programs, drainage and bridge improvements, equipment/furnishings and special vehicles, but for special projects as well. This ordinance authorizes \$1.5 million for 911 Center upgrades; \$1.5 million for an addition to our Human Services/Temporary Assistance & Social Services building; \$500,000 for Courtroom #1 renovations; \$500,000 to improve the Road Department's Belvidere salt shed, and \$200,000 toward a garage in Alpha. "Once again, fully funded, with no borrowing required," said Mr. Francisco.

Phone calls and video apps can help us all stick together.

Considering the impact that COVID-19 has been having on our older Americans, it is vital that we are reminded how essential they are to our communities. Older adults comprise a strong base of volunteerism in our county. "They're always there to get things done," he said. He wished they could be here in person to accept the proclamation. "We should be there for them now, during this difficult time," said Mr. Sarnoski, "They are certainly in our thoughts."

"Warren County government works better because of our older citizens, who are always ready to help," said Mr. Gardner. It is essential that we recognize their contributions. He looked forward to getting back to being able to welcome not only seniors, but all citizens, to public gatherings to be honored.

Mr. Sarnoski thanked all members of the county team that put together this budget, especially Mr. Francisco and his department. "I'm very proud of this budget... a great, solid budget," he said, and reiterated that it is completely flat with no tax increases. "Considering what we're going through right now, I think that's quite an achievement," said Mr. Sarnoski, "We're successfully navigating COVID-19 without increasing taxes, and without any federal or state aid." He thought this was a testament to the hard work of the residents of Warren County and his fellow Freeholders.

Mr. Kern joined Mr. Sarnoski in expressing thanks to CFO Kim Francisco, his staff, and all department heads led by County Administrator Alex Lazorisak. He said, "When we started this budget in late 2019, we had no idea where we would be in May 2020 with respect to the COVID-19 crisis." Mr. Kern said this was a responsible budget that goes easy on the taxpayers, while continuing to provide critical services to our residents.

Being Mr. Gardner's final year serving as Freeholder before retiring, Mr. Kern thanked Director Gardner for his years of leadership and for presiding over a great budget for the people.

Mr. Gardner said he was especially proud of the library, which had been a focus of his attention even before he became a Freeholder, and received an award in 2017 for being the most improved library system in the State of New Jersey.

Mr. Gardner noted that it was typical to have numerous personnel resolutions upon budget adoption.

REPORTS AND COMMENTS

County Counsel Joe Bell said he had several matters for discussion in Executive Session, including Covanta negotiations, status of W.M./C.C./R.M. litigation, eviction from county property, and a property acquisition.

County Engineer Bill Gleba reported that the NJDOT reopened the Route 173 Bridge in Greenwich Township about three and a half weeks ago. Mr. Gardner said he had received some calls regarding another tractor-trailer hitting a bridge on Upper Sarepta Road. Mr. Gleba said he was aware of the incident; it was unusual to have about three incidents occur at the structure over the course of about two months. The Bridge Division performed some repairs, there is a barrier to protect the area, and they are in the process of coming up with a more formidable deterrent. Mr. Gleba said with no police reports, there is no one to go after, but they are following up on some leads provided by local residents.

County Planner Dave Dech reported that the Paper Shredding service the County previously scheduled for June 6 was cancelled. The next one was set for September 19.

Census response rates were increasing, with Warren County's response rate at 65.8 percent, compared to 60.8 percent for New Jersey and 59 percent nationally. "So we're doing pretty good," he said, noting Warren ranked in the top five counties in the state. He said marketing efforts would continue; there is still plenty of time to respond. Mr. Dech thanked Mr. Gardner for recording a video encouraging residents to participate in the census.

ParkFest @ Bread Lock Park, which had been scheduled for June 9, has been cancelled. Mr. Gardner hoped there could be some alternate festival in the fall.

County CFO Kim Francisco said since the county is self-insured, COVID-19 was very concerning, and he had been watching the bills. He said we have actually been saving money on our claims. This could be due to people not going to doctor visits as they normally would.

County Administrator Alex Lazorisak first brought the Board's attention to the latest vacancy report, which only had one backfill position and nothing out of the

ordinary.

Mr. Lazorisak then offered a COVID-19 report, noting that this was day number 64 since the COVID-19 task force formed, and day number 37 since the county opened its testing site. The testing site has cut back to being open two days a week from three, as appointments seemed to be dropping.

Essential Warren County employees are still working on modified schedules, with many working from home, and those coming in have their temperatures checked daily in accordance with CDC regulations. Mr. Lazorisak thanked Bob Sidie and the I.T. Department for making sure workers were equipped with laptops and phones to work remotely. As of Monday, May 18, all Public Works divisions will be operational to meet requirements, and will practice social distancing.

"We are starting to prepare and get facilities ready to open up to the public, at least getting a plan together," Mr. Lazorisak said. It will take some time to comply with Governor Murphy's Executive Order 122, stipulating social distancing, plexiglass barriers, etc., but hopefully in the next week or two we will have our plan in place. Mr. Lazorisak was grateful to department heads and employees for continuing to provide services. "We're all getting tired, but everyone is still working hard," he said.

Mr. Gardner asked about the locations for the plexiglass installation requirements. "Just about every facility," Mr. Lazorisak said, adding that top priorities will be offices of the Constitutional Officers, particularly the County Clerk and Surrogate, and the Board of Elections. Human Services employees continue to work from home on modified work schedules, a practice we will continue as long as possible. Direction comes from the governor.

County COVID-19 numbers as of May 13. Total positive cases: 1,054; of that number, 394 were in long-term care facilities. Probable cases (those living in households with other positives, but not yet tested): 59. Recovered: 289. Recovered is a self-reported number; we follow up with each case and ask a series of questions. Total deaths: 110; of those 87 were from long-term care facilities (79 percent). Average age of death: 82 years. "This is a disease that is particularly dangerous for our older citizens, particularly those over the age of 65," said Mr. Summers. On a positive note, hospitalization rates and ICU rates have decreased across the board.

As of May 8, Mr. Summers said 2,816 tests had been conducted countywide, with a positivity rate of 33 percent. This rate has also been going down in recent weeks.

As Mr. Lazorisak had mentioned, the testing site is currently open two days a week, on Tuesday and Friday, due to decreased demand. About 10 people per day (including long-term care facilities) are being tested, down from about 28/day with a high of 44/day. The testing site has ample capacity with no wait, so screening criteria has changed to be less stringent. Now, just about any symptom, or close contact with someone with the disease, will make individuals eligible for testing at the site. Mr. Summers was grateful to St. Luke's and Atlantic Healthcare systems for their involvement.

In recent news, Governor Murphy has proposed increases in testing, with a goal of 25,000 tests per day statewide. Based on population, Mr. Summers estimated that translated to a goal of 292 tests per day for Warren County's share. He seemed to think that was unrealistic and unnecessary; there would simply not be that much demand. "Our ability to test the people who need to be tested is very good," said Mr. Summers. He intended to follow up and learn more about the governor's goals.

Likewise, on the contact tracing front, the governor reportedly intends to recruit thousands of contact tracers. There is a signup function on the state's website. Here in Warren County, Mr. Summers said we are not behind at all in contact tracing, but if the effort expands, we might be able use 15-20 more individuals. Our existing team is comprised of our public health nurses, epidemiologist, inspectors, school nurses, Medical Reserve Corps volunteers, and some detectives from the Prosecutor's Office. Mr. Summers said the team is doing an excellent job, and has been from the beginning.

In terms of potentially reopening, "Overall, our numbers are looking good," Mr. Summers said; everything is coming down. That said, he cautioned that we have to continue to protect our senior population. They are still going to be at risk as businesses begin to return to normalcy.

Mr. Summers thanked the Freeholders for their support, noting Warren County received no aid from the federal or state governments and Bergen County received about \$180 million in aid. "We did all the things we were able to do with no outside financial support," Mr. Summers said, noting that was a tribute to the Freeholders and Mr. Lazorisak's leadership. He thanked his own staff, and all other departments that have helped out, saying everyone has done an outstanding job.

Mr. Gardner thanked Mr. Summers for his great efforts. Through his own observation, Mr. Gardner thought members of the public were being respectful to those around them, and doing a great job of following the guidelines with respect to social distancing. Mr. Summers said he agreed; businesses have stepped up and reorganized,

yet he still personally was not going out in public more than he had to.

Mr. Gardner asked for more details on the contact tracing component. Mr. Summers said this is telephone contact. Those having tested positive are asked a series of scripted questions regarding with whom they had close contact in the few days prior to feeling ill.

Regarding restaurants reopening, Mr. Summers said he has seen some guidance, and it will ultimately have to come from the state. Some kind of table service will return at some point, but it will have to be limited, perhaps to 25 percent of normal volume. Unfortunately, that may not be enough patronage for establishments to stay open.

FREEHOLDER COMMENTS

Mr. Kern expressed gratitude to Mr. Summers and the entire Health Department on handling this outbreak. "Everyone involved in the county has done a tremendous job improvising this response to the CCOVID-19 crisis," he said, and went on to thank external partners, St. Luke's and Atlantic Health, for helping make the testing site a reality.

With many planning and land use applications pending throughout the county, Mr. Kern said meetings had still been taking place "virtually" via Zoom and other online platforms, which he thought was inappropriate. Legislation sponsored by Sen. Oroho to extend statutory guidelines for municipalities to make decisions regarding development is pending.

Mr. Kern noted two resolutions passed at the Board's last meeting: one objecting to Pennsylvania maternity wards denying visitation to New Jersey families, and the other advocating for state and federal aid to combat COVID-19. The maternity issue was resolved to our satisfaction, but "We have yet to receive a single penny from the federal government," said Mr. Kern.

To review, Mr. Kern said the bipartisan CARES Act was passed on March 27, and it contained no money for Warren, Hunterdon, Sussex or Salem counties, but there was \$11 million for discretional aid. About two weeks later, on April 10, the entire congressional delegation sent a letter to the governor asking for the discretionary funding to be directed to Warren County. It was cited that Warren County did not meet the criteria of the automatically predetermined federal formulas. On April 29, Congressman Gottheimer joined a few other congress members from Pennsylvania

and added wording that 'longstanding unchangeable automatic federal formulas' were the reason these counties did not receive funding. On May 12, the Speaker of the House released a \$3 trillion bill, which now allowed for funding to Warren County. "So, if you're following the ball here, the explanation has changed on why we haven't gotten funding," Mr. Kern said, "There is money available to us sitting in Trenton right now, and we have still yet to see a dime."

Warren County set up a testing site over a month ago, operating on county tax dollars. Mr. Kern said it was time for the political spin to stop, and get our residents much-deserved funding. "It can be done, and should have been done," he said. He hoped to have some good news at the next Freeholder meeting, but felt the lack of leadership on this issue was totally unacceptable.

Mr. Sarnoski agreed with Mr. Kern's remarks, thanking him for his leadership on this front.

Moving on to the next phase of gradually reopening our economy, Mr. Sarnoski said we are trying to get out ahead of that. Warren has joined with Hunterdon and Sussex counties to form a task force to provide guidance on some reopening measures. While these counties cannot supersede the governor's directives on this endeavor, they can provide input on how to re-start our economy. "Quite frankly, our economic development and our businesses are suffering extremely," he said. Over 64 days, Mr. Sarnoski said, our known positive COVID-19 rate is one percent of our population. "So, how long do we wait?" he asked. These three regional counties share similarities in a number of ways, including not having received any federal or state funding to fight this crisis. Cape May County and the South Jersey Chamber of Commerce have compiled reopening plans. Mr. Sarnoski said partnering with the other two counties gives us more resources and the ability to act more quickly than we can on our own. A survey seeking input from Warren County businesses on reopening safely is now online.

Administrations of both St. Luke's and Atlantic Health have been included in these meetings for their viewpoints. So far, they did not have any economic input, but agreed to be open to look at emerging plans and offer guidance from a health safety perspective. "We're progressing," said Mr. Sarnoski, and hoped to provide more information soon.

Mr. Gardner asked about elective surgeries. Mr. Sarnoski said it was rumored that the governor was going allow them to resume within days, but that was not confirmed. Mr. Gardner thought if they didn't open up soon, patients (and the revenue)

would go across the river to Pennsylvania. He thought Warren County should be allowed to open up earlier than the more densely populated counties to the east.

Returning to the funding topic, Mr. Gardner said in conversation with Congressman Gottheimer's office, he was told the first round of funding was through the Small Cities Block Grant, for which Warren County did not qualify. Mr. Gardner said, "Whatever the reason is, it's still unfair, and our people are suffering, just the same as anybody else in the rest of the state." Mr. Kern said the elected official(s) writing the bill could put what they want in it. "We should have not received zero," said Mr. Kern.

CLOSING PUBLIC COMMENTS

Lori Ciesla of Lopatcong Township thanked the Freeholders for producing a sound budget. She was also grateful for the leadership and hard work of many on behalf of the county for implementing the COVID-19 testing site. She said we have been doing this alone and you are doing a great job.

Stan Prater of Jersey Central Power & Light provided some updates regarding JCP&L's procedures in light of the pandemic to keep employees and the public safe. He said many employees are working from home, and others are maintaining social distancing, wearing masks and having their temperatures checked. All trucks and work areas are sanitized daily. They continue to read outside meters, and service will not be disconnected for nonpayment during this crisis. Mr. Prater said office workers would not return until June 29. To date, six JCP&L employees have contracted COVID-19 and there has been one fatality in the Lakewood area.

In April, JCP&L signed an agreement to sell its interest in the Yards Creek facility in Blairstown, with an expected closing date in 2021.

There were no questions from the press.

RESOLUTION TO EXCEED THE COUNTY TAX LEVY LIMITS AND TO ESTABLISH A CAP BANK AS PER N.J.S.A. 40A: 4-45.14

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a county shall limit any increase in its county tax levy to **2.5%** unless authorized by resolution to increase it to 3.5% over the previous year's county tax levy, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a county may, when authorized by resolution, appropriate the difference between the amount of its actual county tax levy and the 3.5% percentage rate, subject to certain exceptions, as an exception to its final county tax levies in either of the next two succeeding years; and,

WHEREAS, the Board of Chosen Freeholders of the County of Warren finds it advisable and necessary to increase its CY 2020 budget by up to 3.5%, subject to certain exceptions, over the previous year's final county tax levy, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Board of Chosen Freeholders hereby determines that a three and one half percent increase in the budget for said year, amounting to \$532,410 in excess of the increase in final county tax levy otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Board of Chosen Freeholders hereby determines that any amount authorized herein above that is not levied as part of the final budget shall be retained as an exception to final county tax levy in either of the next two succeeding years.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the budget of the County of Warren shall, in accordance with this resolution and N.J.S.A. 40A: 4-45.14, be increased by 1.0%, amounting to \$ **532,410** and that the CY 2020 county budget for the County of Warren be approved and adopted in accordance with this resolution; and,



(6) Specialty Vehicles and Maintenance and Construction Equipment

\$ 774,809

Trucks, snowplows, sanders, tractors, mowers, and maintenance and heavy construction equipment

(7) New Building and Land Acquisitions

\$ 975,000

\$ 10,942,562

Section 2(B). The maximum amount of money to be appropriated for said purposes is \$10,942,562 no part of which is to be borrowed.

Section 3. The said purpose(s) described in Section 2(A) of this Ordinance are not Current Expenses and can be funded by the issuance of bonds if they were not being permanently funded by capital funds on hand.

Section 4. These appropriations are made as a result of the need to improve existing county infrastructure and facilities.
