Mr. Sarnoski elaborated on the resolution appealing to Governor Murphy for reimbursement, noting Warren County is out \$1.6 million for expenses incurred relative to COVID-19, including setting up a testing site and complying with the governor's executive orders. He said this was extremely important and the Board would continue to fight for it.

Mr. Kern agreed, saying our county had yet to see any money, which was unacceptable. He said New Jersey's entire congressional delegation – both democrat and republican – sent a letter to Governor Murphy on April 10 asking him to release money to counties that had not yet received any aid under the CARES Act. He insisted this was not a partisan issue nor a regional issue; the governor was failing to give Warren County the money it needs. "We knew the state wasn't going to assist us with a site early on; our staff stepped up to the plate and made that site happen, and we have been left hung out to dry here in Warren County," said Mr. Kern. He hoped the governor would realize that there are 21 counties in our state, all of which should be funded fairly.

Mr. Gardner said the CARES Act is federal money, and considering the state tax dollars our residents are required to pay, this funding should not be held up by the governor. "Our folks are feeling the pain just like anybody else, anywhere else in the state," he said.

M. Gardner said he had known Judy Leone a long time. "What a fabulous individual... she's done a great job for the county," he said, and accepted her resignation with regret. Mr. Sarnoski agreed.

#### REPORTS AND COMMENTS

County Counsel Joe Bell said he had one matter for Executive Session regarding the W.M. case.

County Engineer Bill Gleba had no report, but Mr. Gardner asked him about the volume of traffic near White Lake, as Hardwick Township officials noted it could be difficult to exit the natural resource area. He wondered if something could be done in terms of signage to slow people down in the area. Mr. Gleba said this was the first he was hearing about it, so he intended to reach out to Land Preservation director Corey Tierney to find out about the situation and take a look, but he wasn't sure there was anything they could do.

County Planner Dave Dech was away on vacation.

County CFO Kim Francisco said it was early, but already time to start thinking about next year's budget. As was mentioned, the county has spent \$1.6 million responding to COVID-19 with no reimbursement to date. "It's really important we get some money from the state," he said, or else it will have to come out of our surplus. Department heads will have to be prepared to look at the budget differently next year.

County Administrator Alex Lazorisak said the latest position vacancy report contained nothing noteworthy.

Turning to a coronavirus update, Mr. Lazorisak said it had been 120 days since the formation of the County's COVID-19 task force. As discussed, the county was roughly \$1.6 million out-of-pocket and had not received any money. He was pleased to report that the CFO and Office of Emergency Management submitted documentation for our first round of reimbursement to FEMA. He said the process took more than two weeks because the state's website crashed, and once it was recovered, the person assigned to process Warren County's application was been furloughed for 10 days. "So we'll be waiting another two weeks before it even gets looked at," he said, but he had confirmed that the state does not have this money. Once the state reviews this, it will go to the federal level. Given the history of how long it takes FEMA reimbursements to arrive, Mr. Lazorisak said he would be shocked to see any money by the end of this year.

Mr. Lazorisak said he was working with John Donnadio, Executive Director of NJAC, and a few other County Administrators to appeal to the governor's office to make the counties whole.

Within the county, many safety measures have been installed and implemented (Plexiglas, etc.). Offices of the County Clerk, Surrogate, Board of Elections, Board of Taxation and Prosecutor were prepared to open by appointment the following week. Mr. Lazorisak hoped that most county offices would be back up to full staff by July 20. He said all have been cooperative and diligent. "Knock on wood, we've been safe and secure here in Warren County," he said.

Mr. Gardner asked how many employees had contracted the coronavirus. "Just a handful," said Mr. Lazorisak, and noted preventative measures currently in place, such as temperature screenings upon arrival, mask protocols in common areas, and daily disinfecting procedures. "Everyone's chipping in," Mr. Lazorisak said, "We've been very safe."

County Health Officer Pete Summers said the latest COVID-19 data had been posted online earlier in the day and available for viewing in detail, so he only highlighted a few numbers: Warren County's average number of cases per day had been 2.8 for the past week, up from 1.7 the week before, and 2.5 the week prior to that. "It's still pretty low," he said, noting that our positivity rate was 3.2 percent, well below the 5 percent threshold for safe openings. Regarding the infection rate, currently at 1.0, Mr. Summers said we want that to be less than one. This number means we have one new case of infection for every positive case we have.

On re-openings, Mr. Summers said his department has been talking to our school districts, and he was pleased to report that all superintendents were "all of one mind" and working together to produce a good plan for reopening schools. Mr. Summers has been in contact with Health Officers of Hunterdon and Sussex to coordinate similar guidance for schools across the three counties, which the superintendents appreciated, as they wanted to take the same approach. He thought the schools would be in as good a shape as possible when they reopen in the fall. There will be some differences between grammar schools and high schools, and there will be some hybrid plans, with half the students attending Monday and Wednesday and the rest Tuesday and Thursday, for example, as well as some online education. "It's fluid because the state's guidance is fluid, too," Mr. Summers said.

#### FREEHOLDER COMMENTS

Mr. Kern was scheduled to meet with St. Luke's Hospital along with Phillipsburg Mayor Todd Tersigni at the end of the month to revisit maternity ward access policies, as New Jersey families have been treated differently than Pennsylvanians.

Mr. Sarnoski spoke of the primary election having been the prior day, and how things were more complicated due to the pandemic and mail-in ballot voting. He said the Board of Elections and County Clerk's Office were working diligently to count the votes, and it would take some additional time to confirm official results. He said he had not heard of any major issues with the primary. "Hopefully we get this process completed and we can have a normal election in November, which I really want," said Mr. Sarnoski.

Mr. Gardner asked if the Election Board expected things to run smoothly in November. "I think they're just trying to get through this one," said Mr. Sarnoski, noting it was a good test case for the future. There were some issues elsewhere in the state with regard to ballot dissemination, and the state's online resource providing polling place information apparently went down. Here, most issues seemed to be minor and dealt with accordingly. Mr. Gardner thought if November's election consisted of in-person voting, certain polling places would need to be reexamined because they are rather tight.

Mr. Gardner had nothing else to report, and hoped everyone was enjoying the summer.

Mr. Gardner opened up the line for closing public comments, reminding participants to keep their phone on mute unless speaking during public comment, but no one spoke out. There were no comments or questions from the press, either.

County Counsel Joe Bell withdrew his request for Executive Session, saying the one matter about which he intended to apprise the Board was not of any urgency and could wait until a later date.

# RESOLUTION ESTABLISHING RESIDENCY PREFERENCE FOR PROSPECTIVE EMPLOYEES OF WARREN COUNTY

**WHEREAS**, the County of Warren is authorized to promulgate residency requirements and standards for appointment to positions and employment in classified and unclassified positions; and

**WHEREAS**, the Board of Chosen Freeholders of the County of Warren has determined that such residency requirements promulgated herein as a residency preference will enhance the quality of employee performance and will produce general economic benefits flowing from local expenditures of employees' salaries;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Chosen Freeholders of the County of Warren, as follows:

- 1. Unless otherwise provided by law or by provision within this Resolution, it is preferred that all officers and employees hired by the local unit, the County of Warren, after the effective date of this Resolution be bona fide residents of the County of Warren. A bona fide resident for the purpose of this Resolution is a person having a permanent domicile within the County of Warren and one which has not been adopted with the intention of again taking up or claiming a previous residence acquired outside of the County of Warren's boundaries.
- 2. It is preferred that applicants for positions and employments in the classified service with the County of Warren at the exclusion of the Warren County Prosecutor's Office and the Warren County Sheriff's Office be bona fide residents of the County of Warren. The referenced exclusions are made in accordance with decisional and statutory authority. If the New Jersey Civil Service Commission, after ample advertisement, determines that an insufficient number of qualified residents exist for available positions or employment in the County of Warren, it may open eligibility lists for such positions or employments to qualified nonresidents pursuant to N.J.S.A. 40A:9-1.6, as set forth in Paragraph 3 of this Resolution.
- 3. Whenever the County Administrator shall determine that there cannot be recruited a sufficient number of qualified residents for available specific positions or employments, the Warren County Personnel Department shall advertise for other qualified applicants. The County Administrator shall thereupon classify all qualified applicants for such positions or employments so determined in the following manner:

- (A) Other residents of contiguous counties.
- (B) Other residents of the State of New Jersey.
- (C) All other qualified applicants.

The appointing authority should first appoint all those in class A and then those in each succeeding class in the order above listed and should appoint a person or persons in any such class to a position or positions, or employment or employments, remaining after all qualified applicants in the preceding class or classes have been appointed or have declined an offer of appointment. The preference established by this Paragraph shall in no way diminish, reduce or affect the preferences granted pursuant to any other provisions of the law. The New Jersey Civil Service Commission shall be notified that such preference schedule has been determined to be applicable for any specific position or employment, in order that the New Jersey Civil Service Commission may classify all applicants for such position or employment accordingly.

- 4. Whenever the County Administrator shall determine that there are certain specific positions and employments requiring special talents or skills which are necessary for the operations of the County of Warren and which are not likely to be found among the residents of the County of Warren, such positions or employments so determined shall, pursuant to N.J.S.A 40A:9-1.7 be filled without reference to residency. At the time of such a determination, the County Administrator will indicate the formal criteria under which it has been determined that the position or employment requires special skills or talents. The criteria pursuant to which such positions and employments shall be so determined are as follows: (A) Any position or employment, the services which are specialized and qualitative in nature; (B) Any position or employment which requires expertise and extensive training; (C) Any position or employment, the services of which will be required to be performed by an individual who has a proven reputation in the particular field or endeavor; (D) Any position or employment, the talents, skills, services or other important characteristics of which cannot be reasonably described by written specifications; (E) Any position or employment, the services of which must or foreseeably will be rendered or performed by a person authorized by law to practice a recognized profession or a person whose practice is regulated by law; (F) Any position or employment whose performance requires knowledge of an advanced type in a field of learning acquired by a prolonged formal course of specialized instruction and study as distinguished from general academic instruction or apprenticeship and training.
- 5. Notwithstanding anything provided herein to the contrary, in the event the County Administrator shall determine an insufficient number of qualified County and State residents exist for available positions or employment in the County of Warren, the County may, in its discretion, appoint an out-of-state resident for employment in such position, provided that any person so appointed shall have one (1) year from the time of taking the office, employment, or position to satisfy the requirement of principal residency in the State of New Jersey or otherwise obtain an exemption from that requirement on the basis of critical hardship in accordance with N.J.S.A. 52:14-7. In the event the person so appointed fails to satisfy the principal residency requirement or obtain an exemption from that requirement within the time herein provided, the person shall be deemed unqualified for the office, employment, or position and shall be subject to removal from the same.
- 6. Preference shall be given in promotion to officers and employees of the local unit, County of Warren, who are bona fide residents of the County of Warren. When promotions are based upon merit as determined by suitable promotion tests or other objective criteria, a resident shall be given preference over a nonresident in any instance when all other measurable criteria are equal. The preference granted by this Paragraph shall in no way diminish, reduce, or affect the preference granted pursuant to any other provision of law.

- 7. Should any portion of this Resolution be declared illegal or invalid by any court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect, the provisions hereof being fully severable;
- 8. This Resolution shall in no way affect or apply to persons already in the employ of the County of Warren as of the effective date of this Resolution. Nothing in this Resolution shall restrict employees from relocating their residence outside of Warren County after permanent employment, except that pursuant to N.J.S.A. 52:14-7, an employee that moves out of State is subject to disqualification from public employment in the absence of obtaining an exemption from the State residency requirement.
- 9. This Resolution shall take effect upon adoption of same.
- 10. All prior resolutions or parts thereof inconsistent with the provisions of this Resolution are hereby repealed as to such inconsistency only.
- 11. A copy of this Resolution shall be provided to the New Jersey Civil Service Commission-and all Warren County department heads, to indicate the intent of the Board of Chosen Freeholders. Any subsequent modification of this Resolution shall be forwarded to the New Jersey Civil Service Commission within twenty (20) days after adoption.

**WHEREAS**, county governments have led the way on the front lines and played a vital role in providing essential services and protecting the public health, safety, and welfare of residents across the Garden State during this once in a generation pandemic; and,

WHEREAS, county governments have incurred substantial costs in responding to the COVID-19 public health crisis by operating test centers, purchasing and distributing personal protective equipment, hiring public nurses, implementing mitigation measures, disinfecting county facilities, sheltering homeless and at-risk individuals, managing correctional facilities, administering social services programs, conducting elections, and more; and,
