We Freeholders try to make accommodations for our friends with disabilities, and we must also do so throughout our culture, and recognize the integral roles they play in our society.

"I can't say enough for the Advisory Council and our Human Services Department," Mr. Kern said, noting that they continually help "play matchmaker" in identifying the many different organizations around the state and advocating for those with disabilities. He thought so many businesses in the private sector have done a great job in terms of inclusiveness. Mr. Kern said he thought this was some of the finest work we could all be doing. He thanked Human Services Director Shawn Buskirk,

Aging & Disabilities Services Division Director Lakshmi Baskaram, and members of the Advisory Council on Disabilities, for all they do.

Mr. Gardner echoed his colleagues' comments, adding sometimes we go along with our daily lives and don't think too much about individuals with disabilities, but he made note of the recent Supreme Court confirmation hearings, when it was revealed that a blind woman was able to clerk for one of the justices. "I thought that was just incredible," he said, due to the enormous demands placed on that position. This shows folks with disabilities are breaking their own glass ceilings and barriers to achieve amazing things. Mr. Gardner said Warren County had a wonderful Human Services Department.

Lakshmi Baskaram accepted the proclamation with gratitude, and said this year marked the 75th observance of National Disability Employment Awareness Month, as well as the 30th anniversary of the Americans with Disabilities Act. She said the Division was evaluating applying for an implementation grant through Rutgers to build strategically inclusive communities. If we receive the grants, Ms. Baskaram said they would look forward to working across departments and with local community partners to help implement initiatives that are truly sustainable and inclusive of individuals with disabilities.

REPORTS AND COMMENTS

County Counsel Joe Bell said he had several matters of litigation to be discussed in Executive Session.

County Engineer Bill Gleba had nothing new to report. Mr. Gardner said he had been receiving several compliments on how good our county roads are.

County Planner Dave Dech reported that he had scheduled a Scenic Byway WebEx meeting for November 16.

County CFO Kim Francisco had no report.

County Administrator Alex Lazorisak said the most recent vacancy report for the Board's approval contained nothing out of the ordinary.

Regarding COVID-19, he said this was day number 231 since the formation of the task force, and numbers were going up slightly. He provided financial status relative to the pandemic. The county had made five submissions to FEMA totaling \$618,915 to date, and no money had been received. The first CARES Act funding we received came in three parts. The first was \$397,404, which was a direct reimbursement of the 25 percent that FEMA does not cover. The second was \$357,500 to be put toward a testing site and related materials to continue testing. Mr. Lazorisak was happy to report that portion had been deposited into our account two days prior, without any notification. "Finally, I can report that we have a check in the bank," he said. The third part was \$627,636 to be devoted strictly toward testing. He hoped to receive that money soon, as the State of New Jersey had approved the testing plan submitted by our Health Department and task force.

The deadline to apply for the latest round of CARES Act funding, totaling \$802,682, is due November 10. Mr. Lazorisak said our County CFO was diligently working on it, and he hoped to get it submitted by November 2. He said this portion required a high level of detail, noting some items for which we applied through FEMA had been removed, so this was another means to recoup. "It's very complicated just trying to get some money back," he said.

Mr. Gardner in inquired about the expenses associated with the first testing site. Mr. Lazorisak said those were hard numbers, and while he didn't have precise figures in front of him, confirmed the county was out of pocket in excess of \$1 million. "We're tracking them all, we're submitting them to FEMA, we're submitting them to both pairs of the CARES Act funding," Mr. Lazorisak said, "We'll see what gets paid and what doesn't get paid."

On a related matter, back in June the Freeholders had passed Resolution 245-20, reimbursing restaurants \$75 for a special outdoor liquor license permit. That expires November 23, and the State of New Jersey is now charging restaurants an additional \$10 to maintain that permit. The prior reimbursement came out of the Economic Development Committee's budget, and there was still money in that account. Mr. Lazorisak asked if the Board was amenable to reimbursing this additional fee. Mr. Gardner said, "This is crazy that the state would even ask for that. These people are dying on the vine. Unbelievable." Mr. Kern thought it would cost more just to administer it. Mr. Sarnoski thought this was the perfect use of EDC money. Mr. Lazorisak was to prepare a resolution for the next meeting.

Regarding the coin toss matter discussed at length at the Board's October 14 meeting, Mr. Lazorisak reported on information he had gathered since then. He went over some crash data at the intersection of County Routes 519 and 623, which demonstrated that accidents there have been slowly on the rise in recent years. A survey of 16 other counties revealed that 10 do allow the practice; four refer requests to local

municipalities; and two do not allow it. There was a wide range of protocols. He reviewed the statutes with County Counsel, and while there are statutes in place that provide the county with immunity, he suggested a number of additional requirements should be implemented, such as applicants obtaining peddler's licenses and disallowing certain intersections. He asked for a few more weeks to compile protocols, and hoped to have a resolution prepared for January. Mr. Sarnoski thought this was reasonable, and Mr. Gardner agreed it was a positive approach.

FREEHOLDER COMMENTS

Mr. Kern reported having hosted a virtual meeting with County Planner Dave Dech and municipal leaders regarding the traffic study completed the prior month, saying attendance was poor. Likening the effects of industrial zoning to a fire, he made the following analogy: "The towns that already have the fire were the ones that were there, and those that should be aware weren't there," he said. Without naming individuals, he confirmed representatives from the following municipalities attended: White, Hope, Pohatcong, Knowlton and Harmony. Moving forward, Mr. Kern proposed a regional approach (south, central and north) to foster more participation.

Mr. Gardner thought that was a wise approach, noting he thought some were missing the point. In addition to 18-wheelers, warehouses can bring in straight trucks capable of navigating local roads. Mr. Sarnoski was disappointed more towns weren't interested in being updated on their regional transportation issues, and thought the Freeholders couldn't make it much easier than by hosting an online meeting. He applauded Mr. Kern for his continued efforts. Mr. Kern noted that public demand was important, and if the residents do not put pressure on their local officials, it was unlikely to change.

Mr. Kern moved on, sharing that he had been on a call earlier in the day with Election Administrator Bill Duffy, County Prosecutor Jim Pfeiffer, Public Safety Director Frank Wheatley and other public safety officials to make sure plans were in place for a number of scenarios that may occur with respect to the upcoming election. "I can tell you that our local law enforcement, our State Police and our County Prosecutor are doing a great job and are ready for that," he said.

Mr. Kern thought it was great that the Department of the Interior recently designated the Musconetcong as part of the Wild & Scenic River Trail.

Regarding the money received from the CARES Act, Mr. Kern said the whole process was very frustrating, and it was difficult to devise strategies and know what our budget is going to look like next year. County CFO Kim Francisco said it was nice

to get the money, but the timing was inopportune, with only about a month to spend it. Discussion continued, and Mr. Gardner took issue with New Jersey being the only state to keep 911 money - close to \$1.3 billion.

Lastly, Mr. Kern reminded everyone to be sure to vote.

Mr. Sarnoski picked up on that, reminding everyone of this year's unique voting procedures, including where to turn in ballots.

Mr. Sarnoski reported on having presided over a recent NJTPA planning and prioritization committee meeting. He again voted "no" on the Transportation Improvement Plan (TIP) because the Route 80 project was still included, with something like a \$65 million price tag; and the intersection of Routes 57 and 519 – which we desperately want – had been pushed back again. "I think I'm being heard, but nothing's changing, unfortunately," he said.

Mr. Sarnoski said the state had extended outdoor dining premises permits to be valid through March 31. If the COVID numbers didn't start coming down, Mr. Sarnoski expected the governor might close down indoor dining again. He said Warren County would support the opportunity for outdoor dining with heaters.

Regarding the Musconetcong designation, Mr. Gardner thought it was great.

Mr. Gardner said he wanted to set up a meeting on the Route 80 rock fall mitigation "fiasco" after the election, saying the plan was to spend roughly \$200 million within a 25-mile radius. He didn't care if it was federal or state money – he said it was throwing away taxpayer and ratepayer money. "It's outlandish," he said.

Mr. Gardner then asked if there were any closing public comments, reminding phone participants to mute their phones unless speaking. An individual could be heard on the phone, but not clearly understood, and it did not seem as if she was addressing the Board.

Lori Ciesla approached the Freeholders to thank them for a number of actions, including recognizing Christine Rusin; paying the \$10 liquor fee on behalf of restaurants; and the Board's continued support of the local arts grant program (agenda item E-13/Resolution 446-20), saying the Arts Coordinator does a great job and it is a big help to Lopatcong Township's recreation program. She also agreed with Mr. Kern in terms of taking a regional approach to meeting with municipalities regarding the warehouse/traffic issues facing the county, and reminded everyone that ballot drop

boxes would be locked at 8 p.m. on Election Day.

There were no questions or comments from the press.



- (2) Matters Relating to Collective Bargaining: Items to be discussed include: PBA Local 280 – Sheriff's Officers, CWA Local 1032 - Prosecutor's Clerical, PBA Local 331 - Prosecutor's Detectives, FOP 171 -Corrections Officers.
