The Board of County Commissioners of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on March 10, 2021 at 6:00 p.m.

Due to social distancing directives, this meeting was conducted without any members of the public in attendance. The public had the opportunity to listen to the meeting, and participate if they chose, via internet and telephone.

The meeting was called to order by Director Kern at 6:01 p.m. and upon roll call, the following participants were present: Commissioner Lori Ciesla, Commissioner Deputy Director Jason Sarnoski, Commissioner Director James Kern III, County Administrator Alex Lazorisak, Assistant County Counsel Joe Bell IV, County CFO Kim Francisco, County Engineer Bill Gleba, County Planner Dave Dech and Deputy Commissioner Clerk Holly Luberto. County Health Officer Pete Summers participated online.

PUBLIC COMMENTS (AGENDA ITEMS ONLY)

Columbia (Knowlton Township) resident Tara Mezzanotte said she was speaking as a representative of the I-80 coalition. "Our goal is to stop the wall, preserve the gap, and fix the s-curve," she said. Having set on this mission almost two years ago, she said they had no idea this thing would be so stubborn. Ms. Mezzanotte thanked the Commissioners for sticking with the group and listening to Knowlton and Hardwick's pleas for help. "We're not contesting that rockfall mitigation may be needed," she said, but thought the current proposal was not effective or respectful of the natural beauty of the area. Further, Ms. Mezzanotte said there was the potential for disrupted traffic for five years. She referred to a letter Commissioner Sarnoski had sent to the NJ TPA in 2018, expressing opposition to the rockfall project as proposed, with its \$59 million price tag (at the time), and requesting it be removed from the TIP (Transportation Improvement Program). She was very grateful for the support.

All three Commissioners thanked Ms. Mezzanotte for her comments, and Mr. Kern said they would each be making comments later, when voting on the resolution.

William Collins of Bucks County, Pennsylvania (across the Delaware River from Hunterdon County, New Jersey) spoke as a representative of the Devil's Tea Table Alliance of Hunterdon and Bucks Counties. The alliance is opposed to a similar but smaller project for Route 29 in New Jersey. Collins said the plan threatens the scenic beauty of the Devil's Tea Table, a rock formation in Kingwood Township, near Frenchtown. He hoped the Hunterdon County Commissioners would be urged by local mayors to pass a resolution similar to the one (agenda item E-5) under consideration by this board this evening. He thanked the Warren County Commissioners for their leadership and for providing the model.

Commenting on the opposition to the rockfall project, Mr. Sarnoski began by thanking Ms. Mezzanotte and her group for taking the time and making the effort to compile so much data. It was helpful for this board to advance its efforts to further intelligent discussion against the DOT's proposal. He also expressed appreciation to Mr. Collins for his support, and for pointing out that this is not just a Warren County issue, but a regional one.

As Ms. Mezzanotte had said, Mr. Sarnoski had started out by asking for the I-80 project to be removed from the TIP entirely, and the 57/519 project be moved up on the timeline. The process was now underway to reevaluate the TIP for next year. In a written response to Mr. Sarnoski's letter acknowledging his concerns, the NJTPA said the only people who could remove the I-80 rockfall project from the TIP was the sponsoring agency. "Well surprise, surprise, the sponsoring agency is the NJ DOT, and they are not going to remove the Route 80 rockfall project from the TIP," Mr. Sarnoski said. "So this is how these projects get on there," Mr. Sarnoski said, "They get on the TIP as a reasonable five million dollar project, where they talk about wanting to do rockfall remediation, and it seems reasonable... then five million goes to \$12 million in two years, and then \$12 million goes to where we are now - at \$65 million - for a mile of road, which is absolutely preposterous."

The County Commissioners' current proposal was to revert back to the six million dollar range and talk about reconfiguring this project, seeking local feedback and environmental impact studies. This was now being recognized as a regional issue, and he hoped other Boards of County Commissioners in the area would pass similar resolutions. His said nobody wants to fully reject the TIP, as it includes many worthy projects, but "A lot commissioners recognize that the 80 rockfall project, and rockfall projects in general, are not going in the right direction, and are not being programed properly," Mr. Sarnoski said, hoping the NJ TPA would listen if the movement garnered enough support. "If not, why are we there? Are we just a rubber stamp for these projects from the DOT? I don't think so, and I won't accept that, so I'm happy to have this here tonight," Mr. Sarnoski said.

Ms. Ciesla thanked Mr. Sarnoski for putting forth the resolution, as well as Ms. Mezzanotte for providing information and support, and Mr. Collins. "It's not just I-80," she said, "Now it's I-78; it's also the Devil's Tea Table and all these areas." Ms. Ciesla agreed when we add it all up - plus the potential problems these projects may bring - the amount of money was ridiculous. "Warren County is on the precipice of having some major, major traffic issues," she said. "And the fact that they're ignoring the Route 57/519 project, and concentrating on one mile of I-80 - that isn't even going to fix the actual traffic issue — is ridiculous," said Ms. Ciesla, adding there was support from Senator Oroho to stop it from a legislative perspective.

Mr. Kern began by thanking Ms. Mezzanotte and Mr. Collins for their involvement, emphasizing the value of continued local, grassroots movements. He also thanked Commissioner Ciesla for picking up the ball from the recently retired Freeholder Rick Gardner and really learning about the issue, as well as Commissioner Sarnoski for his efforts. Mr. Kern thought the problem was actually national, not just regional. "This is a national park; this is one of the most visited areas in the country," he said, and thought it was disrespectful to destroy the scenic aspect of the area. "After this past year with COVID, where people are coming out here and seeing the beauty of Warren County, and you want to put up a wall," Mr. Kern said. He noted the issue was uniting people of different political parties and from different states. He was confident there was some positive momentum to rein in the project, and was proud to support this resolution.

Ms. Ciesla said we need to ensure we get enough vaccine for our teachers, and get kids back in school.

Mr. Sarnoski said we have heard the call to get our kids back in school, and the only way to achieve that is to get our teachers vaccinated. "The children are not receiving the vaccine, but it's the children who can transmit (COVID-19) to the teachers, who can go home and transmit it to their families, and maybe their elderly parents... and so on," he said. In terms of getting answers from the state regarding vaccine supply, "We're on 'pause' constantly," Mr. Sarnoski said. He credited Commissioner Kern for spearheading efforts to obtain more vaccine supply. He said the county was ready for it, was doing a good job with distribution, and simply needed more vaccine.

Mr. Kern critiqued New Jersey's vaccine rollout plan, with so many different tiers of eligibility and people competing with each other, saying an age-based approach would have been more successful. "Before we can cross a threshold, we continue to open up the vaccine for more people, so we're constantly moving the goalposts here on how we can vaccinate," Mr. Kern said. The perception was that once teachers were eligible, they could easily obtain the vaccine, which was not the case. Plans were in place to get all teachers vaccinated, but "Unfortunately, there's that nothing we can do because we don't have the vaccine," said Mr. Kern, "All we're saying is if you give us the vaccine, Governor, we can get the teachers vaccinated."

County Engineer Bill Gleba reported notification from the NJ DOT that Route 31 would be resurfaced in late summer/early fall of this year, from Asbury Anderson Road near the former A&P, up to Route 46. Our county roads will be utilized for detours.

County Planner Dave Dech had no report.

County CFO Kim Francisco said the county budget had been advertised and made available for public review; final adoption was scheduled for the next County Commissioners meeting.

County Administrator Alex Lazorisak said the vacancy report contained nothing out of the ordinary.

Regarding COVID-19, Mr. Lazorisak alluded to a phone call with the governor's office earlier that evening, and he reviewed some statistical numbers from the state's website. "First of all, I can assure every county resident that we have not the county has not - been receiving 10,000 vaccines in whole, per week," he said. According to the state website, to date, 18,118 first doses of vaccine had been administered to Warren County residents, and 8,151 second doses, for a total of 26,269. Individuals age 18 and older represent about 80.7 percent of Warren County's population. "So, out of 105,260 residents, 84,950 are 18 or older," Mr. Lazorisak said, and that was the target we've been trying to reach. He said it had been frustrating and a struggle to obtain data from the state regarding the outstanding number of residents age 65 and older still in need of vaccine. "We're doing the best we can, we're trying to target our seniors," he said.

Mr. Lazorisak thanked Dennis Riley, Transportation Coordinator Jan McDyer and the Health Department for some good news with respect to implementing an initiative to vaccinate homebound individuals. The task force was able to schedule transportation for 43 residents of Allamuchy's Colonial Manor to be vaccinated on March 18. He hoped this outreach would continue to grow. The call center was working very well, with about 22,000 calls fielded in six weeks.

Regarding teachers, of the 500 vaccine doses allotted this past week, 112 went to teachers. Mr. Lazorisak noted many of those were for Warren County residents that teach outside the county. He again expressed frustration in the governor "just opening the floodgate," with insufficient control and planning.

Warren County libraries were scheduled to reopen for full service four days a week beginning March 15. Curbside service would continue, and the Northeast branch would remain closed for repairs.

"Tomorrow will mark day 365 – one year – since we established the Warren County COVID task force," Mr. Lazorisak said, thanking all department heads, county employees, and all three Commissioners for the support.

Mr. Kern thanked all involved on the transportation initiative to vaccinate those in the Allamuchy long-term care facility.

County Health Officer Pete Summers began by thanking the Board of County Commissioners for its determination to obtain more vaccines to get to teachers. "I can say that if we get vaccine, we can do it in a week," he said with respect to Warren County teachers. School nurse volunteers were lined up to help.

Mr. Summers said 21.77 percent of Warren County's adult population had been vaccinated to date, two and a half months into the program. A goal had been to vaccinate 70 percent within six months. "We're still in the game," Mr. Summers said, "But we're going to need more vaccine if we're going to get to that bar by June 30."

Our rates came down a bit. There were about 31 cases per day in the past week. One interesting statistic was that the 18,118 vaccinations was almost three times the number of people who tested positive for the virus. "So we're definitely making some progress there," said Mr. Summers. New Jersey was to increase restaurants' capacity up to 50 percent the following week. As we open up, Mr. Summers urged everyone to continue wearing masks as we wait for more vaccine. "The vaccine is going to come, it's just going to take a little longer," he said.

COMMISSIONER COMMENTS

Approaching the one-year mark since the pandemic hit, Lori Ciesla expressed gratitude to the COVID-19 task force, Pete Summers and others who have been "Doing the best job throughout the state to keep our residents safe, make sure they get vaccinated, and just keeping us involved and informed," she said.

Regarding I-80, she again thanked Ms. Mezzanotte and Mr. Collins for their remarks. "We're doing everything we possibly can... Warren County has a lot of traffic issues, is going to have even possibly more, and that's what we need to focus on, and we need the NJ DOT to be a partner with us in this," said Ms. Ciesla.

With respect to the public outcry to get kids back in school, Ms. Ciesla said, "We hear you, we're listening to you, and we're just trying to get our teachers vaccinated as fast as we possibly can."

Having been in contact with Congressman Gottheimer concerning internet accessibility, Ms. Ciesla said on the federal level, they are starting to change how our is classified, so we may be able to obtain some grant money. "Right now, we're not

considered rural because they don't consider New Jersey a rural state, but they're looking to change that... to get everybody wired up so they can get better internet service," she said, noting the difficulties of working and schooling from home without internet access. Mr. Sarnoski pointed out that changing that designation would help with grant opportunities in other areas as well, not just internet access. "I don't think they realize how rural we are here," he said.

Mr. Sarnoski reported on a meeting earlier in the day with Congressman Gottheimer, Congresswoman Sherrill, Congressman Malinowski, and Senator Corey Booker with respect to a potential northwest New Jersey veterans center (Sussex, Warren, Morris, and Hunterdon counties). Currently, our veterans drive quite far for veterans' services. The concept is still in its infancy, but Mr. Sarnoski voiced his support.

The latest early voting rules and laws were discussed at a different meeting. He thought the state "dropped the ball" once again by imposing regulations without proper planning and cost considerations. Early voting may begin up to three weeks prior to the election. He said two million dollars was pledged for these preparations for the entire state. "That is not going to get us anywhere," Mr. Sarnoski said, "It's a significant cost for us." NJAC was strongly advocating on behalf of the counties for more funding, but it was going to be a challenge. "We wonder why this state is one of the most taxed states in the country... it's because we create laws that are just so costly for us to implement," he said. Things like this drive the cost of living and taxes up so high.

Mr. Kern reported having lobbied Congress on behalf of the Musconetcong Watershed Association, for funding for the Wild & Scenic designation for the Musconetcong River. He said all the towns along the river have adopted that resolution. "It's a good thing, it's a protection for that river," he said, noting dam removal and temperature monitoring. Mr. Kern had approached the offices of Congressmen Gottheimer and Malinowski, and they were both very receptive.

The pandemic has prevented the presentation of many of the certificates of merit and proclamations that are normally customary throughout the year, but Mr. Kern recalled that last year around this time, the board endorsed a proclamation marking the anniversary of women's suffrage and honoring women in leadership. "Commissioner Ciesla was in the audience as a former elected official, and I just wanted to acknowledge and say it's great that she's on the board now... it's good to have representation and it's great to have you up here," said Mr. Kern said to Ms. Ciesla.

CLOSING PUBLIC COMMENTS

Tara Mezzanotte of Knowlton thanked the board again for passing the I-80 rockfall resolution, and then mentioned a 33-page document produced by the NJ DOT, which it refers to as a traffic study to be used for an environmental assessment and to form an opinion regarding potential impacts on traffic resulting from the project. She felt there were errors and omissions, and asked if the Warren County Engineer's Office could review the document and submit its opinions.

Mr. Sarnoski said the county did review the document (himself and County Planner Dave Dech), and submitted comments to Ms. Mezzanotte. He said to conduct a full engineering review would be costly and very time-consuming, would probably have to be contracted out, and he didn't think that was the direction we wanted to take just yet. "Let's see where this goes," he said, and believed there would have to be an environmental impact study regardless. "I'm not in favor just yet of having our engineering group refute something that we can't stand behind with engineering documents of our own, without spending a significant amount of money," said Mr. Sarnoski. Ms. Mezzanotte then asked him to go on record with a formal letter to the DOT with the comments from Mr. Sarnoski and Mr. Dech. Mr. Sarnoski said he would revisit the comments and likely send them on to the DOT.

John Best of *The Express-Times* said he missed the beginning of the meeting and wanted to confirm that the rockfall resolution was passed.

Knowlton Township Mayor Adele Starrs first thanked the county for its representation on the phone call with the governor's office earlier that day regarding vaccinations. "They are not doing justice to Warren County and their claim that they are distributing 10,000 doses of vaccine to Warren County a week is just nonsense," she said.

Mayor Starrs thanked the commissioners very much for the rockfall resolution. She said Knowlton Township had requested to be a consulting party on the project – a higher level than its current "cooperating" status – and the Federal Highway Administration and NJ DOT said they would not allow it because the township had local observations, not expertise. She said that was very disheartening, and the county's involvement "Helps counter the way that they are treating us; that we don't deserve to be full stakeholders sitting at the table," she said.

Mr. Kern thanked Mayor Starrs and Ms. Mezzanotte for their continued leadership on I-80. He also thanked the mayor for chiming in with questions on the vaccine phone call, resulting in a senior staffer jumping on the call.

Mr. Sarnoski added if anyone was wondering what they could do now that the County Commissioners had passed this resolution, he suggested Mayor Starrs reach out to her contacts and ask them to pass similar resolutions. "That would be the strongest message," he said. "That is my mission for the next week," said Mayor Starrs.

There were no further questions from the public or the press.

RESOLUTION OPPOSING THE INTERSTATE 80 ROCKFALL PROJECT AS CURRENTLY PROPOSED BY THE NEW JERSEY DEPARTMENT OF TRANSPORTATION (NJDOT) AND URGING THE NJTPA TO REPROGRAM THE PROJECT IN THE TRANSPORTATION IMPROVEMENT PROGRAM AND REDESIGN THE PROJECT IN CONSULTATION WITH PUBLIC AND PRIVATE STAKEHOLDERS AT THE LOCAL, STATE, AND FEDERAL LEVELS

WHEREAS, the middle and upper Delaware River segments were designated a National Wild and Scenic River in 1978 by Congress and President Jimmy Carter in 1978, and the lower Delaware River was designated by Congress and President Bill Clinton in 2000 and;

WHEREAS, in 2015 an application for Scenic Byway designation was submitted to the NJDOT Scenic Byway program for approval and was subsequently rejected because the NJDOT does not consider applications in areas that are in design or construction; and

WHEREAS, designation in the National and State Scenic Byway programs would have allowed for funding opportunities to help protect and promote the Delaware River Water Gap National Recreation Area as a national and worldwide treasure; and

WHEREAS, the I-80 Rockfall project DB# 09545 first appeared in the North Jersey Transportation Planning Authority's FY 2012 – 2015 Transportation Improvement Program (TIP) with a projected outyear construction cost of \$6.0 million; and

WHEREAS, the FY 2012 TIP's project description stated that "a problem statement had been submitted, detailing rockfall hazards in this section of I-80 and that the recommended remedial action would consist of analysis, design and implementation of rockfall mitigation measures, including, but not limited to: scaling, rock bolting, wire mesh, and catch fences"; and

WHEREAS, in the FY 2016 TIP the project description changed to "Initiated from the Rockfall Hazzard Management System, this project will stabilize the existing rock outcrop area adjacent to I-80 Westbound at four locations within the project limits" with a subsequent project cost estimate increase to \$18.165 million, already doubling in cost in two years; and

WHEREAS, the project continued to appear in subsequent TIP's and projected costs increased to \$65 million in FY 2018 and \$59 million in FY 2020, demonstrating the uncertainty in cost estimates and confirming a three-fold increase over the 2016 estimate and 10 times more than the estimate projected in 2012; and

- WHEREAS, alternatives to mitigate the purported rockfall problem have not been presented in a meaningful way in which they can be discussed and vetted thoroughly and thoughtfully with the stakeholders in the region; and
- **WHEREAS**, the NJDOT's Concept Development Report prepared in September 2011 states that between 2003 and 2008 there were two "rockfall incidents", on the same day, that resulted in lane closures, and were weather related resulting in mudslides/washouts; and
- **WHEREAS,** the Concept Development Report stated that between 2007 and 2009 there were 81 total crashes in the project limits, two of which were caused by rockfall, which occurred on the same day on 10/7/10 10:54 PM near M.P. 1.2 and at 11:05 PM near M.P. 1.0; and
- **WHEREAS**, the Concept Development Report states that "the crash rate for this section of Route I-80 exhibits a relatively unsafe crash record as it is above the year 2009 statewide average for roadways with similar cross-section. The crash rate of 4.52 crashes/mvm (million vehicles miles) was above the Statewide Crash Rate for the year 2009 of 2.86 crashes/mvm."; and
- **WHEREAS**, the Concept Development Report identified a number of geometric deficiencies which may contribute to the higher crash rate for this section of I-80; and
- **WHEREAS**, the NJDOT has not provided current crash figures that may be related to rockfall incidents since the Concept Development Report was prepared; and
- **WHEREAS**, the current preferred alternative does not correct the geometric deficiencies that were identified in the Concept Development Report; and
- WHEREAS, the Rockfall project appears to be lacking sufficient study and analysis including a full and comprehensive traffic study, a historic/archeological impact study, a Delaware River Wild and Scenic River visual and environmental impact study, and an Environmental Impact Study; and
- **WHEREAS,** the NJDOT selected a preferred alternative without the concurrence of local officials and stakeholders in the bi-state region; and
- WHEREAS, concurrence on the NJDOT preferred alternative has not been obtained from the National Park Service, the NJ State Department of Parks and Forestry, the NJDEP Land Use Regulation Program, the Delaware River Basin Commission, the Delaware River Joint Toll Bridge Commission; and
- **WHEREAS**, United States Congressmen from New Jersey and Pennsylvania, the State legislators from New Jersey and Pennsylvania, County Commissioners, and local elected officials from both States have officially opposed the project; and
- WHEREAS, Senator Oroho and Assemblymen Space and Wirths have introduced bills S2863/A4601 that state that the Department of Transportation shall not plan for, design, or construct, or use funds for the planning, design, construction of, a rock wall between milepost 1.00 and milepost 1.50 on Interstate Highway Route 80, and that for any departmental project for rock fall mitigation between milepost 1.00 and milepost 1.50 on Interstate Highway Route 80, the department shall conduct a full analysis of all feasible options for rock fall mitigation, provided that any such option shall not include the construction of a rock wall; and
- WHEREAS, the NJDOT has refused to meet with local elected officials to keep them informed and to discuss other alternatives despite past NJDOT practice to gain local support or at least ensure there was no local official opposition before proceeding with projects; and

WHEREAS, the preferred alternative selected by the NJDOT is costly and does not address the high number of crashes that do occur on this segment of highway between mileposts 1.0 and 1.5 that contain the S-curves; and

WHEREAS, the funding being programmed for the I-80 Rockfall project could be spent on improving the safety of motorists traveling through the S-curves and on many other worthwhile transportation projects in the NJTPA region that would address known documented safety problems; and

NOW, THEREFORE BE IT RESOLVED, that the Warren County Board of County Commissioners requests that the NJTPA;

- 1. Reprogram the I-80 Rockfall project, DB# 09545, in the FY 2022-2025 Transportation Improvement Program to Concept Development to re-evaluate and re-engineer the project to bring the final estimated construction costs into the \$6.0 million range as originally estimated in the FY 2012 TIP.
- 2. Meet and consult with local officials during concept development to address all of the concerns raised by local, state, and federal officials and stakeholders including but not limited to: visual impacts, traffic management during construction, roadway safety improvements through the project area, and cost.

BE IT FURTHER RESOLVED, that copies of this resolution be transmitted to all of the County Commissioner Boards in the NJTPA region and request that each Board of County Commissioners support and adopt concurring resolutions.
