County CFO Kim Francisco was away.

Ms. Ciesla said she was very thankful for the Department of Human Services and Division of Aging & Disabilities, as well as groups like Abilities that help find employment for clients and support for caregivers. She spoke of a family member who suffered brain damage resulting from an accident in his youth, who derives great joy in the employment he was able to procure through the services in his county. "I think it makes a big difference to everybody," she said.

Mr. Sarnoski said employment was such an important aspect of our society. He was grateful to Abilities and other organizations that help make positive changes to benefit the community and economy.

Mr. Kern said prior to the pandemic, he had the privilege of visiting the Abilities Thrift Shop in Pohatcong, where they teach clients work and life skills. He thought it was wonderful to have such a tremendous support staff in Warren County, helping individuals of all walks of life. Warren County has long been a supporter of these types of organizations, and Mr. Kern said it would continue to be. "To do this proclamation is a great honor," he said.

Accepting the proclamation was Cindy Wildermuth, CEO of Abilities of Northwest Jersey, Inc. She thanked the commissioners, and the county as a whole, for the continued support for the community served. She said more than 800 individuals had been placed in employment over the years. This year's theme was "America's Recovery: Powered by Inclusion". Ms. Wildermuth said everybody has different talents, strengths and skills. "It's important to remember to include those in the workforce," she said.

#### PUBLIC COMMENTS (AGENDA ITEMS ONLY)

Tara Mezzanotte of the I-80 DWG Coalition took the lead on remarks relative to agenda item E-2, requesting the NJ DOT initiate a problem statement to study the safety, mobility, and congestion issues on I-80 from exit 4/Columbia to the Delaware Water Gap Bridge. She was accompanied by a number of stakeholders from New Jersey and Pennsylvania. "We've all been really fighting pretty hard against big government," she said, adding that these small, rural communities didn't have much of a chance individually, but collectively – with the support of county government – they hoped to be heard. She expressed gratitude to the commissioners for the aforementioned resolution, and for sending a letter to senators Booker and Menendez in support of Congressman Gottheimer's amendment to defund the rockfall project. "It would accomplish the same goal," she said, "to slow the rockfall project down and give us a chance to pressure the NJ DOT to do their job, which is to keep us safe and fix the s-curve."

The following individuals each took a turn thanking the commissioners and Ms. Mezzanotte on behalf of their constituents for their actions in support of this bi-state, bi-partisan effort: Sandra Newman, Vice Chair of the Lower Mount Bethel Township, PA Board of Supervisors; John Bermingham, member of the Upper Mount Bethel Township, PA Board of Supervisors; Kevin Duffy, Mayor of Hardwick Township, NJ; Larry Freshcorn, Mayor of the Borough of Delaware Water Gap, PA; and Frank Van Horn, former mayor of Knowlton Township.

Mr. Van Horn, a local character, spoke of having run milk trucks on that stretch of Route 80 for 45 years, calculating he had made about three million trips through the Delaware Water Gap, never once encountering a detour due to rocks falling. "This is a generational decision," he said, one that will affect our children and grandchildren. He thought the public should be able to vote on this project. He thought the citizenry should have a say, and pointed out that the people making these decisions were appointed, rather than elected. "I want you to be proud of doing this, because this is the right thing to do," Mr. Van Horn said to the commissioners.

Chuck Walsh of Knowlton Township spoke in support of agenda item E-3, the restoration of passenger rail service, on behalf of North Jersey Rail Commuter Association and Lackawanna Cutoff Historical Committee. He was also appreciative of the I-80 endeavors being discussed.

Mr. Sarnoski thanked all those who remarked earlier for their encouragement. "All of you supporting us, and all that you have done, makes it so much easier," he said, and singled out Ms. Mezzanotte for being such a driving force and honing in on the data. "I've been vocal on the NJTPA, but unfortunately, we have to keep putting pressure on all those members, because one vote is just not going to do it, we're going to need multiple," he said, "I want to thank everyone for all their hard work."

Ms. Ciesla echoed Mr. Sarnoski's sentiments, and complimented Ms. Mezzanotte for being able to gather small towns together to form a larger entity that keeps fighting this. She hoped these efforts would buy some time to fix the problem. "Together, we're mighty, and hopefully, it will work," she said.

With respect to the passenger rail service, Ms. Ciesla said it would make a big difference. With all the warehouse development occurring in our area, rail would alleviate some problems.

#### **MINUTES**

First commenting on I-80, Mr. Kern mentioned participating in a rally on the Pennsylvania side of the river this time last year. "We've come full circle here, and yet we've still not seen any progression from the state government on this issue, so again, your persistence is tremendous and I thank you," he said.

Moving on to the passenger rail resolution, Mr. Kern said anyone who drives on Route 80 or 78 has seen rail disappear and vehicular traffic increase. He recalled having participated in a call with the Trump administration back when he was mayor of Pohatcong, and being told there was no funding available for rail in the Lehigh Valley. "Now there's an opportunity where there is funding available, so Warren County is taking the position that if there are going to be some infrastructure improvements, this is one that should happen because it will benefit everyone here in Warren County, both along the Route 80 corridor and the Route 78 corridor," said Mr. Kern.

County Counsel Joe Bell, IV advised he had no report for public session.

County Engineer Bill Gleba had no report.

County Planner David Dech reminded the commissioners that the county's paper shredding event would be held Saturday, September 25 from 8-11 a.m.

County CFO Kim Francisco was absent.

County Administrator Alex Lazorisak offered to answer any questions regarding the latest vacancy report, but there were none. He was happy to report that the renewal for general liability from the NJiiF had come through. "Thanks to Randy May and John Daly, they're keeping our rates flat," he said, and planned to prepare a resolution for the next meeting. "That's significant," said Mr. Sarnoski.

Mr. Kern summoned Public Safety Director Frank Wheatley to report on Hurricane Ida developments. Mr. Wheatley said two weeks prior, Warren County Emergency Management, along with NJ State Police and FEMA, had toured a majority of the municipalities to compile a sampling of residents that had sustained damage. Warren County was subsequently declared a disaster area for individual assistance. Earlier in the day, a disaster relief center opened up in Franklin Township. Residents who suffered damage may bring documentation and apply for assistance. Mr. Kern noted that Warren County did not initially make the list, but "Thanks to your office, the State Police, the local police and county staff, you helped make that happen, so we appreciate your efforts on that," he said.

#### COMMISSIONER COMMENTS

Ms. Ciesla thanked Joe Lake and the 9/11 Memorial Committee for the great ceremony they conducted on September 11, one of several observances throughout the county. She had also attended one in Hope, which she said put up a beautiful memorial.

She thanked Art Charlton and his team for the new website. "It looks great, it's awesome," she said, adding she knew it was a lot of work to make it happen.

Ms. Ciesla advised everyone keep an eye on election information provided by the County Clerk's Office. There will be a number of changes this year, including early voting. "When you go in, it's going to be a different experience, but hopefully it will work out well," she said.

Lastly, Ms. Ciesla reported that the Phillipsburg Housing Authority had been contacted by HUD to try to improve internet connections though its "Connect Home" program. A virtual symposium was scheduled for October 13, gathering school administrators, hospital administrators, elected officials and ISP providers. She said a lot of money was out there from the federal government. She hoped to see some changes and affordable options for those in Phillipsburg area, as well as other areas. Mr. Kern noted Kevin Duffy had lost service during his online participation in the meeting earlier.

Mr. Sarnoski congratulated NORWESCAP on its 40<sup>th</sup> anniversary. It postponed its celebration to next spring, but he was appreciative of all the hard work it does. "It's a good organization that helps us a lot in Warren County," he said.

Mr. Kern reported having attended Rutherfurd Hall's "first flush" commemoration for completing a bathroom renovation. "Projects like that are a great thing to see — where money is being used smartly by government," he said, emphasizing how Rutherfurd Hall has grown to become a well-attended community center. He thanked Commissioner Sarnoski for getting the building "on the radar" with the county years ago. "I thinks that's a real gem, and the model of what can be done, and smart programming," Mr. Kern said.

#### CLOSING PUBLIC COMMENTS

Scott Reyes of Country Meadow Road in Mansfield Township expressed concern on behalf of a growing community of residents opposed to a proposal before the Mansfield Township Land Use Board to construct a food-composting dump behind Grandview Estates on Blau Road. He said there was an online petition with more than

700 signatures going around, and he sought an opportunity to discuss the matter with the Board of County Commissioners. Mr. Reyes said the NJ DEP advised the group that the township did not have direct impact on approval, and referred them to the county level.

Mr. Kern said the county had not been officially notified of the application, but had heard about it. From a process perspective, he said the township would be the first level of approval (Land Use Board); then if it were to be approved there, it would go to the County Solid Waste Advisory Council (SWAC); then if it passed there, then it would come before the Board of County Commissioners. He thought SWAC was the most appropriate county-level audience for these concerns, and that council's next meeting would be October 7. He recommended the group make its feelings known at the local planning board. Mr. Dech added that SWAC would look to the township for support or opposition to the application. "Because it is a solid waste recycling facility, it does not absolutely require township approval, but the SWAC, when it bases its recommendation to you as commissioners, will be looking for what the township position is on that application," Mr. Dech said.

Mr. Sarnoski noted that with "home rule" the county is guided by what the municipality wants to do. He said this board has been pushing very hard for local governing bodies to examine their land use and planning goals to make sure they are consistently laid out. "To a degree, we have some impact, but not as much as home rule towns have, and really, that's where that pressure is going to have to put – on the town – with regards to what you want to see there," he said, in an effort to limit expectations moving forward.

Mr. Reyes said he suspected the township's decision would be guided by potential revenue, but he appreciated the commissioners' time and guidance.

There were no comments or questions from the press.

# RESOLUTON TO REQUEST THAT THE NEW JERSEY DEPARTMENT OF TRANSPORTATION INITIATE A PROBLEM STATEMENT TO STUDY THE SAFETY, MOBILITY, AND CONGESTION ISSUES ON I-80 FROM EXIT 4/COLUMBIA TO THE DELAWARE WATER GAP BRIDGE

**WHEREAS,** it is well documented that the S-Curve Section of I-80 from mile marker 2.0 to the Delaware Water Gap Bridge, located in Warren County is known to have a high crash rate; and

**WHEREAS**, the I-80 Rockfall Project Purpose and Need Statement noted: *NJDOT Bureau of Safety Programs crash data for January 2007 to December 2009 also shows that there are 81 crashes within the project limits for that period. This section of I-80 has a crash rate of 4.52 crashes/mvm, which is 58% greater than the statewide crash rate for the year 2009 of 2.86 crashes/mvm*; and

**WHEREAS**, the 2011 NJDOT I80 S-Curve Rockfall Concept Development Report noted on page 5: "The Route I-80 roadway carries several safety deficiencies that also contribute to high crash rates. These safety deficiencies include substandard sight distances, narrow shoulder width, and substandard horizontal radii."; and

WHEREAS, a 2013 Knowlton Township Fire and Rescue (KTFR) and NJ Legislative District 24 (Senator Oroho) correspondence with NJDOT discussed the request for warning signs to be installed for the S-Curve, noting: "emergency personnel have had a few harrowing near-miss situations while operating in this corridor. One situation involved a motor vehicle overturning while we were operating on another motor vehicle accident in this corridor. In another recent incident, two tractor trailers one in each of the two lanes side by side, skidded up to the emergency scene, where KTFR personnel were in the process of setting up a safety buffer nearly jack-knifing and colliding into the on-scene personnel"; and

WHEREAS, a 2018 NJDOT NJSP Accident Report Crash Study Report (2001-2016) which analyzed only a half-mile portion of the 1.5-mile S-Curve noted: 633 motor vehicle accidents, involving three (3) fatalities and 226 injuries; and

WHEREAS, in July 2020, Knowlton Township formally submitted a Fix The S-Curve NJDOT Transportation Problem Statement request supported with resolutions from Warren County, Hardwick, Portland, Delaware Water Gap, Upper Mount Bethel, Lower Mount Bethel and others seeking a study to identify solutions to all safety, mobility and congestion issues in this section and to conduct a regional traffic study; and

**WHEREAS,** a study compiled by the I80 DWG Coalition using NJDOT, PennDOT and NPS data showing the known safety, mobility and congestion issues in the S-Curve was submitted to NJDOT by Knowlton Township with a Problem Statement request; and

WHEREAS, in March 2021, Knowlton Township inquired on the status of the Problem Statement Request and was informed by NJDOT policy had changed and NJDOT was no longer accepting external stakeholder requests, despite the website and posted policy at that time included specific guidelines on how external stakeholders are to submit Transportation Problem Statement Requests that were followed; and

**WHEREAS**, the Warren County Transportation Plan sponsored by the NJTPA Final Presentation noted I80 S-curve as the area that received, the most comments (145) and listed 1-80 "Safety Improvements on I-80 at the S-Curves" under Policy and Multimodal Recommendations; and

**WHEREAS**, just recently the I80 DWG Coalition compiled a list of multi mile traffic events and crashes in the I-80 Delaware Water Gap Area between June 26, 2021, and August 27, 2021 (63 days) from 7:00 am to 8:00 pm with the following results:

- 31 days had no crashes or 3+ mile traffic back ups
- 32 days had crashes or traffic back ups
- 30 crashes
- 46 individual 3+ mile traffic events
- 23 crashes occurred secondary to an existing traffic back up caused either from Gap/S-Curve volume or a previous crash or in a work zone
- 16 3+ mile traffic jams occurred secondary to a crash
- 6 crashes did not happen in an existing traffic back up or in a work zone
- 5 events closed or jammed both 80W AND 611W at the same time leading to potentially life-threatening EMS delays to the nearest Emergency Room
- 9 days had two or more separate events on the same day

WHEREAS, current volumes on I-80 average approximately 47,300 – 70-500 vehicles per day with 12% heavy trucks while traffic projections show volumes that range between 89,200-132,800 vehicles per day, thereby exacerbating the already compromised safety and congested conditions; and

**WHEREAS,** the NJDOT is responsible to address safety problems on their highway system when they have been identified.

**NOW THEREFORE BE IT RESOLVED,** that the Warren County Board of County Commissioners request that New Jersey Department of Transportation immediately initiate a Problem Statement to study all the safety, mobility, and congestion issues on I-80 from Exit 4/Columbia to the Delaware Water Gap Bridge.

WHEREAS, Amtrak has released its report titled "Amtrak's Vision for Improving Transportation Across America" (Report); and

WHEREAS, the Report identified two formerly active passenger railroad corridors that traverse Warren County, namely the former Delaware, Lackawanna, and Western (DL&W) referenced in the Report as the "Scranton Service" and the Central New Jersey/Raritan Valley/Lehigh Valley Lines, referenced in the Report as the "Allentown Service"; and

WHEREAS, for the "Scranton Service" the Report envisions three round trips per day between NYC and Scranton, Pa, with a stop in Blairstown, NJ Warren County, subject to further analysis; and

**WHEREAS**, the Pennsylvania Northeast Regional Railroad Authority has contracted with Amtrak to conduct an updated ridership study for the entire corridor which should be completed in less than a year; and

**WHEREAS,** for the "Allentown Service" the Report envisions two round trips per day between New York City and Allentown, Pa with the nearest stops proposed in Easton, Pa and Somerville, NJ, subject to further analysis; and

WHEREAS, the restoration of passenger service has been studied numerous times in the past and is among thirty-nine new routes and twenty-five other routes proposed to be enhanced across the U.S. in the Report; and

WHEREAS, the Warren County Transportation Plan has identified both lines for continued evaluation to re-instate passenger service to provide another mode of travel for those residing in Warren County and for those traveling through, and to help reduce congestion on I-78 and I-80; and

WHEREAS, restoration of passenger service will help in meeting global climate reduction goals; and

WHEREAS, it is projected that the net benefit from all operations nationally will reach \$8 billion annually by 2035, generate an additional \$195 billion in economic activity by capital investments, and create over 26,000 permanent jobs; and

WHEREAS, the Report envisions a 15 year horizon for implementation with a \$75 billion investment; and

WHEREAS, the Report proposes that federal funding would cover 100% of the initial capital investments and operational costs, with tapered reductions in Federal funding for operating support during the first five years of service with States continuing service under an Amtrak-State cost sharing structure; and

WHEREAS, implementation will require a team effort with Amtrak, the federal, state, and local governments, and host railroads; and

WHEREAS, implementation is contingent on Congress putting the necessary funding and policy elements in place, and on an agreement between Amtrak and the State in advance.
