Investigations like these are very time-consuming and require quite a bit of research into contracts and documents. It is actively being reviewed and additional information is being gathered. These are serious allegations that have been made, and I want to be able to obtain as much information as I can on the matter.' "Ms. Mezzanotte said while these remarks were very general, she felt they conveyed that the information was being taken seriously.

The documentation Ms. Mezzanotte submitted specifically referenced the change in scope. She said there was one project approved through the concept development phase for the rock fall mitigation plan that recommended an approved alternative, and a box checked off saying it was the Community Information Action Plan for the preliminary engineering phase, and a few other specifics. "And then, something happened, and a contract was written for that preliminary engineering phase, and that contract does not reference, at all, the alternative that was recommended after the three-year, 312-page document that was produced after it," she said. "That mild, nine-month, five million dollar plan" was the alternative not referenced, according to Ms. Mezzanotte. Instead, it speaks about the project we have today, "Which was going to be 37 to 200 million and it was going to be four years at a minimum," she said.

Ms. Mezzanotte continued, saying the written contract also did not speak to the Community Involvement Action Plan, which was very specific in that Knowlton Township and Warren County engineers were to be involved early in the preliminary engineering phase. She said Knowlton Township was omitted completely, and Warren County was going to be involved towards the end.

"We're using two examples to be specific, because it relates to Warren County and it relates to the alternatives that you're representing us on, so I wanted to have that in the minutes," Ms. Mezzanotte concluded.

There were no further public comments, nor questions from the press.
