The three County Commissioners then came forward for a ceremonial Ribbon Cutting to celebrate the completion of renovations to Court Room #1. They invited Judge Miller to join them as they cut the ribbon.

REMARKS BY ELECTED AND APPOINTED OFFICIALS AND OTHER DIGNITARIES.

Mr. Sarnoski said it was an honor and a privilege to have Judge Miller here, as the courtroom refurbishment would not have been possible without his support and that of the judiciary. He thanked the Belvidere Singers and Adam Conti for performing here today,

Mr. Sarnoski began his remarks by saying after the past couple of years, which had been challenging, today was a day of gratitude for him. He thanked Mr. Kern and Ms. Ciesla for their support, and for their confidence in him in as Director. He praised Mr. Kern for his leadership, which he considered heroic in the age of COVID. Speaking of COVID, Mr. Sarnoski was grateful for the County's Health Department and Department of Public Safety - particularly Dennis Riley, Pete Summers and Courtney Sartain – for doing an "amazing" job navigating the challenges of the pandemic.

Continuing with a list of individuals to thank, Mr. Sarnoski noted that Ms. Ciesla, as the newest commissioner, really hit the ground running by reaching out as liaison to municipalities and various departments, particularly Human Services, and for coordinating a Health & Wellness Field Day, which was important in these times.

Mr. Sarnoski was appreciative of the efforts of County Clerk Holly Mackey and Elections Administrator Bill Duffy for aptly navigating through a challenging election environment. Warren County had gotten out ahead of the curve by purchasing new voting machines, ensuring election security in our county.

Mr. Sarnoski was grateful to all the mayors for working closely with county officials, as well as state-level legislators for their advocacy. He thanked Senator Doherty for swearing him in each time, and congratulated Senator Oroho and Assemblyman John DiMaio for earning leadership positions in Trenton.

Above all, Mr. Sarnoski thanked his family for their support.

Mr. Sarnoski continued, saying Warren County had a great administration team led by County Administrator Alex Lazorisak. Regarding the renovation of Court Room #1, the vision had finally become a reality. Mr. Sarnoski was grateful to Mr. Lazorisak; former Freeholders over the past decade, including Rick Gardner, Ed Smith, John DiMaio and Everett Chamberlain; new Public Works Director Emily Hammer; Prosecutor Jim Pfeiffer and his staff; and the entire judicial team. He noted that the

faded draperies had yet to be replaced due to backorder/supply chain issues. "In government, nothing happens as quickly as we would like, and this courtroom is the perfect example, but good things certainly come to those who wait," he said.

The \$1.2 million renovation was not only cosmetic. This was now purportedly the only courtroom in the state that was fully set up for remote trials, video conferencing, et cetera. "So this very old courtroom is now one of the most modern in the state, and I think that's something we all should be very proud of," he said.

Entering his 12th year as a county leader, Mr. Sarnoski said there was still much more he wanted to achieve. Work continued in terms of reorganizing county facilities and departments, as well as efforts to attract high quality talent to the county workforce. "We're going to have to give them the space and resources they need to do their jobs," he said. He pledged to continue to work with municipal leaders to help them realize their visions for their towns, saying Warren County had a number of great mayors and council/committee members who truly care about their communities. One major issue affecting the area was transportation and traffic. Mr. Sarnoski said he would continue to press the NJDOT to move forward on projects Warren County needs, such improving the intersection of Routes 519/57 and other intersections; and abandon projects that the county does not want, such as the Route I-80 rock fall project.

Warren County was in a great financial position and virtually debt-free. Mr. Sarnoski said the county would remain strong this this area and continue to produce reasonable budgets that support our communities.

In closing, Mr. Sarnoski reiterated that for him, the past couple of years had been all about gratitude and giving back. He was grateful to all for their hard work. "I know this has not been easy," he said, "Thank you, God bless you, and God bless Warren County."

Mr. Sarnoski then invited Deputy Director Lori Ciesla to the podium to speak. Ms. Ciesla began by extending Happy New Year wishes, and said it was nice see people in the audience, unlike a year ago. "Twenty twenty-one was quite the year," she said noting that this time last year, we were going through the ravages of COVID, and now we are again. "It doesn't seem like it's ending anytime soon," she said.

After congratulating Mr. Kern on his reelection, Ms. Ciesla elaborated on the county's handling of the pandemic, highlighting its vaccination clinics conducted earlier in the year and getting people vaccinated - some getting COVID despite being vaccinated - and the challenges of staffers working remotely and coordinating split

shifts. "First and foremost, as my first year here, I am unbelievably impressed with the employees that work for this county," she said, having found that they didn't let anything get in the way of doing their jobs, which was to serve the people of the County of Warren. She was pleased with new employees as well, mentioning new Public Works Director Emily Hammer, who helped ensure the completion of this courtroom renovation.

Ms. Ciesla said the county had a great judicial branch; our Prosecutor's Office was taking care of crime in the county; our Health Department has been working nonstop since 2020; and our Human Services Department was trying to meet the needs of those who have the most need, which intensified because of COVID. "They have really stepped up to the challenge," she said, noting in some instances new people stepped into roles vacated by others and were getting the job done. As Director Sarnoski had mentioned, with everyone working together, we managed to hold a Health & Wellness Field Day. The goal was to reach out those who need it most, and show what services are available. The planning committee obtained a grant exceeding \$15,000 to put toward next year's event, about which Ms. Ciesla was very excited.

Over the past year, Ms. Ciesla said she learned that the Warren County Planning Board was very meticulous, precisely what we need as we face current challenges (the inundation of warehouses, the state allowing solar to go just about everywhere). She said the county's Agriculture Board and Land Preservation Department worked very hard to preserve as many farms as possible, with the county stepping in to fill gaps in funding. "Because we can't wait," she said, "If we wait, they'll be purchased either by a warehouse, or they'll end up being solar."

Looking ahead, Ms. Ciesla said traffic on our county roads was an issue. We want to keep them safe by continuing to work with municipalities and focus on the projects we need - not the ones we don't need. Going forward, Ms. Ciesla she said she would continue to pursue obtaining broadband internet availability throughout the county, as we have both accessibility and affordability issues. Money has become available for this effort, so in the coming year the county would look into how to best devote those resources.

Ms. Ciesla wrapped up by saying she learned a lot over the past year. She was appreciative of everyone's hard work throughout the county, thanking mayors and committee/council members; legislators; everyone here today; then singled out County Clerk Holly Mackey; County Sheriff James McDonald; the Election Board; Chairman Doug Steinhardt; and particularly County Administrator Alex Lazorisak for his hard work and devotion. "I want to thank everybody here in the county, as we try to keep

this county the best in New Jersey," she said, wishing all a happy, healthy New Year, hoping this one would be a little more normal by the end.

Mr. Kern was next to the podium, and began by thanking everyone in the room, especially his family; his campaign team, including Nancy Brown, Chairman Doug Steinhardt, Dale Parichuk, Christine Rusin and Randy Piazza, Jr.; as well as his colleagues on Board of County Commissioners. He appreciated Ms. Ciesla's support and help in creating efficiencies, particularly in the technology realm. Mr. Kern noted that the two had discussed their visions back when they both served on the municipal level, "and here we are," he said. Mr. Kern expressed gratitude to Mr. Sarnoski for his guidance and mentorship. "Thank you... you're a fearless leader for this county and I know we're in great hands going into 2022."

Recalling his speech of upon taking the oath of office in 2019, Mr. Kern said he had a lot of "grandiose ideas" of what he wanted to accomplish, "and then COVID-19 happened." As liaison to the departments of Public Safety and Public Health at the time, he said, "I was really knee-deep into what was going on with COVID." Mr. Kern reinforced prior comments about the capability of Warren County's workforce as it continues to confront the pandemic, saying it was nothing short of "amazing". He went on to cite some numbers: the county conducted 118 vaccine clinics, administering nearly 20,000 shots. This was made possible with the help of about 300 people, including volunteers, our Public Health nurses, private sector nurses, physicians and pharmacists. "I will tell you that Warren County will continue to adapt and fight this virus, but we must do so based on science – not political science. The vaccines work, and we can't continue to live our lives as if they don't," he said, pledging to continue to advocate for that.

Moving past COVID, Mr. Kern was proud of this governing board's fiscal responsibility. Not including our own legislators, he said while spending in Trenton and Washington, D.C. remained high, the current Board of County Commissioners continues the legacy of past boards – keeping taxes and operational expenses flat. He said they would continue to scrutinize every expense and provide a responsible budget to the taxpayers.

In keeping with his pledge of open and transparent government, Mr. Kern noted the county's technological advances, including the launch of a new website, that meetings were being recorded and streamed online, as well as an increased social media presence. "With shrinking local media coverage, it's imperative that local governments provide their residents with access to information," he said, and that he looked forward to continuing to grow in this area.

As Commissioner Ciesla had mentioned earlier, Mr. Kern said this board was committed to preservation. Warren County had preserved 312 farms since 1989, comprised of almost 28,000 acres. The taxpayers were also committed to this endeavor. Of the total \$144 million cost, \$90 million was borne by the state, \$38 million came from Warren County, and about \$10 million from municipalities. "We put our money where our mouth is, and will continue to support these programs," he said.

Looking to the future, Mr. Kern was excited about the county's new environmental committee, which had already received a large number of applications from individuals willing to serve on it. This committee will advise the Commissioners and the public regarding how to protect and preserve Warren County's natural beauty and resources and increase environmental awareness, ensuring a healthy environment and improved quality of life.

Mr. Kern recognized several partners, including Prosecutor Jim Pfeiffer, with whom County administration enjoyed a great relationship. The Commissioners were supportive of a cybercrimes unit within that office to combat online sex crimes. Due to smart budgeting, the unit would have a negligible impact on the taxpayers while confronting a serious problem in our county. Mr. Kern looked forward to continuing to work with Warren Community College President Will Austin as he fostered a new relationship with our law enforcement community, and, with the support of former Commissioner Boards, helped the college emerge as a leader in robotics. These new tools, including drones, will aid in fighting crime and help keep our officers safe.

Along with local council and committee members, Mr. Kern expressed appreciation to the mayors, who participated in phone calls as part of the county's COVID-19 task force, formed 676 days prior. (County Administrator Alex Lazorisak was able to recite the number of days into the pandemic without hesitation when asked.) Mr. Kern said the mayors acted as "foot soldiers" in this fight. While we may not always agree, he said, mayors who strongly advocate for their communities are the ones we would want as our own mayors. Mr. Kern thanked county employees, from Health and Public Safety to Administration. He asked all county employees in attendance to stand and be recognized.

In addition to the presentation of this newly refurbished courtroom, Mr. Kern looked forward to the county's bicentennial, an event on the horizon. He was excited to celebrate what has made this county great for 200 years, and why it was the greatest place to live in the State of New Jersey. Mr. Kern closed by thanking everyone and wishing all a Happy New Year.

Mr. Sarnoski then welcomed Honorable Judge Thomas Miller to say a few words, introducing him as a great partner in helping to ensure this courtroom was properly completed. Judge Miller said it was an honor to be invited here, and to speak. He said the county has been a great partner, and recognized all three Commissioners by name. He said one of his goals when he became the Assignment Judge (the head judge in three counties) 18 months ago was to improve relations with the satellite counties (Warren and Hunterdon). Somerset, a larger county with more cases, received more attention, so Judge Miller strove to make things equal, and felt relations had come a long way toward that goal. He drew particular attention to County Administrator Alex Lazorisak, one of the key people helping to improve the relationship. Having served as attorney and judge for many years, Judge Miller said he had dealt with many administrators, and Warren County had superlative one. "He is dedicated, energetic, smart, honest, trustworthy," Judge Miller said, "Thank you, Alex."

He went on to explain that he relationship between county governments and the courts in New Jersey was strange, unique and sometimes awkward, with the county charged with owning and maintaining the facility that the court – an autonomous body - occupies. The arrangement is not ideal, and can cause angst and resentment. "We've gotten past that," Judge Miller said, and the relationship has turned into a strong one that understands the importance of the shared aim of serving the taxpayers and citizens. That symbiotic relationship must be fostered, he said.

Judge Miller noted that in any community, the most distinctive and prominent buildings are the courthouses and the churches. Both serve vital needs and are deserving of a sense of beauty, grandeur and awe. "And that's exactly what you've done here," he said. "This facility is beautiful, it has grandeur, and it has awe... and it is also a link to your historic past." He noted the courthouse has been here since 1826. As a lawyer, Judge Miller said he had been to every courthouse in the state. He said this one was unique and among the most beautiful. "Certainly the most beautiful setting, with that beautiful square outside," he said.

Judge Miller thanked all involved, saying this renovated courtroom was a recognition of the importance of the justice system in our society. "We are pleased today to be able to recognize the county commitment to our justice system and the vital role that it serves for our mutual constituents," he said.

Former Warren County Freeholder Richard Gardner was invited to speak next. He said he was delighted that the Commissioners invited him to this occasion in this great room. He recalled that plans for this goal had begun a long time ago, so it was exciting to see the "number one room in the number one building" in the county

restored to its beautiful yesteryear splendor. The technological capabilities made it even more exciting. He congratulated all involved for this bringing this to fruition. He also extended congratulations to Mr. Kern on his reelection, and Mr. Sarnoski for being voted in as director.

Warren County Prosecutor James Pfeiffer said while the past year had presented challenges, there had also been successes. He appreciated the confidence the Commissioners had in him. "We have a tremendous relationship," he said, "We have a plan together... to keep this county safe." Mr. Pfeiffer was grateful to his own staff, of which he was proud, and to the County Administrator and the Commissioners for contributing to the office's success. This courtroom, with its technological capabilities, was an important part of moving forward, as the pandemic caused a backlog in processing cases. He thanked the aforementioned, as well as Superior Court Operations Manager for Warren County, George Georgeles. "I really appreciate the opportunity to be the Prosecutor for Warren County," Prosecutor Pfeiffer said.

County Clerk Holly Mackey wished all a Happy New Year, and hoped to get through 2022 with no new election laws. She brought attention to Warren County Elections Administrator Bill Duffy, who had to navigate through early voting in 2021. She said the prior year, the vote by mail requirements were on her shoulders, but the implementation of early voting was squarely on the Division of Elections. "He was a person down, and he served this county really, really well," she said, "We work very well together." Ms. Mackey offered congratulations all around, and said she looked forward to serving for another year.

Mr. Sarnoski would have liked to have called on Surrogate Kevin O'Neill at this point, but he was unable to attend. His deputy, Tom Thorp, was taking good care of things in the office, and Mr. O'Neill was in contact and had sent his regards.

Former Warren County Sheriff Sal Simonetti said it was his honor to return here each year for the County's annual reorganization. Having spent 19 years doing business in this courthouse, he hoped to see the front entrance restored one day. He knew it was a complex undertaking, but perhaps this current administration could rise to the challenge. Mr. Simonetti wished all a happy and healthy New Year. Mr. Sarnoski quipped, "Judge Miller, you can't retire yet – we've got to get the front door open!"

Senator Michael Doherty (23rd District) said it was wonderful to be here and see a nice crowd. He said Warren County could be proud of its leadership team, noting that each of them was humble, and expressed commitment to family and the taxpayers. They continued to improve facilities without incurring any debt, instead planning and

saving first. Sen. Doherty was pleased that northwest New Jersey would be well represented in Trenton in the coming year, with Assemblyman John DiMaio (23rd District) and Senator Steve Oroho (24th District) both moving into leadership roles to advocate more for this area. Sen. Doherty reminisced about being sworn in as Director of the Warren County Board of Chosen Freeholders precisely 20 years ago, and recognized Walter Orcutt in the audience as one of his earliest mentors. He closed by offering congratulations wishing all a healthy, prosperous 2022.

Mr. Sarnoski introduced Senator Tom Kean (21st District), saying he had been advocating for us in Trenton, and hoped he would be in a position to advocate for us in Washington, D.C. in the near future. Sen. Kean congratulated the Commissioners, said it was an honor to be back, and wished all a Happy New Year.

Assemblyman Erik Peterson (23rd District) said last year was challenging, and hoped for a better 2022 for our state and country. He talked about freedom reigning in Warren County, and that he was pleased to have been warmly welcomed into this public building. He congratulated Mr. Kern on his reelection and Ms. Ciesla and Mr. Sarnoski for their respective leadership positions, wishing them the best of luck.

Mr. Sarnoski invited Warren County Republican Committee Chairman Doug Steinhardt to say a few words, introducing him as a friend and mentor. Mr. Steinhardt said Warren County was in the greatest hands in the state with its Administrator and Board of County Commissioners. He said he had the honor of serving as chair for 17 years, and he was grateful to Nancy Brown for being his vice-chair for over a decade during his tenure. New Jersey was unique in that it is never more than a year away from the next election, and he felt there was much at stake in 2022 for which to prepare. Mr. Steinhardt thanked everyone for coming out for this occasion, and wished them well.

Before adjourning the meeting, Mr. Sarnoski took a few moments to recognize the following dignitaries in attendance not previously mentioned: Will Austin, president of Warren Community College and his wife, Lori, chair of the Warren County Technical School Board; Yvonne Reitemeyer, new chair of the WCC Board of Trustees; from Belvidere, Mayor Joe Kennedy; from Blairstown, Mayor Rob Moorhead, Deputy Mayor Walter Orcutt and Committeeman Charlie Makatura; from Hope, Mayor Tim McDonough; from Lopatcong, Councilman Bill Wright; from Liberty, Mayor John Inscho; from Washington Borough, Councilwoman Louann Cox; and from Hardwick, incoming mayor Chris Jacksic. He apologized if he missed anyone; many attendees were wearing facemasks.
