Meeting Minutes December 20, 2012

The regular monthly meeting was held at the office of the Department of Land Preservation, 500 Mt. Pisgah Avenue, Oxford, New Jersey. The meeting was called to order by Chairman Schnetzer at 7:32 p.m. An announcement was read as required by the Open Public Meetings Act, N.J.S.A. 10:4-6-21.

Old Business

Smith/Rasa Farm – Ms. Campbell stated that she has contacted Brian Smith several times regarding him reviewing the title binder and the endorsed survey that was done in accordance to his specifications. Mr. Smith told Ms. Campbell that he is very busy with the Farm Stand and Solar Energy laws.

Wattles Auction – Mr. Tierney stated that the Freeholders' authorized Norton Conservation Company to remove the contaminated soil from the two sites and that it will be completed by the end of January before the public auction on February 2nd.

New Business:

Grotenhuis Farm – BL 37 Lot 14, Harmony Twp. - Mr. Tierney was contacted by the NRCS regarding a report that there was excavation activity on the preserved farm. There is a NRCS conservation plan, but there are no design specifications for the pond. Mr. Tierney asked Dan Mull for the

conservation plan, but the NRCS is not allowed to give us the plan. It has to come from the landowner. Mr. Grotenhuis stated that the fertile soil remains on the farm and is spread on the field, but that the clay is removed offsite. Mr. Grotenhuis said that he completed a well and wanted to use the pond for irrigation. Mr. Resker contacted him regarding a complaint of removing the soil in 2006. Mr. Grotenhuis explained to Mr. Resker that he was removing the sub-soil clay because it can't be put on topsoil. Mr. Resker advised Mr. Grotenhuis to stop digging and was going to discuss this issue with the CADB at the next meeting, but there wasn't a quorum. According to Mr. Grotenhuis, Mr. Resker came back to the property and told Mr. Grotenhuis that everything was fine. The pond is graded and is being filled now. Mr. Grotenhuis worked with Dave Schaaff, NRCS Soil Conservationist. According to Mr. Grotenhuis, the pond can hold 2,558 million gallons of water, 1.8 million gallons of water per 50 acres is needed with three days reserve, and the surface area is approximately 222 ft. in length x 170 ft. in width and 15 feet in depth. Mr. Grotenhuis had guidance from David Schaff four years ago and that design was in the farmland plan. Mr. Grotenhuis started digging a few years ago and is now starting to fill and finish the pond. Mr. Grotenhuis said that the pond is located in an area of the field that is swampy, but not in wetlands. The Board advised Mr. Grotenhuis to stop removing anymore soil from the property and go to the NRCS and get a plan for the pond as to what the usage is going to be and to provide that copy of the plan to the Board.

DiRisio Farm — Resolution # 12-18 BL 501 L 14 & BL 602 L 6, 67 acres, Mansfield Twp.

Mr. Race made a motion to approve the funding resolution of \$7,000/acre for purchase price of the development easement on the farm. Mr. Gourniak seconded the motion.

County/TLC-NJ Non-Profit Farmland Preservation Agreement

Mr. Tierney stated that TLC-NJ is seeking 50% cost-share for three non-profit farmland application, K-J Farm, Star D Farm in Harmony Twp., Sunny Hill Farm in Harmony & Lopatcong Twps. and the May Farm in Hope Township. The total estimated cost-share by the County would be \$577,320 for the three farms. This amount is based upon the estimated appraisal value of the farms. TLC-NJ would like the County to provide 100% of the appraisals, 50% of the total bills for the surveys and title. TLC-NJ will seek 50% reimbursement for due diligence costs from the SADC and that amount will be remitted back to the County. TLC-NJ will provide the County with all copies of the documents that are required by the SADC. The County will provide funding to TLC-NJ for closing. They will take title of the non-profit farms, but will immediately assign the deed of easements to the County. Ms. Campbell is to review the agreement and make any necessary revisions.

Mr. Race made a motion to recommend this agreement to the Freeholders that is subject to any revisions deemed by counsel. Mr. Baduini seconded the motion.

Randall Paul Farm (Hillyerd) – BL 46 L 3, Knowlton Twp.

Mr. Tierney stated that he received a report from the Township that dumping of unknown debris was occurring on this preserved farm. Mr. Tierney inspected the property with the County Health Department's Kevin Covatta. The debris is made mostly of leaves, and there are some sticks and paper bags. The Health Dept. is monitoring the farm and will issue a violation if the pile is not being distributed on the fields. If the pile of debris is not spread soon, in accordance with DEP regulations, it will become waste material which is prohibited under the deed of easement. Knowlton Twp. advised Mr. Tierney that the pile was still present today, Thursday, December 20th. Mr. Tierney will be in contact with the Health Department regarding this issue.

Mr. Tierney advised the Board that Assemblyman John DiMaio offered to have a meeting with the CADB and the SADC in response to the letter regarding the CADB's response to the Solar Energy Laws. The Board decided that it would be best to advertise a special meeting held at the Dept. of Land Preservation. Mr. Tierney will get back to Assemblyman DiMaio's office with the Board's response.
