Meeting Minutes November 15, 2012

The regular monthly meeting was held at the office of the Department of Land Preservation, 500 Mt. Pisgah Avenue, Oxford, New Jersey. The meeting was called to order by Chairman Schnetzer at 7:33 p.m. An announcement was read as required by the Open Public Meetings Act, N.J.S.A. 10:4-6-21.

Chairman Schnetzer led the Pledge of Allegiance.

Old Business

Raub Case

Mr. Baduini made a motion to enter into Executive Session and was seconded by Mr. Gibbs. Motion carries. The Board entered into Executive Session at 7:34 pm.

Mr. Baduini made a motion to come out of Executive Session and was seconded by Mr. Gibbs. Motion carries. The Board came out of Executive Session at 7:49 pm.

Santini driveway – This issue was discussed among the Board.

Smith/Rasa Farm – Mr. Lavery stated that the title binder and the endorsed survey were sent last month to the SADC. Brian Smith told Mr. Lavery that he will review the documents after he is done working on the proposed Solar Energy laws.

Wattles Auction — Mr. Tierney stated that the township public hearing is scheduled for tomorrow, November 16th at 1 pm. Mr. Tierney stated that there was contamination discovered at the Ranch House where an underground oil tank with holes was removed, as well as in the basement of another home along Anderson Road where another oil tank leaked. Mr. Tierney visited the site during the removal of these tanks. A total of 8 containers were removed from the property, three interior above ground oil

tanks, two underground oil tanks, and three other containers with gasoline and/or diesel, as well as removing miscellaneous waste from several other small containers. The auction date has been set for February 2, 2013.

New Business:

DiRisio Farm - BL 501 L 14 & BL 602 L 6, 67 acres, Mansfield Twp.

The DiRisio's have petitioned the Board for \$500 more per acre. The CMV is \$6,500. One appraisal is \$8,000 and the other is \$6,155, almost a \$1900 difference. The farm has been in the family since 1938 and was a dairy farm, but now has beef cattle and produces round hay bales for sale. The DiRisio's would like the Board to meet them in the middle at \$7,000. Mr. Baduini proposed \$250 per acre instead of the \$500 more per acre at a cost of \$6750/acre. The total cost to the County would be \$33,500 at \$500/acre.

Mr. Race made a motion to approve the applicant's request at \$7,000 per acre or \$500 more per acre raising the cost-share of the County to \$33,500 for the approximately 67 acre farm. Mr. Gourniak seconded the motion.

This application was presented to the Board for approval. This farm is 100% tillable with 100% prime soil with hay production. There are no existing buildings or residences on the property. The applicant will not be taking any exception areas. Elmer Terhune currently farms the property.

Mr. Baduini made a motion to approve this application and forward it to the SADC for Green Light Approval. Mr. Gibbs seconded the motion.

Pryslak 8-Year Farm Terminations

Pryslak "A" Farm - Block 602, Lots 11.01, 12 & Block 602.01 Lots 11 & 14, Allamuchy Township, Block 28 Lots 28 & 30 & Block 29 Lots 20, 22, 23, 24, 25, Independence Township, Block 1 Lots 10, 11 & 23 Liberty Township, 290.68 Acres

Pryslak "B" Farm - Block 1 Lots 9, 24, 25, 27, Township of Liberty & Block 28 Lots 21 & Block 29 Lots 7, 15, 16, 17 & 21, Township of Independence, 153.72 Acres

Block 29, Lots 7, 15, 16, 17, 20 & 21 are no longer in the tax database system. Independence Township said that these lots were absorbed into other lots but were not aware of which lots.

The legal metes and bounds on both Pryslak "A" & Pryslak "B" has changed since the creation of the initial farmland preservation program agreement and has to be terminated referring to N.J.A.C. 2:76-3.9 ii.

Mr. Race made a motion to approve the terminations for both Pryslak "A" & Pryslak "B" from the 8-year program. Mr. Gourniak seconded the motion.

Mr. Tierney stated that the County ADA is being amended to include Block 2 Lot 5 in Lopatcong Township in the West Project Area. This block and lot is part of a non-profit application where the farm straddles two townships, Harmony and Lopatcong. The total acreage for the Sunny Hill Farm is 30.647 acres. Mr. Tierney stated that publications for the hearing were published in the Star Ledger on 11/14 and in The Daily Record on 11/13. Mr. Tierney had forwarded a resolution to Lopatcong Township for the approval of including this block and lot in the County ADA. Lopatcong Township would not be participating in the cost-share, but would be supporting the preservation. Mr. Tierney has not received a response from the Township.
