# Meeting Minutes March 17, 2011

The regular monthly meeting was held at the office of the Department of Land Preservation, 500 Mt. Pisgah Avenue, Oxford, New Jersey. The meeting was called to order by Chairman Schnetzer at 7:34 p.m. An announcement was read as required by the Open Public Meetings Act, N.J.S.A. 10:4-6-21.

Chairman Schnetzer led the Pledge of Allegiance.

**Minutes** of the regular session meeting held on February 17, 2011 were approved on a motion by Mr. Race and seconded by Mr. Baduini. Mr. Gibbs abstained. Motion carried.

#### **Public Input (Non-agenda Items):**

Cynthia Curtis, Perfect Christmas Tree Farm, Lopatcong Township wanted to know if the Earth Day Event that they have in April falls under sub. 4.1 C 9H education/event. Mr. Lavery stepped out of the meeting room because he has a conflict with Lopatcong Township. Mrs. Curtis wanted to know if she needs to come to this Board and ask permission each year to have the Earth Day Event. The Board said it was under agritourism and she doesn't have to get permission from the Board to have the event as long as they were complying with the town. Mrs. Curtis sent a letter to Mayor Steinhardt thanking him and got a response letter from Attorney Sposaro telling her to ask permission from the CADB for events.

Mrs. Curtis wants to do a tailgate farm market on her property. The Board told her to file a Site Specific Form for that and could not discuss or proceed without counsel.

**Smith/Rasa Farm** — SADC will provide a GIS description of area to be excluded, county must supply amended survey and an emended deed of easement will be needed to receive cost share.

## **New Business**

**Kenco** — **Division of Premises, Block 202, Lot 5, Allamuchy Township** - Mr. Palmer, attorney for Mr. Kenny addressed the Board concerning Mr. Kenny's desire to merge Block 202 Lot 5 (6.04 acres) to Block 202 Lot 7 (101 acres, owned by Mr. Van Vugt, also preserved farmland) for better access to turf and switch grass. This division of premises will change ownership of preserved land to Mr. Vugt and Mr. Kenny is giving up RDSO on Lot 5 to Mr. Van Vugt. The division request is for division along pre-existing lot lines. Mr. Baldwin made a motion to approve Mr. Kenny's request for Division of Premises with a second by Mr. Race.

Freeholder Rick Gardner commented about the SADC interpretation of the deed of easement rules and said he would request a meeting with the Secretary of Agriculture.

Mr. Baduini would like the Board to provide a letter of support requesting a grant from the US Department of Agriculture for the Hackettstown Auction Farm Market. Mr. Baduini made a motion to support this issue that was seconded by Mr. Gibbs.
