# Meeting Minutes September 16, 2010

#### Raub Report

On a motion by Mr. Baldwin and seconded by Mr. Race the Board went into Executive Session at 7:37 p.m. to discuss the Raub case.

#### **New Business**

#### **Martin Farm** – White Township

Mr. Resker was seeking approval from this board to get a wavier of minimum score for this farm. Although this farm falls short in ranking by less than two points below the minimum score, Mr. Resker feels this farm is worthy of being preserved because this farm has been in the family for 150 years and this farm is currently being farmed by the Martins.

On a motion by Mr. Baldwin and seconded by Mr. Gourniak, the Board approves the motion to seek approval to waive the minimum score based upon the dedication of the family to farming.

# **Administrator's Report:**

Mr. Resker briefly went over the important matters on the report.

Mr. Lavery stated that they were close to settling the Rasa issue. DEP has filed an amended ACO.

Wattles - almost close to getting cost share.

Singley – The Board agreed to pull out of the offer by December 1, 2010 if sellers continue to be non-compliant.

Mr. Resker reminded the committee of the 20,000 acres celebration at the Demeter #3 farm in White Township on September 27, 2010.

Millburn – still waiting for NJ Conservation Foundation to secure federal funding. The Board is still stalled on its decision about appraisals, will vote again at a later date.
