#### REPORTS AND COMMENTS

County Counsel Joe Bell only had matters involving litigation for Executive Session.

County Engineer Bill Gleba had nothing to report.

County Planner reported on the June 11<sup>th</sup> paper shredding event, two-hundred fifty-five deliveries from everywhere, but Hardwick Township. Just over nine thousand pounds had been collected. Last year we collected just over twelve thousand pounds at the September event. It is up there, but did not a break record.

County Public Works Director not in attendance, on vacation.

County CFO Kim Francisco had no report.

County Administrator Alex Lazorisak said the most recent vacancy report contained nothing out of the ordinary, backfilling of a few existing positions.

# **COMMISSIONER COMMENTS**

Mr. Kern reported, two weeks ago he participated in the New Jersey Annual Planning Conference. Topic this year was warehouse development. It was a great discussion with stakeholders from around the state. There were about three hundred people that had watched live. Similar concerns had been heard from around the state that are happening in Warren County. To that end, we had sent a letter about a couple years ago to the New Jersey State Planning Commission asking them for the state to take an active role in addressing the warehouse proliferation that is taking place around the state and around the county. They actually have just released their proposed guidance.

Mr. Kern has been talking with Dave and Ryan in the Planning Department, and they are going to come up with their thoughts and comments that they would like to potentially see or not see. We will get that circulated to the Planning Board and ultimately the Commissioner Board. Essentially, the guidance aims to facilitate a proactive approach rather than a reactive approach that we are all too familiar with here, to provide the municipal factors when developing and updating master plans and review applications and requirements. Encourage a regional approach to planning and facilitate logistic facilities. "Again, I don't know what recommendations are as opposed to the requirements, unfortunately. However, I think that there might be some state funding that's associated if towns don't actively participate in this type of regional approach. So I think that is the carrot and stick model that might be being addressed down in Trenton. So again, very happy to see it, it's pretty lengthy, I do encourage my colleagues to read it."

Finally, along the warehouse discussion, I attended a meeting with the DEP Commissioner in Phillipsburg. I went there to get on is his docket about electric vehicles. Try to make sure he didn't forget about Warren County. There was also a lively discussion about warehouse development in the town as well, under urban communities and environmental justice communities in Phillipsburg, as one. That is also, kind of one of the areas we are focusing on for our electric vehicle program. "So good meetings I attended, that is all I have this evening."

Ms. Ciesla reported she has been busy attending different events that has been taking place around the county. "I encourage everybody to go out and support all of our different town events." Warren County is a great place to be in the summer.

I have been reviewing all the documents that came out, there is quite a lot of guidance out there, but it is good that it is getting the attention that it needs regarding the warehouses. I am sure that our Planning and Engineering Departments will do a great job looking at those.

"There are a lot of things going on right now that are up in the air with the broadband and cellular. The state is almost done with their review of coverage, I know they had to go back and update those numbers, I think with Comcast. Our assemblyman and senators have been roped into this as well. I don't know if they have gotten the money yet. That is all that I have."

Mr. Sarnoski kept it brief, did not have anything to report.

#### **CLOSING PUBLIC COMMENTS**

Tara Mezzanotte, Knowlton Township and I-80 DWG Coalition gave an update on the rock fall mitigation concern efforts. She had been visiting lots of other municipalities, updating them and thanking them for past the support because we are kind of in this together. Many municipalities on the New Jersey side and Pennsylvania side that are very concerned with the new project that the DOT is putting forward addressing the safety issues of the retaining wall. They are standing completely ready to support, any action Knowlton or Warren County should take, looking for any information, anything at all. They are very interested in whatever could come of it.

"Along that vain, I am deep into research about the asset neglect, which is what has happened here, the retaining wall is a structure and the drainage is a structure, and there is no provision that has required the NJDOT to inspect those assets like a bridge. Bridges are required every two years. They got away with not including this. Other states have a complete inventory of all there retaining walls and all their other smaller structures, I am just talking those that are pertinent to the s-curve. So they have an inventory of all their drainage, inventory of all their walls, New Jersey did not include that; and that was in their report that went out in 2019. What came out of that report was also the recommendation to include new policies that would include assets such as retaining walls and drainage in an asset management plan. I am looking at that there were significant issues with the drainage, the pipes are clogged and were clogged in multiple areas and the pipes are separated in multiple areas. They knew that when they inspected in 2020, only addressed the erosion hole. So, I will be coming back with specifics on that, and give you guys some stuff to chew on once I have it all in a form that's easy to understand. Thank you."

Mr. Sarnoski, stated, "just for your information, we did ask the DOT about some information that you presented with regards to the date of the road, when the road was constructed, was it constructed on the old rail line. I don't think we have gotten anything back yet to confirm some of the documents that you had. So we haven't gotten any information back either, just and FYI."

Ms. Mezzanotte thanked the Board.

Mr. Kern asked "had we gotten a response back yet to request of meeting." Mr. Sarnoski replied "No, but Bill I do understand that they were up by Decatur looking at traffic pattern, correct? Mr. Gleba, "they were supposed to but had to cancel, had some mechanical issues. I have not heard back from them, when we do I will let you know. We were all scheduled to be there, we had a meeting place all set-up, and they were

going to be looking at the inter-change up by the truck stop to figure out a solution or solutions for the tractor trailers heading onto Decatur Street."

Mr. Sarnoski, as far as an overall meeting I know they are still discussing setting it up correct Dave? Mr. Dech, "that is what I am told, yes." Mr. Sarnoski, stated, "but have not gotten a date yet, but they were up at Decatur Street looking at the issues there. So, they know the issues we have, they know we want to meet about them. We have bothered them, and they say it is coming, we are just waiting for it."

Mr. Kern wonder if it is easier to get on the Governor's schedule at this point.


