#### 2. Municipal Ordinance Review & Update Report

**9/21/22** White Township Notice of Public Hearing on Adoption of Amendment to the Township of White Housing Element and Fair Share Plan. Hearing scheduled for October 6, 2022.

**9/22/22** White Township Notice of hearing to determine whether a study area is an area in need of redevelopment, Block 53 lot 1. Hearing scheduled for October 6, 2022

**9/27/22 Pohatcong Township** - Adoption of 2022 Master Plan Reexamination Report for Pohatcong Twp. Adopted September 26, 2022.

**10/17/22** Phillipsburg - Notice of preliminary investigation to determine whether a proposed amendment to permit 65 foot building heights to the Revised Riverfront Redevelopment Plan is consistent with the Town's Master Plan. Hearing scheduled for October 27, 2022.

**10/17/22** Liberty Township - Ordinance to Amend Chapter 105 concerning solar installations to ensure that realizing the important benefits of solar power does not result in degradation of the rural and agricultural character of Liberty Twp. Hearing scheduled for November 3, 2022.

**Stormwater Control Ordinances** and Stormwater Plans - The County is responsible for reviewing and approving municipal stormwater control ordinances (SCO) as they are updated pursuant to NJDEP revised rules. One (1) municipality has not submitted an ordinance.

**3. Development Review Online Applications** – October 2022 development applications are in process of being uploaded into the story map. Story map is being phased out and ArcGIS Experience Builder will be used to show case Development Review applications. - **4. Public Information Requests** Addressed/processed three requests from September 16 through October 17.
- 5. Demographics/US. Census –The New Jersey 2020 Census data is on the NJ Data Center web page at <a href="https://nj.gov/labor/lpa/census/2020/2020census">https://nj.gov/labor/lpa/census/2020/2020census</a> index.html . The Board of County Commissioners approved a resolution requesting the Office of Management and Budget to classify Warren County in the New York-Newark Metropolitan Statistical Area instead of the Allentown-Bethlehem-Easton MSA. The OMB replied and said that by current definition Warren County is a central county in the ABE Urban Area and that it would be classified in the ABE MSA. The OMB stated that it will be revising the MSA classifications in 2023 based on the 2020 Census Data. Subsequently, we were contacted by Senator Corey Booker's office to schedule a meeting to discuss the County MSA resolution and how his office may help. A meeting was held on June 8. Senator Booker's office asked for additional information and will be following up with the Census Bureau and OMB. No response has been received yet as of October 17, 2022
- **6. Open Space and Trails** The GIS "Trails" layer is being updated to GPS and fill in missing segments of trails. The goal is to prepare a countywide comprehensive trails map. The trail layer has been updated using the GPS unit. The trail map is being prepared.
- **7.** Warren Highlands Trail- A spur of the trail is being blazed through Harmony Township. Signage is being considered on CR 519 in Harmony Twp. where the trail will cross.
- 8. Morris Canal French and Parrello was contracted for engineering services for the design for construction of trails on six segments of the Morris Canal owned by the County. As of this writing the Phase II Archeological investigation is still ongoing. SHPO had additional comment/questions about the project about the color of the pedestrian bridge abutment, interpretive signage, and why the trail deviates from the Canal's towpath alignment in several locations. Soil Conservation District Permit has been obtained. A Stormwater permit is now required from the State Dept. of Agriculture. The NJDOT will then issue a Categorical Exclusion document.

It is undetermined when the project will go out for bid and construction. Autumn of 2023 is now the projected date for start of construction.

- **9.** Warren Heritage Scenic Byway Both the Northern and Southern Extensions were submitted and received by the NJDOT. Coordinating on scheduling a meeting to continue to move the project forward.
- 10. Rt 57/CR 519 A follow up email was sent to NJDOT on and a virtual meeting is tentative scheduled in November. Projects of interest are; Rt 22/CR 519, Rt 57/CR 519, Rt 46/CR 519, the I-80 Interchange in Columbia. The request for discussion on the Rockfall and Fix the S Curve projects was withdrawn from this request as we anticipate discussing the Rockfall project in a separate meeting.
- 11. I-80 Rockfall Project/S Turns/Retaining Wall The current schedule projects construction to start in 2025 and complete 2029. NJDOT needed to amend the Transportation Improvement Program to advance funding into preliminary engineering to fix the retaining wall that holds up I-80 eastbound in the Rockfall project area. Total PE, Design, and construction costs are estimated to be \$56.5 million. Currently reviewing the draft flood hazard permit NJDOT filed with the NJDEP for the retaining wall stabilization project. Comments were submitted the week of Sept 19.

- 12. Pilot Freight Concept Development Program- Drainage Culvert Replacement Project in Hackettstown –
- 13. Freight Rail Grade Crossing Assessment Study Planning Staff participated on the Technical Advisory Committee for the NJTPA's Freight Rail Grade Crossing Assessment Study. The first study was completed in 2008 to address the impacts of increased freight rail traffic along the region's major freight rail lines. This traffic creates increased delays at grade crossings and raises issues of safety and quality of life in those communities where these crossings are located. The conditions have changed since the completion of the original study. The purpose of this study is to update the original study to document the current conditions and to develop recommendations for addressing issues at the top 10 grade crossings in need of improvement. Since the study is focusing on only the main lines that serve the region, the Lehigh Line, which is the Norfolk Southern Main Line, is the only line that will be studied in Warren County. The only grade crossing on this line in Warren County is at Springtown Road in Pohatcong Twp. The study is scheduled for completion by June 2023. The consultant on the project conducted a field inspection earlier this month.
- **14. Transportation Plan** The County Planning Board held a public hearing on May 23, 2022 meeting and adopted the Plan. The adopted plan is on the County website.
- 15. County Transportation Advisory Council- Next meeting is scheduled for November 10.
- **16. NJTPA** Attended the October 17 NJTPA PPC/PEDC and Freight Committee meetings. Heard a presentation on a Smart Mobility Project in New Brunswick and one about the warehouse guidance document prepared by the Office of Smart Growth.
- 17. NJTPA Subregional Study Program- To advance some of the recommendations contained in the County's Transportation Plan, we worked to complete thumbnail sketches for four different planning projects for consideration. Completed submission of grant application for the Countywide Comprehensive Complete Streets Study August 26<sup>th</sup>. Interviewed/presentation to the SSP Program Review Committee for grant on September 23. Final revision was submitted on October 17.
- **18. EV Vehicles** Working with NJTPA to locate more Electric Vehicle chargers throughout the county. We are assisting the County's Public Works Director is exploring the possibilities of converting the County motor pool to EV and identify locations throughout the county where charging stations may be installed for county and for public use. Ideally they should be installed in locations throughout the county to ensure adequate coverage and reliability.
- 19. Lackawanna Cutoff- NJTRANSIT announced that funding has been allocated for the continued expansion of the project Rehabilitation of the Roseville Tunnel should have begun in June. Additionally, NJT, NJDOT, and PennDot will be filing an application to the Federal Railroad Administration (FRA) for funding to conduct a detailed comprehensive engineering evaluation of the entire corridor from Andover to Scranton. Attended regional meeting with local and regional leaders regarding the potential application to the FRA. The application must be filed by the end the year.
- **20.** Raritan Valley Line- Recently, the Lehigh Planning Commission announced that it is partnering with PennDot to conduct a study of passenger rail options into the Lehigh Valley. One of the lines being examined is the Raritan Line extension from High Bridge through Phillipsburg. The Lehigh Planning

Commission and PennDot should have a consultant under contract by October. The final study should be completed in one year.

- 21. Road Safety Audit The NJTPA with the NJDOT developed road safety audit program where a segments of roadway that statistically have a higher number of crashes are identified as a candidates for an audit. The segment of County Route 519 from Rt 57 south to Strykers Road was identified for the audit. The audit team, led by Greenman Pederson, visited the site t on October 4 and 5 with county and municipal officials. Many interesting ideas were discussed to address safety, congestion, and freight movement. A report of GPI's findings and recommendations will be submitted in November/December
- 22. CR 519/521 Weight Restriction Under review by NJDOT.
- **23. NJDOT/ NJTPA TAP Grant-** Staff had a pre application meeting for the NJDOT Transportation Alternatives Program. The County is planning on moving forward with a grant application through this program for the installation of a bridge across the Lopatcong creek in addition to the continued enhancement of the Morris Canal Greenway trail in the Lopatcong Creek vicinity. The Application is due November 3.
- **24. Economic Development Council** –Attended the October 13 EDC meeting. Reviewed the results from the EDC survey, which is designed to gauge interest in potential economic development initiatives to help identify and address economic growth/development issues throughout Warren County. The EDC opted to continue survey for an additional social media push. The link to the Survey is <a href="https://www.surveymonkey.com/r/3ZLHLJ7">https://www.surveymonkey.com/r/3ZLHLJ7</a>. The EDC is going to continue to keep the survey open. There was a discussion on the cell service survey and a discussion about the future Highlands presentation.
- **25.** Musconetcong River Management Council Next meeting October 18, 2022 via zoom. Attended meeting to review the National Park Service brochure of the Musconetcong River. A new brochure is being produced and a committee was formed to review wording and pictures.
- **26. Solid Waste and Recycling -** Weekly education advertisements about recycling continue to run in the Express Times and/or Warren Reporter.

Developed a How and What to Recycle brochure and was posted on the county website. In addition a postcard displaying useful websites will be distributed to households located in the municipalities that have the lowest documented recycling rates. This will go in the mail this week once the internal mechanism to pay the postage is worked out.

Received the application for a food waste composting facility proposed in Mansfield Twp. for inclusion in the Warren County Solid Waste Management Plan. The SWAC heard a presentation from the applicant at its meeting on September 1. The October meeting had to be canceled due to the number of people in attendance. The next meeting scheduled for November 3 will be held at the Warren County Technical School. The SWAC Sub-Committee had a field visit to a food waste compost operation in Sussex County that utilizes windrows technology instead of aerated static piles.

At its October 12 meeting the Board of County Commissioners added LMR LLC as a Class A Recycling Center to the Solid Waste Management Plan. Obtaining unconditional site plan approval from the

County Planning Board was the last condition that needed to be met before LMR could be added to the SWMP.

- **27. County Road Map-.** The narrative and photos were added to the backside of the map. Narrative was added. Narrative is under review by Public Information Department currently.
- 28. Park Locator App and Parks Story Map- The app is still a work in progress and will be able to deploy from any mobile device. The County of Warren's transportation objective is to provide a safe and efficient road system for all users. This is accomplished through a combination of traffic management techniques and capital improvement projects. The preparation of this report is part of Warren County's efforts to identify areas on the County Road system where changes may improve safety for the traveling public.

The Year 2021 Crash Data and Road Safety Assessment is prepared with information provided by local police departments in Warren County and the New Jersey Department of Transportation (NJDOT) providing State Police data. The engineering department receives data from various police departments and NJDOT for crashes occurring on county roads. The information is then reviewed and the critical data is entered into a computer database. After all the crash data has been entered, the data is sorted under several parameters so locations of high crash occurrences can be identified. These locations can then be studied further to determine if corrective measures can be made.

When completed, the information in this report is distributed to police departments, municipalities, state officials, and county officials. The government officials receive the report to assist in their decisions in allocating funds to improve problem areas. Local police departments receive the report so they can concentrate enforcement efforts where most needed. While motor vehicle crashes cannot be entirely eliminated, the process of identifying high crash locations and determining appropriate improvements will minimize crashes and improve public safety.

# Warren County Road System Locations with the Highest Number of Crashes and Addressing Comments Year 2021

## 1. Intersection of County Route 638 & US Rte. 22, Pohatcong / Greenwich Twp. -27 Crashes

The State of New Jersey has jurisdiction over this signalized intersection. The intersection shows a pattern of same direction and turning related crashes, typical for signalized intersections. The reported crashes may be attributed to the very high traffic volumes at the intersection. There are no changes proposed at this time. This report will be forwarded to NJDOT for further review.

## 2. Intersection of County Route 519 & US Rte. 22, Pohatcong / Greenwich Twp. -19 Crashes

The State of New Jersey has jurisdiction over this signalized intersection. The reported crashes are attributed to the heavy traffic congestion in this area and the unusual configuration of the intersection. The intersection shows a pattern of same direction and side-swipe crashes, as expected for the layout of the intersection. There are no changes proposed at this time. This report will be forwarded to NJDOT for further review.

## 3. Intersection of County Route 604 & US 46, Hackettstown – 8 Crashes

The State of New Jersey has jurisdiction over this signalized intersection. The intersection shows a pattern of same direction crashes involving vehicles stopped on County Route 604. The majority of the crashes are attributed to the high traffic volume and limited space for turning movements. It has been reported that NJDOT is evaluating intersections along this stretch of Route 46. This report will be forwarded to NJDOT for further review.

## 4. Intersection of County Route 517 & Bilby Road (Former CR 665), Independence Twp. – 8 Crashes

A traffic control signal was installed in 2011 at this intersection to improve operation and safety. The intersection shows a pattern of same direction crashes involving vehicles stopped on County Route 517. This is a typical pattern for signalized intersections. This location will be monitored for future crash occurrences

## 5. Intersection of County Route 519 & State Highway 57, Lopatcong Twp. – 8 Crashes

The State of New Jersey has jurisdiction over this signalized intersection. The intersection shows a pattern of same direction and turning related crashes, typical for signalized intersections. There are no changes proposed at this time. This report will be forwarded to NJDOT for further review.

## 6. Intersection of County Route 646 & US Rte. 22, Phillipsburg – 7 Crashes

The State of New Jersey has jurisdiction over this stop controlled intersection. The intersection shows a pattern of same direction and turning related crashes. The intersection is not signalized and the crashes are typical of drivers' hesitation to merge into traffic, and pulling too far into the intersection into oncoming traffic. There are no proposed changes at this time. This report will be forwarded to NJDOT for further review.

## 7. Intersection of County Route 519 & County Route 623, White Twp. - 5 Crashes

This location shows a pattern of angle crashes. The crashes are generally minor in nature involving property damage only. The intersection is currently a 4-way stop with an overhead blinking light. The intersection is planned to be signalized in the future. This location will be monitored for future crash occurrences.

# 8. Intersection of County Route 630 Spur & State Highway 31, Washington Twp. - 4 Crashes

The State of New Jersey has jurisdiction over this stop controlled intersection. The intersection shows a pattern of same direction crashes involving vehicles stopped on South Broad Street. The two roads intersect at an acute angle. This type of configuration is susceptible to same direction crashes. A previous recommendation was made to the NJDOT to install left turn lanes on Route 31. A traffic control signal should be considered at this location. This report will be forwarded to NJDOT for further review.

## 9. Intersection of County Route 638 & Dumont Road, Greenwich Twp. - 4 Crashes

This location shows a pattern of angle crashes. The intersection is currently a 2-way stop. A new shopping center development and a new road segment were constructed at this location in 2011. This created new traffic patterns and increased traffic volumes through the intersection. Since the crash experience from prior years shows lower crash activity, this location will be monitored for future crash occurrences.

## 10. Intersection of County Route 517 & US Rte. 46, Hackettstown – 4 Crashes

The State of New Jersey has jurisdiction over this signalized intersection. The majority of these crashes are attributed to the high turning volume and the geometrics of the intersection. The crashes are generally minor in nature, involving property damage only. This report will be forwarded to NJDOT for further review.

## 11. Intersection of County Route 517 & Franklin Street, Hackettstown. - 4 Crashes

This intersection shows a pattern of angle crashes. The majority of these crashes are attributed to the high traffic volume and congestion in the area. This location will continue to be monitored for future crash occurrences

## 12. Intersection of County Route 517 & I-80 EB Ramp, Allamuchy Twp. - 4 Crashes

The State of New Jersey has jurisdiction over this signalized intersection. This report will be forwarded to NJDOT for further review. There is no predominant pattern to the crashes at this location

## 13. Intersection of County Route 517 & I-80 WB Ramp, Allamuchy Twp. - 4 Crashes

The State of New Jersey has jurisdiction over this signalized intersection. This intersection experiences a pattern of same direction and angle crashes which are attributed to the intersection geometry being skewed. These crashes are expected of skewed intersections. A traffic signal was installed in 2014 at this location. There are no changes proposed at this time. This report will be forwarded to NJDOT for further review.

## 14. Intersection of County Route 519 & Pershing Avenue, Pohatcong Twp. - 4 Crashes

This location has reported a sudden increase in crash activity compared to previous years. Pershing Avenue intersects County Route 519 at a 90 degree angle, and is controlled by two stop signs located on Pershing Avenue. There is no predominate pattern to these crashes at this time. This location will continue to be monitored for future crash occurrences
