Reports and Comments

County Counsel Joe Bell had no report.

County Engineer Bill Gleba said his office had been in contact with the NJ DOT regarding several matters. They will be starting back on Route 46 with the pavement preservation program they had started last year.

Mr. Gleba and his staff had a meeting with NJ DOT at Interstate 78 and County Route 632. The State has a project going on Route 78 lanes, as well as ramps, and it has not completed the project. This unfortunately has impacted the County's project, as the NJ DOT does not seem to be clear on where its jurisdiction begins and ends. The County's position is that they should pave the road from ramp to ramp. He is still working on getting the State to agree. This project is part of our resurfacing program to complete this year, but without the State's cooperation, it may have to be delayed again.

Several railroad bridges are also being discussed with the NJ DOT, one of which is CR 620 in Belvidere. About two weeks' worth of work is anticipated there. Both lanes will be kept open in the evening; during the day, there will be one lane of alternating traffic. The other structure is on CR 608 (Silver Lake Road in Frelinghuysen), which will need to be closed and detoured, probably soon after the July 4 holiday. CR 629 in Port Murray is also on the list with no timeline as of yet.

There was a bit more discussion regarding the area between the ramps on Route 632 in the Bloomsbury area.

County Planner Dave Dech reminded the Board of the electronics waste event being conducted at the PCFA from 8am-12pm on April 15.

County CFO Dan Olshefski said we are now one quarter through the year, and revenues are up again this year. The County Clerk is doing well; the Sheriff's Office continues to do well; TASS is bringing in the revenues we anticipated; so that is good news. Ratables are up only one percent over last year. Valuations are flat, and have been for the last few years.

Mr. Olshefski said he has been working with Corey Tierney on Open Space Trust Fund reallocations between the categories.

The auditors completed their fieldwork; Mr. Olshefski received a draft copy of the audit, and it looks very favorable. We should have the final report in the next few weeks, he said.

County Administrator Steve Marvin requested a copy of the ratables report Mr. Olshefski had alluded to, since he had not seen it. He then brought the Board's attention to the position vacancy report for approval, followed by a request for a motion and second to cancel the May 9 freeholder meeting due to the NJAC Conference being held that week.

On motion by Mr. Sarnoski, seconded by Mr. Gardner, the Warren County Board of Chosen

Freeholders cancelled the scheduled Regular Session of May 9, 2018 at 7:30 pm at the Wayne Dumont, Jr. Administration Building, 165 Route 519 South, Belvidere, New Jersey. Recorded vote: Mr. Gardner yes, Mr. Sarnoski yes, Mr. Smith yes.

Freeholder Comments

Mr. Gardner said due to the lack of press coverage, he felt a county newsletter was warranted and a responsible thing to do, to inform the public of various accomplishments of the Freeholder Board. He recalled a four-page newsletter produced a number of years ago; he thought the cost was modest, although that would have to be looked into. Mr. Sarnoski asked how often he thought one should be produced. Mr. Gardner thought once or twice a year. He cited accomplishments in the 911 Center, Land Preservation, and historic achievements. Mr. Sarnoski said he did not disagree there needs to be more marketing regarding what goes on here. He noted an electronic version could be posted on the County website as well. Mr. Smith asked Public Information Officer Art Charlton to come up with a proposal for the Board.

Mr. Sarnoski had no report; he reminded everyone to pay their taxes.

Mr. Smith reported having a post-storm meeting the prior day with John Anderson of JCP&L and Public Safety Director Frank Wheatley. He thought he delivered a clear message that the roads need to be clear for emergency vehicles, particularly during events when people may turn to alternate heating sources that may cause fires. "If we can't get to those houses... that's a problem," he said. He thought it was a very positive discussion that should yield some results.

Mr. Gardner remembered something else he wanted to bring up. He talked about having attended a meeting at the Asbury Mill, as it is seeking \$110,000 to match a grant, to continue its restoration goals. Mr. Smith said he was still troubled by the lack of commitment over the dam. Mr. Gardner said the County may be able to have more control over the matter because it is intertwined with a bridge abutment within the county road system. Regarding the dam, Mr. Smith said he had reached out to his contact at the NJ DEP, who was going to reach out to historic contacts at the State level, to look at whether perhaps an exception could be made on the match based on past contributions. That's a work in progress, but Mr. Smith was still very troubled that the County has already invested \$1.6 million; this would make it \$1.8 million. "I don't think that there's been any other organization that has seen that type of support," he said. The tourism component would be the Resource Center.

Mr. Sarnoski said he had spoken to Corey Tierney regarding these issues. While \$1.6 million was granted to the Musconetcong Watershed Association, he said \$825,000 has been dedicated to this particular site. Another \$110,000 would bring the total to \$935,000, which is similar to the amounts invested in the Ramsaysburg and Hoff-Vannatta locations to achieve stability. He had asked to see some specific agreements regarding the following: a parking plan for public access; getting easements on locations for public access; and what about other funding avenues, like Franklin Township? He thought Franklin should invest this year as well. Mr. Gardner said they have invested \$150,000 so far, but not this year.

Mr. Smith said this is an NGO, not a charitable institution. I look at the amount of return, he said. We haven't put this kind of money into Rutherfurd Hall, which is by far a greater benefit to the county, with many events conducted there. He still has not seen commitment in terms of the level of staffing at the Asbury Mill... there are a lot of issues, he said.

Mr. Sarnoski said we have invested so much; we don't want what we've already done to rot away. Mr. Gardner said they are in dialog with the William Penn Foundation, which he thought was important.

Further discussion ensued, with Mr. Sarnoski and Mr. Gardner articulating specifics on what they want to see from the Musconetcong Watershed Association. An April 26 deadline for the match was looming. Mr. Smith remained concerned on several levels, comparing the matter to other county historic facilities. If we put a million dollars into Shippen Manor, we could have staffed it and could have turned it into a go-to museum, he said. "I don't think there's any other nongovernment entity that we have provided the level of funding that we have to the Musconetcong," said Mr. Smith.

With Mr. Sarnoski and Mr. Gardner waiting to see some commitments from the MWA, and Mr. Smith not inclined to support the \$110,000 venture at this point, Mr. Smith advised his colleagues to put something together for the next meeting. All agreed they would prefer a deadline extension, but Mr. Sarnoski did not want to miss the grant matching funds opportunity. Mr. Smith said he would continue working on trying to extend the deadline, and for the DEP to waive the match money based on the Freeholder Board's prior commitments.

There were no closing public comments.
