REPORTS AND COMMENTS

County Counsel Joe Bell had a few matters for discussion in Executive Session regarding litigation, contract negotiations, and personnel matters.

County Engineer Bill Gleba had no report.

County Planner Dave Dech announced several meetings and events: Household Hazardous Waste recycling at the PCFA on April 29; Paper Shredding at the County Administration Building on May 12, the same date of the Morris Canal bus tour; a public open house on the Transportation Technical Study the evening of May 16 in Washington; and a Planning Board hearing on the Open Space Plan on May 21. Mr. Smith remarked on the overwhelming response to the recent electronics recycling event.

County CFO Dan Olshefski said we are ending our participation in the State Health Benefits plan as of May 1, which should be seamless and is expected to result in a savings of nearly eight percent. It should be a win/win.

Mr. Olshefski was pleased to report that the completed audit was received this week. It shows we are in good financial shape, as there were no recommendations or comments.

County Administrator Steve Marvin was absent.

FREEHOLDER COMMENTS

Mr. Gardner reminded everyone that the next regularly scheduled meeting of May 9 had been cancelled to accommodate for the NJAC Convention. The Board's next meeting of May 23 will begin at 7:30 p.m.

Mr. Sarnoski reported on various matters relative to the Addiction Awareness Task Force, starting with a logo contest it conducted among students. The winner will receive a certificate and a check. An addiction resource event originally planned for May was postponed until

September.

Regarding drafting a resolution on the marijuana issue, as several citizens had suggested, Task Force members overwhelmingly recommended that we wait for more information to be revealed. The language in the medical marijuana law had recently changed. Mr. Sarnoski said a subcommittee of the Task Force is tracking the issue very carefully. Mr. Smith said he appreciated them going through that process, saying a deliberate approach is better.

Mr. Sarnoski then talked about the electronics recycling event of the prior weekend. If success is measured by how many people participated, it was very successful. He said he waited in line for three hours. This shows there is a need for the service, and also a need for improvement. He thought perhaps splitting it up over a couple of days, with certain municipalities assigned certain days, could help alleviate the long wait. It was reported that 13 53-foot box trailers were filled, with 852 cars coming through with items.

Two senior citizen recognition luncheons were coming up; May 22 hosted by Hackettstown Medical Center, and the County's May 24 event at the Independence Senior Center.

Mr. Sarnoski was looking forward to being honored with the Good Scout Award on May 17 along with John Kruk at Bella Giorno.

Regarding the electronics recycling event at the PCFA, Mr. Smith said we had been told such a program was not eligible for recycling dollars because it was supposed to be provided for in legislation; covered materials should be processed at no charge to the PCFA or the County. There were some costs incurred in terms of oversight, but that should be able to come out of the recycling grant. A process is underway to hold another event this year if the funding is there. This vendor is being very cooperative; there may be a possibility of something ongoing a couple of days a week. Mr. Smith thought the demand for this service was similar to what happened with the tires; there had been pent-up demand that should level out over time. Overall, he thought the program was a "tremendous success." Mr. Sarnoski agreed it was successful, but thought lessons could be learned for it to run more efficiently in the future.

Mr. Smith noted that the NJ DEP and Historic Commission did extend the grant deadline for the Musconetcong Watershed project. This gives us about another month to get to the bottom of this, though he was still somewhat confused about where the numbers were coming from and questions remained.

CLOSING PUBLIC COMMENTS

Stan Prater of JCP&L advised the Board that JCP&L would be having meetings with the Warren County OEM on May 22 and May 24 to review its storm process and talk about lessons learned from the storms in early March. Mayors from each municipality have been invited, along with OEM coordinators, police chiefs and State legislators.

The local radio reporter sought and received clarification regarding the time and date of the next Freeholder meeting.
