REPORTS AND COMMENTS

County Counsel Joe Bell said he had a few matters for Executive Session regarding litigation and contract issues concerning acquisition of property.

County Engineer Bill Gleba updated the Board on several matters. His office, along with Public Works, met with the NJ DOT regarding the Route 173 bridge reconstruction. While some concerns were addressed, such as the NJ DOT agreeing to repair any damage that may occur along

the detour route, the bigger issue was the estimated 15-month length of time for the road closure. They got it down to 12 months and basically said that was the best they could do. Mr. Gleba found that timeline hard to believe, but was not very optimistic that it would improve.

Mr. Gleba was pleased to report that all documentation regarding the Blairstown bridge and roadway exchange had been delivered to the Courthouse. Once filed, the arrangement will be finalized, so departments of public works should be all set for winter operations.

County Engineers have been contacted by NJAC regarding a Senate bill (NJ S2863) that is going to modify some of the local aid allocation requirements. "Reading through it, it's very concerning," he said. "There's five elements to it, none of which seem all that appealing." The major element was for counties to start spending down their funding within one year of receipt. Essentially, he said, this would mean we would have to have "shovel-ready" projects ready to go years in advance.

The Township of Knowlton forwarded a copy of its Resolution 2018-120 regarding County Route 676 (Decatur Street) in the Columbia area. It requests an examination of the traffic problems on the street; suggesting closure of one end of the street. Enclosed was a petition with signatures of area residents. Looking at this, Mr. Gleba said, "I don't know why the County would want to close down one of its roadways. The whole purpose of our roadway network system is to move people, to move goods, and to move services." They are apparently having a lot of issues up there. However, they mainly seem to be enforcement issues (speeding, overnight parking, trash, debris, overweight trucks and power lines being brought down by oversize trucks) but not issues germane to the county. Mr. Gleba went back through some files, and found back in the year 2000, the County had done a lot of work up there to try to take care of some of these issues. It had formerly been a through street; we put up stop signs, among other things, in an effort to help.

Knowlton is looking to close the road. "I would say if they want to close the road, they should take the road, and contact the DOT to try to work out a deal with them in order to resolve it," Mr. Gleba said. "I don't know how much more the county can do." The speed limit is 25 MPH; we also installed rumble strips. Mr. Gleba went on to provide more examples of how the county has tried to help, but it cannot have someone posted there 24/7.

Mr. Sarnoski acknowledged that Knowlton Township Mayor Adele Starrs was in attendance this evening, and was aware of discussions with Mr. Smith, the township's liaison. He said we mentioned earlier the culmination of a road exchange with Blairstown, which took years to complete, because we could not do some of the things they wanted on Main Street and still conform to what a County Road is supposed to be. We finally found an agreement there, and are currently working on one with Oxford, he said. Knowlton has been resistant to take ownership of the road. Mr. Smith added that this is similar to the Oxford road in that it comes up to Route 31 and is sort of an off-ramp. He understood there were other issues in Knowlton, which he said he would be happy to discuss later during the public comment portion.

Back to the County Engineer, Mr. Smith requested an update with the right-of-way issues on Edison Road, relative to the water main there. Mr. Gleba said Mr. Smith was referring to the federally funded and overseen Pohatcong Operating Unit 2 project. This has to do with the Pohatcong Valley Superfund site and the extension of potable water main systems. Along Edison Road, the design is to have it offset out of the right-of-way, which is very limited there, and there is already a gas main on the one side of the road. The design consultant suggested putting in an easement, and attempting to get easements from property owners along Edison Road. The EPA turned the project over to Rio Tinto, the entity responsible for the cleanup, who hired another consultant engineer, who concluded that it could not obtain any easements from property owners and want to come into the roadway.

Mr. Gleba said we are trying to figure it out. We have a corridor available on one side of the road, but we do want the water main put deeper into the ground so we can put in a drainage system in the future. "I don't see why the County should be impacted by some entity that we may have to pay to have relocated in the future," he said. Nevertheless, dialog is ongoing and Mr. Gleba was optimistic. We have a limited right-of-way, and we need to be able to plan for future projects. Mr. Smith said he had been advised that homeowners are being told that the county is the problem. He suggested outreach to explain the facts of the situation.

County Planner Dave Dech apprised the Board of the Paper Shredding event held the prior Saturday. He reported that 260 cars delivered an estimated 9,000 pounds of material. Mr. Sarnoski said he was one of them, and it went very smoothly.

County CFO Dan Olshefski said he didn't really have anything to report, other than budget requests for 2019 are starting to trickle in.

County Administrator Steve Marvin said the latest vacancy report was very limited, and reminded everyone that the Board's next meeting would begin at 7:00 p.m., and all meetings thereafter through the end of the year.

FREEHOLDER COMMENTS

Mr. Gardner reported on the recent NJAC meeting, where representatives from Senate President Steve Sweeney's office discussed a working group that was examining how to shave costs off pensions, but it wasn't clear how they were going to do this. He asked Mr. Smith if he concurred. Mr. Smith said the consolidation services has become an old topic. They are trying to look at everything, but the problem is simply revenues and spending. Mr. Gardner said that's why he brought it up. He had asked if they were going to examine excessive regulation, and didn't really get an answer. We know how hard it is to do business in New Jersey, and Mr. Gardner thought that was a paramount issue of concern.

Mr. Gardner said the Grand Opening of the Southwest Branch of the Warren County Library over the weekend was exciting. He thought it was very well attended and quite impressive.

Preservation Day at the Roseberry Homestead in Phillipsburg on September 15 was nice as well, but Mr. Gardner didn't think it had been as well attended as the previous year.

Rutgers Cooperative Extension of Warren County has a new Program Coordinator up and running. "I think he will really serve the public well," said Mr. Gardner. He has an extensive background in Florida and New York.

Mr. Sarnoski reminded everyone of an Addiction Resource Conference being held on October 12 from 8:30 a.m. to 2:00 p.m. at Warren County Community College. The United States Attorney for New Jersey will be the keynote speaker at 9:00 a.m. to talk about how the nation is combating this problem. He looked forward to a good discussion, and there will be at least a dozen addiction resource providers there.

Mr. Smith talked about pending legislation on voting machines, as had been discussed at the last Freeholder meeting. He raised the issue at NJAC with Mr. Drennan, who is very much aware of the discussion up to that point, and he assured us that Warren County's actions – if it moves in a positive direction – would be consistent with the statute of generating a paper ballot. Legislation has been introduced requiring a computer-generated voting record – which Warren County already does – which eliminates the cost of having to buy tens of thousands of dollars of paper ballots for voters to fill out manually. Mr. Marvin asked if NJAC decided to file a state mandate/ state pay on this new vote by mail requirement that they hung on the County Clerks. Mr. Smith said it was discussed at length among the clerks. There is not going to be monetary compensation in part because this established a new policy and will not have to be done again.

Mr. Smith was very pleased about the completion of the Blairstown road exchanges, which has been 30 years in the making, and expected similar discussion regarding Knowlton. We have begun the process for Oxford to take over a road as well, which he hoped to see through before leaving office at the end of the year.

Regarding mosquitoes, Mr. Smith said West Nile Virus is out there. He recommended insect repellant as the best defense. If it continues to rain, we will see rampant increases in the population. Mr. Gardner reminded residents to empty any standing water on their properties. On a related note, Mr. Sarnoski urged the public to get flu shots.

Mr. Smith said Crisis Intervention Training (CIT) sponsored by the Prosecutor's Office is being conducted again this year to identify if an individual has mental health issues that could be the reason they are acting out in a certain manner. That helps our law enforcement and other first responders.

The new library's Grand Opening was a great testimony to the work of the Library Commission, and the Freeholders. It was a great day, and he was especially pleased about the 3-D printer there.

CLOSING PUBLIC COMMENTS

Knowlton Township Mayor Adele Starrs approached the Freeholders to bring them up to date on the Decatur Street matter. She said the Township Committee has twice extensively discussed taking over the street. "Our attorney has very strongly indicated to all of us that we may not do that," she said, nothing both the township attorney and insurance attorney agreed on this. There is a salt problem in general in Columbia, and the committee commissioned a study. They are awaiting results from that, to look at long-term solutions to the problem. While she believes there is a long-term solution, until the issue is resolved, their legal advice is not to take ownership of the street. Mr. Sarnoski asked what one thing had to do with the other. Any liability issues regarding the salt will revert to which entity had ownership at the time of the problem. Mayor Starrs said that was a question for the attorneys.

Mayor Starrs continued to illustrate the issues occurring. Heavy trucks are increasingly utilizing the road due to GPS directions, and when an accident occurs on Route 80, it creates bumper-to-bumper traffic and prevents people from getting out of their driveways. She has reached out to the State Police multiple times, but they just don't have the manpower.

Mr. Smith wondered if some sort of lease agreement would be feasible, in which the township could take over maintenance and control of the road, with an ultimate long-term goal of ownership later on.

Ms. Starrs thought making the road a one-way street could be a simple and viable solution. She said if it didn't work out, it could be undone later. Mr. Smith said, "It's just a terrible precedent for us to set." If we arbitrarily make a county road one-way or block one end of it off, then everybody is going to come in here seeking something like that. "I honestly cannot say that I would support closing a county road," Mr. Smith said. Decatur Street does not fit the standard norm of a county road; it was inherited and is more along the lines of a municipal road. Mr. Smith still wanted to work toward the aim of transferring ownership.

Mr. Gardner inquired about the response from the State Police. Ms. Starrs said whenever they write a letter, she asks residents if they see any increased presence and the answer is no. The township twice requested they send someone for traffic control during a Route 80 backup. She said they were told yes both times, but nobody ever showed up.

Mr. Smith talked about Glen Gardner, and how the NJ DOT made it impossible to get in there except for where the traffic light is located. They put a guardrail right across the county road and closed it, because it was too much of a traffic hazard. However, he thought the NJ DOT did that, not the county.

If nothing else, Ms. Starrs asked if it would be possible to have a letter from the Freeholders to the State Police requesting increased enforcement of the area. Mr. Gleba said he had no problem sending a letter to the State Police. "We'll do our best," he said. Further, he said we would be happy to put speed radar feedback signs on that stretch of road. However, the road connects to the NJ

DOT system (Route 46), so they are going to have a final say on the matter. Regarding the one-way concept, Mr. Gleba expressed concern about having to coordinate extensively with NJ DOT to direct drivers who are trying to get to our county road, to get back around through the jug handle system. Another suggestion of Mr. Gleba's was to "do some tweaking" to the signage. "It's a GPS issue," he said, and offered to put up signs that say something like "Not a GPS Truck Route." Mayor Starrs said thank you.

Speaking to Ms. Starrs, Mr. Sarnoski said we sympathize, we know you're trying to do the best you can, but we have to balance what we can do and how to operate a county roadway. I really hope we can work towards getting though this salt issue and a fair transfer of roads, he said.

Regarding the legal advice, Mr. Smith suggested Ms. Starrs have further dialog with the insurance company regarding liability. At the time of the (salt) incident, the county would have owned the street. The Freeholders suggested County Counsel confer with Knowlton's attorneys to keep the dialog going. "Thank you very much," said Mayor Starrs.

Mr. Gleba said we will be up there maintaining the drainage system around late October, and possibly do some resurfacing this season as well.

Pamela Rusweiler of 5 Decatur Street asked the Freeholders to put faces to the people who live there and the circumstances they are dealing with. She brought photos. She understood it was an enforcement issue, but she said the State Police just can't get there. She described suspected drug activity, and people urinating on lawns when traffic is backed up.

Sharon Valentine, also of Decatur Street, said people disregard the signs and "just fly through," she said. There's no enforcement. Mr. Smith reiterated that this board does not have the jurisdiction to be able to change that.

There were no comments nor questions from the press.
