20th ANNIVERSARY WC WAR MEMORIAL & VETERANS' AWARENESS WEEK NOVEMBER 11-17, 2018

WHEREAS, on November 11, 1998, the dedication of the Warren County War Memorial marked the presentation of the memorial to the people of Warren County; and

WHEREAS, the story of the Warren County War Memorial goes back several years as a concept in the mind of Leo Becker, historian of Belvidere American Legion Post 131, presently historian for Post 528 of White Township. There had not been a county memorial to Warren County's veterans since 1910, when the Civil War Memorial was removed from Garret D. Wall Park, in Belvidere and was replaced by a lighted drinking fountain by the Women's Temperance League; and

WHEREAS, the construction of state and federal monuments and the Vietnam Veterans Memorial in Sussex County had generated discussion about a Warren County memorial. In 1996, Becker talked with veterans' groups and by June 1997, a war memorial committee was formed. Architects Jim/Dorothy Constantin volunteered to work on some proposed designs for the memorial; and

WHEREAS, once a design was approved by the committee and the Warren County Freeholders gave permission to build on county property. The name certification subcommittee set out on the monumental task of searching local, state and federal records to determine whose names would be inscribed on the monument stones. It had been decided that the names of men and women who died while on active duty in World War I, World War II, the Korean War and Viet-Nam War would be inscribed on the stones since those records were available. As of November, 2018 there are 307 men and woman's names inscribed on the stones; and

WHEREAS, on September 19, 1998, a ground breaking ceremony was held at the monument site. The nine black stones were quarried and polished in India. Construction began in October with committee members working on weekends and some members using vacation days to work on week days. The stones arrived in the U.S. approximately one week before the dedication; and

WHEREAS, on Veteran's Day 1998, hundreds of people gathered to witness the unveiling of the monument and to see names engraved on its stones.

WHEREAS, in November of 2006 two additional stones were dedicated for Operation Iraqi Freedom and Operation Enduring Freedom with names of fallen soldiers engraved on them.

NOW, THEREFORE, BE IT RESOLVED, that in recognition of the important work done by the **WARREN COUNTY WAR MEMORIAL CORPORATION MEMBERS,** the Board of Chosen Freeholders of the County of Warren does hereby join the members and all citizens in remembering the personal sacrifices made by war veterans so that generations of American citizens may continue to enjoy our country's freedoms and join in celebrating the 20th Anniversary since the dedication of the WC War Memorial on November 11, 1998 and hereby proclaim the week of November 11-17, 2018 as Veterans' Awareness Week and we urge all citizens to visit this Memorial as a place to pause, reflect and remember.

REPORTS AND COMMENTS

County Counsel Joe Bell had a few matters for discussion in Executive Session relative to litigation (W.M., Courtroom #2) and contract negotiations.

County Engineer Bill Gleba reported that County Route 608 (Silver Lake Road) is now reduced to one lane in Hope Township due to work on a bridge structure. He hoped the repairs would be complete the following week.

County Planner Dave Dech reported on a meeting the previous evening regarding the "hole in the wall" South Main Street project - the raising or lowering the clearance for Washington secondary. It appeared based on the presentations that the most cost-effective alternative was to lower the tracks underneath the bridge. They are seeking comments and support for this and other alternatives, which included raising the bridge and doing a realignment, redirecting traffic. He thought it would be advisable for the County to weigh in on this to get the project moving.

Mr. Sarnoski thought there had been more than one study on the matter; he remembered one that concluded around 2011 or 2012. There was another one, conducted by Gene Feyl, which attempted to estimate the cost and economic impact of bringing all bridges and culverts on that line up to date. No one could recall the overall cost estimate, but remembered it was "big money".

Mr. Smith had attended the meeting as well, and what surprised him was that the remedy would only cause the rail to be shut down for a couple of days. "I'm thinking to myself, why on earth have we gone through 10 years of planning and development for a project that most likely doesn't cost a half a million dollars and it's a plus for all of the rail service for the northern part of the state? It's staggering," said Mr. Smith. This was a public-funded economic development endeavor. Mr. Sarnoski said that might be part of the problem, as they initially tried to get Norfolk Southern to fund the project, but Norfolk Southern said there was no economic return. Mr. Smith said that might have been when the original plan was estimated to cost about \$15 million. Now that it is \$500,000 they may have a different attitude, he said.

Once this is complete, we are going to be using the same cars that the rest of the country uses. The cars we are currently using are smaller and will become obsolete. Mr. Smith suggested directing the Planning Department to send a strongly worded letter to endorse getting this done, whether it utilizes state or federal money. He said he had already reached out the Senator Oroho on this. This will open up freight rail transportation. He noted the major storage facility coming to Phillipsburg. This would be one more step to be able to get things to market.

Discussion ensued regarding the importance of the project to our area — "It's the whole Boonton Line," said Mr. Smith, so state funding makes the most sense. Mr. Dech said the federal funding process pursued earlier, going through years of study on different scenarios, tends to bog down the process. Using private or state money, the improvement could be made almost overnight, he said. The Board decided to create a resolution to be forwarded to state and federal representatives.

County CFO Dan Olshefski was absent due to health issues.

County Administrator Steve Marvin had only the most recent vacancy report for approval. There was no further discussion on the matter.

FREEHOLDER COMMENTS

Mr. Gardner had no report.

Mr. Sarnoski took a few moments to talk about the recent Resources for Addiction fair held at the Community College. He said it was very well attended by service providers, who took the opportunity to exchange ideas and network. Not as many members of the public were there, but that was more or less as expected. The U.S. Attorney for New Jersey, Craig Carpenito, was the keynote speaker and he did an excellent job. Carpenito was one of the only U.S. Attorneys to form an opioid task force within his staff. Mr. Sarnoski said they are approaching the problem from many angles, not only going after the dealers and distributors, but also the pharmaceutical industry for improper advertising.

Also discussed was the potential for legalization of marijuana in New Jersey. Carpenito said it is still a federally controlled substance, and while it will not be his focus, it will still be illegal on the federal level. "I thought he did a good job," said Mr. Sarnoski. He was very well spoken and people were happy to have him there.

Mr. Gardner asked if there had been any mention of Fentanyl. Mr. Sarnoski said yes; it was a comprehensive presentation and some of the things they talked about were just astounding. This concluded Mr. Sarnoski's comments.

Mr. Smith said he had also attended the addiction resource event and thought the presenters did a great job. Anyone entertaining the idea of going into the marijuana business if it does become legal in New Jersey should take pause, as Carpenito made it quite clear he may still choose to prosecute.

Mr. Smith said the Patriot's Day Ceremony was great, though it was held a bit later than originally planned. Frank Hafner, a local rescue squad member, was memorialized at the event.

Following up on the road aid bill and its strict timeline mentioned by County Engineer Bill Gleba in a prior discussion, Mr. Smith said he had an opportunity to meet with Senator Oroho and staff. As one of the prime sponsors of that legislation, Sen. Oroho said he was open to reexamining the issue and perhaps make it tiered so a portion of the money would still have to be spent within the timeline (like blacktop), but allow additional time for bridge design. "He was very receptive to that and he would also speak to Senator Sweeney as well," said Mr. Smith, adding he thought they were previously unaware of these timeline issues.

CLOSING PUBLIC COMMENTS

Jane Primerano of Hope Township wanted to make sure the Freeholders had the dates of September 20-22, 2019 noted on their calendars, as there will be events all three days celebrating the 250th anniversary of Hope Township. She then inquired about the proper verbiage to use when publicizing various events that received grants through what had formerly been the Warren County Cultural & Heritage Commission. A member of Warren County Community Singers, she said they – and other recipients – have been required to state that the presentations were partially funded by a grant from the Commission. "What should we put on our press releases and flyers and posters now?" she asked.

Mr. Marvin asked what required them to do that. "Um... the terms of the grant," said Ms. Primerano. "Consider it waived," said Mr. Marvin. The Board reassured her that the eligibility and status of such grant funding would stay the same, but the wording would no longer be required. Ms. Primerano said the New Jersey State Council on the Arts "gets a little touchy," so she wanted to ask the question publicly.

Next to come before the Board was Jody Liegel of Belvidere. She began by talking about having an issue with a trailer parked next to her house. She said town ordinances limit residing in trailers to 48 hours. She said this has been going on for years, with people staying for two to three months at a time. Mr. Smith interjected to clarify this was a town, not county, ordinance matter. Ms. Liegel said she had already approached Belvidere, and the mayor told her that they are not enforcing these rules. She said she spoke to someone in Trenton who advised her to come here.

Mr. Sarnoski explained that this is a local matter not under the jurisdiction of the Board of Chosen Freeholders, unless it was on county property. "It's purely a local issue," said Mr. Gardner. Aside from that, the Freeholders suggested she contact the State Department of Community Affairs. Ms. Liegel said she didn't understand how the town could fail to follow its own ordinances. Mr. Smith said the State has oversight over the municipalities; the County does not. He said there should be a zoning official to approach, but if she has gotten no satisfaction, he suggested she write down a formal complaint. If the town does not follow through, she should pursue it with the DCA.

Ms. Liegel moved on to the topic of Warren County Special Services School District. In her opinion, it was run into the ground until there were no classes. Mr. Smith said the WCSSSD was a separate board. It was still meeting, but no longer able to maintain itself with the costs it was incurring. She said she didn't understand how it was allowed to go into a deficit of something like \$1 million before closing. "That's like our money going down the drain," she said. Mr. Smith said that money is going to be predominately recovered because certified tuitions follow a few years later. It takes time to go through the audit process. Ms. Liegel asked why the person running it still holds their position and collects a salary. Mr. Smith said he could not answer that question, as he wasn't aware it was only one person responsible for it. It is an autonomous agency and the County does not fund it. After a few more questions and answers, Ms. Liegel returned to her seat.

There were no comment nor questions from the press.
