MINUTES MAY 22, 2019

The Board of Chosen Freeholders of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on May 22, 2019 at 7:30 p.m.

The meeting was called to order at 7:31 p.m. by Director Sarnoski and upon roll call, the following members were present: Freeholder James Kern, III, Freeholder Richard Gardner and Freeholder Jason Sarnoski. Also attending were County Administrator Alex Lazorisak, County Engineer Bill Gleba, Assistant County Counsel Joe Bell, IV and County CFO Kim Francisco.

Director Sarnoski led the Pledge of Allegiance.

Mr. Sarnoski read the following statement: OPEN PUBLIC MEETINGS ACT. ADEQUATE NOTICE OF THIS MEETING OF MAY 22, 2019 WAS GIVEN IN ACCORDANCE WITH THE OPEN PUBLIC MEETINGS ACT BY FORWARDING A SCHEDULE OF REGULAR MEETINGS OF THE BOARD OF CHOSEN FREEHOLDERS TO THE WARREN COUNTY CLERK, THE STAR-LEDGER, AND DAILY RECORD AND BY POSTING A COPY THEREOF ON THE BULLETIN BOARD IN THE OFFICE OF THE BOARD OF CHOSEN FREEHOLDERS. FORMAL ACTION MAY BE TAKEN BY THE BOARD OF CHOSEN FREEHOLDERS AT THIS MEETING. PUBLIC PARTICIPATION IS ENCOURAGED. IN ORDER TO ASSURE FULL PUBLIC PARTICIPATION, THOSE INDIVIDUALS WITH DISABILITIES WHO WISH TO ATTEND THE MEETING SHOULD SUBMIT ANY REQUESTS FOR SPECIAL ACCOMMODATION ONE WEEK IN ADVANCE.

Despite some technical difficulties that thwarted the ability to display a PowerPoint presentation, this did not deter Rev. Mandy Leverett and Rev. Gregory Quinlan from making a powerful call to action on behalf of the Church & Community Abolition Network (CAN). This is an effort to empower church and community to execute abolition including prevention, detection, action, advocacy, and survivor care relative to human trafficking. Rev. Leverett said to the audience, "YOU are the greatest weapon we have to combat human trafficking." She said this issue is everywhere, including Warren County. She relayed a few incidents of young people being lured under false pretenses through social media and game apps. Rev. Leverett said 83 percent of victims in the U.S. are our citizens, aged 11-14. Prevention, detection, outreach, advocacy, and survivor care are all ways CAN equips and engages citizens to make a difference locally.

They presented the following two action points:

- 1) SOAP (Save Our Adolescents from Prostitution) hotel outreaches, launched 10 years ago, provides bars of soap to hotels, as well as posters, with a phone number to call for help advising victims what to do. CAN sought to mobilize the entire state on June 16: one state, three hours, five locations, reaching 1,000 hotels to help rescue missing children trafficked in hotels, in honor of Father's Day weekend. The participating location closest to Warren County is Mountaintop Church on Naughright Road, Hackettstown. Individuals age 16 and older were invited to volunteer to go to every hotel and motel in the state to distribute posters with pictures of local missing children, packets of indicator information, and bars of hotel soap labelled with the national human trafficking hotline number. Teams will deliver the supplies to hotel staff and report back, usually finishing in less than three hours total.
- 2) Rev. Quinlan then spoke regarding the legislative endeavor, the Human Trafficking and Child Exploitation Prevention Act (S-540/A-878). "This bill is to protect our children," he said. He thanked the Freeholders for putting a resolution of support up for vote. Rev. Quinlan held up his smartphone, calling it a "triple-X movie theater" and providing further examples of how minors are targeted, including a music app endorsed by schools. The technology exists to prevent it, he said, which is what this legislation aims to achieve.
- Mr. Sarnoski said he had been impressed with the CAN presentation when he heard it in Sussex County, and was pleased to have the resolution (item E-1) on the agenda this evening. He said this would send a message to our Assembly members, as well as to other counties. He thanked them for coming.
- Mr. Gardner asked what kind of sentences are handed down to convicted perpetrators. Rev. Leverett said it parallels federal law a mandatory minimum 20 year jail sentence.
- Mr. Kern said he just recently read an article about some similar legislation in the U.K. being enacted a few years back. The presenters confirmed this, and said it is working over there. This portion of the meeting concluded at 7:48 p.m.

PROCLAMATION - TICK-BORNE DISEASE AWARENESS MONTH, MAY 2019

WHEREAS, from 2004-2016, human disease cases from ticks have doubled in the U.S.; while Lyme disease accounts for 82 percent of all reported tick-borne diseases, spotted fevers, babesiosis, anaplasmosis/ehrlichiosis, tularemia, and Powassan virus have become increasingly prevalent; and

WHEREAS, Lyme disease is the most commonly reported vector-borne disease in the U.S. and in Warren County; and

WHEREAS, the ticks that carry Lyme disease can also carry several other pathogens, many of which are reported in Warren County; and

WHEREAS, the risk of contracting tick-borne disease can be year-round, nymphal ticks, which are the immature stage responsible for the majority of disease transmission, are most active in the spring and summer months; and

WHEREAS, tick-borne diseases strike people of all ages, thereby making the need for public education regarding prevention, treatment, and control a priority; and

WHEREAS, recognizing and treating tick-borne disease early is important for the effective management of the disease; and

WHEREAS, taking steps to prevent tick bites can help prevent tick-borne diseases, including using insect repellent, reducing tick habitat, removing ticks promptly, and the judicious use of pesticides; and

NOW, THEREFORE BE IT RESOLVED that the Warren County Board of Chosen Freeholders recognizes May 2019 as Tick-borne Disease Awareness Month.

Mr. Kern said this is a very serious issue for Warren County. He was pleased that a bill is in congress to potentially create oversight and coordination for vector-borne diseases. He was happy the federal government, and New Jersey Legislature, were making some positive moves on these very serious issues. He thought it was very important to make our residents and visitors aware of this.

Mr. Gardner noted he pulled two ticks off himself the other day. They carry many different types of diseases, he said, so it is important to make the public more aware and be on guard.

Mr. Sarnoski said that in rural areas such as Warren and Hunterdon counties, we have been talking about tick-borne diseases for years. It's good to know the federal government is finally starting to recognize these risks. "It is going to be a bad tick year, folks," he said, due to excessive rain and mild temperatures. We don't have the money to combat it in Warren County; we can just monitor it, Mr. Sarnoski said. He encouraged everyone to be vigilant by using protection and checking for ticks after being outdoors.

Mosquito Superintendent, Jennifer Gruener brought a preserved deer tick and dog tick to pass around so people could see how small they are. She thanked the Board for the recognition, noting the State recently passed a proclamation as well. She said it was very important to know about other diseases carried by ticks in addition to Lyme. Ms. Gruener said every single tick disease has one symptom in common, which is a fever. If someone has an encounter with a tick, she advised making a note of the date, and consulting with a doctor if a fever presents itself a couple of weeks – or months - later.

Mr. Sarnoski thanked her, and said she and the commission are doing a great job.

REPORTS AND COMMENTS

Assistant County Counsel Joe Bell, IV said he had a few matters for discussion in Executive Session.

County Engineer Bill Gleba reported that the Morrie's Acres railroad tunnel bridge replacement project would begin on June 17. He said they would have started earlier, but the NJ DEP requires us to stay out of the stream April through mid-June. The southbound lane will be closed and detoured to Route 57 and Strykers Road. This project is expected to continue into November. "The roadway is ours to take care of; the tunnel is not ours, and we also have the bridge in there," he said, in response to Mr. Gardner's question about correcting some drainage issues.

County Planner Dave Dech followed up on the C-1 Stream Rule proposal mentioned at the Board's last meeting; the comment period deadline was extended from May 3 to June 3. He said our comments have not yet been sent, but will be by the deadline.

Mr. Dech reminded everyone of ParkFest @ Bread Lock Park 11 a.m. to 6 p.m. on June 8.

County CFO Kim Francisco had nothing further to report.

County Administrator Alex Lazorisak said the latest vacancy report contained nothing unusual, and the Freeholders made no comments.

After a brief discussion about the tradition of canceling two summer meetings to accommodate vacations, the matter was decided.

FREEHOLDER COMMENTS

Mr. Kern was pleased that the Stigma-Free Communities movement is proving successful, after Phillipsburg and Frelinghuysen passed resolutions recently, and Greenwich will be next.

"Really positive momentum there," he said. Mr. Sarnoski said another positive is that these communities are going to combine their efforts and work together as a group.

Mr. Kern noted that all three Freeholders participated in Warren County Community College's graduation, and it was a great moment for him, as an alum, to come full circle and speak at the event.

Regarding the Technology Task Force, Mr. Kern had a positive update. A brief survey will be going out to residents and businesses to obtain feedback on how they use the County website and other media. Public Information Officer Art Charlton created the survey, and it was expected to go out after Memorial Day. We have also begun updating the website in certain areas.

The final matter Mr. Kern raised was a desire to pass a resolution encouraging all County boards, commissions and agencies to work toward having public meeting times after regular business hours. "In the spirit of government transparency, I think it would be beneficial if we were meeting at times when most of our residents would be able to attend and participate in these meetings," he said. He understood there were some cases where this would not be appropriate, but thought a strong encouragement from the Board would be a positive step toward transparency.

- Mr. Gardner agreed with the concept, noting most of the meetings he attends are held in the evening.
- Mr. Sarnoski was inclined to agree, but pointed out that some of these boards require County staffing, which could create personnel difficulties. Volunteerism could also be affected, so he thought some of those meetings should continue to be held during the day.
- Mr. Sarnoski cited the Planning Board, Technical School, Community College, and Board of Chosen Freeholders as a few examples of entities that he thought were important to meet in the evening to encourage public participation. He said he would like to consider it on a case-by-case basis. Mr. Gardner said getting the public to come out and engage is the challenge.
- Mr. Lazorisak said certain commissions and authorities are autonomous and set their own times; the County has no authority to dictate when they meet.
- Mr. Kern said he understood the Freeholders can't force it, but he thought it was an important step to encourage evening meetings.
- Mr. Gardner talked about the recent NJAC Conference a bit, saying it was well attended and some great ideas were presented there. Regarding the College commencement, he said, "It was a great day", and complimented Mr. Kern on delivering a great speech. There were about 223 graduates.
- Mr. Sarnoski reported that the Addiction Awareness Task Force received a leadership award by the Coalition for Healthy and Safe Communities, saying it was nice to be recognized. The Special Services School District was also given an award for its work at the Hills House near Centenary University, where they teach life skills.

MINUTES MAY 22, 2019

Mr. Sarnoski had attended a meeting about the intersection of Routes 57 and 519, in an effort to get the NJ DOT and DEP moving on the project. Funding had been pushed back to the year 2023, but now say they will move it to 2021. The animal crossing issue has been resolved; DEP permitting for the hydrology is the next hurdle. "We are keeping our efforts very focused on that and continue to meet," he said.

CLOSING PUBLIC COMMENTS

Stan Prater of Jersey Central Power & Light said that last year JCP&L submitted a liability improvement plan to the Board of Public Utilities, which was approved in April (though not in its original form). The initial plan was to invest \$400 million over four years; the plan was condensed to 18 months, \$97 million. Starting on June 1, they will do some enhanced tree trimming in Warren and Hunterdon counties and put in "trip savers" to help restore customers more quickly. Work will be done in Lopatcong, Phillipsburg, Hope, Frelinghuysen, Greenwich and Harmony in June and July. Residential customers that use 760-kilowatt hours per month will see a 50-cent increase in their bills per month.

John Betts of Lopatcong had a few questions regarding the tunnel near Routes 519 and 57. Mr. Gleba clarified that the tunnel will not be replaced, but the bridge that the County owns within one of those tunnels.

Mr. Betts said the drug rehabilitation facility in Phillipsburg, Freedom House, was a very good organization. He thought this was an example of the Freeholder Board's integrity. "Thank you," he said to the Board.

Donna Bevington of Belvidere asked if the Freeholders were in favor of, or opposed to, the C-1 Stream upgrades. Mr. Sarnoski said right now, the County is making comments on the proposals. "But I can tell you that we're cautious about the proposal for the C-1 Stream designations," Mr. Sarnoski said. County Planner Dave Dech explained that the C-1 Stream designation carries a 300-foot buffer on either side of the stream, making development or upgrades to existing sewage treatment plans much more difficult. He said the proposal was contradictory. Even though the intention is to protect the water, this designation may make it more difficult to install or upgrade sewage treatment plans.

Dry riverbeds are included, Mr. Sarnoski said, and the Board has concerns. Mr. Gardner said, "I'm a no-change person. It's getting outrageous," he said. They were supposed to leave Warren County alone after they imposed the Highlands legislation.

Terry Urfer of the Hope Township Committee approached the Board on behalf of the committee to express concerns regarding the Jaindl warehousing proposal in White Township. We are obviously concerned about the traffic, he said. The town is preparing for its 250th anniversary celebration in September, and he said there is no way the old buildings can handle the truck traffic this will bring to the area. Hope's constituents are very upset. "This will just destroy the town," he said, and stated an intention to "go everyplace we can" to discuss how to mitigate this situation.

MINUTES MAY 22, 2019

Tom Bodolsky introduced himself as a professional engineer, and said he wanted to reinforce Mr. Urfer's concerns a bit more emphatically. While he understood that there is no application before White Township, he said he ran some figures based on the conceptual meeting, and arrived at traffic generation of as many as 20,000 trucks a day. For reference, he said according to NJ DOT, Route 519 north of Route 46 carries 370 trucks a day. He urged the Freeholders to start planning, because once this facility comes in, "It's going to absolutely change the complexion of this county," he said.

Mr. Bodolsky hoped the Freeholders would give some directive to the County Planner and Engineer to look into this, saying he was more than happy to share his figures. Once this comes in, he said, it will be too late.

Mr. Gardner stated where Route 519 intersects with Route 46, trucks will have to go up Route 46.

Mr. Sarnoski reiterated that there is no application before the County, and he has never heard a complaint that the County Engineer and Planning Department were not thorough enough. "When the time comes," Mr. Sarnoski said, "I guarantee they will take it with as much seriousness as we all expect, and obey every law of the State of New Jersey and every rule and regulation governing County roads and their usage."

Mr. Bodolsky continued to express concerns, including the potential widening of Route 519.

Regarding the C-1 Stream upgrades, Sara Hare of Delaware Road in Hope said she was unclear on the Board's position. She said she supported the DEP proposal, and encouraged everyone to read it in its entirety. It is very detailed in how it is protecting streams. She acknowledged the impact on businesses may be a concern, but encouraged the Board to support our ecosystems.

Mr. Gardner agreed we have to protect our water supply, but was very concerned about the overreach on private property.

Mr. Sarnoski said he has seen the DEP's overreach. "Right now, we are making our comments, and we will see what comes back to get a better picture of what the agreements will be."

With the Highlands, Mr. Sarnoski said, we showed that going from 80-acre zoning to 20-acre zoning had no impact on the water quality and nitrate dilution. There was agreement among environmentalists and the Highlands Council, but to no avail.

Commenting on the truck traffic concerns, John Betts said he thought there might be a future possibility to create a spur from Route 80 to Route 78. He advised the Board to keep their eyes open.

There were no comments or questions from the press.
