The Board of Chosen Freeholders of the County of Warren met in Regular Session in its offices in the Wayne Dumont, Jr. Administration Building, Belvidere, New Jersey on December 11, 2019 at 7:00 p.m.

The meeting was called to order by Director Sarnoski and upon roll call, the following members were present: Freeholder James Kern, III, Freeholder Richard Gardner and Freeholder Jason Sarnoski. Also attending were County Administrator Alex Lazorisak, County CFO Kim Francisco and County Counsel Joe Bell. County Engineer Bill Gleba was absent.

Following the flag salute, Mr. Sarnoski read the following OPEN PUBLIC MEETINGS ACT (Open Public Meetings Act, Chapter 231, P.L. 1975) statement: ADEQUATE NOTICE OF THIS MEETING OF DECEMBER 11, 2019 WAS GIVEN IN ACCORDANCE WITH THE OPEN PUBLIC MEETINGS ACT BY FORWARDING A SCHEDULE OF REGULAR MEETINGS OF THE BOARD OF CHOSEN FREEHOLDERS TO THE WARREN COUNTY CLERK, THE STAR-LEDGER, AND DAILY RECORD AND BY POSTING A COPY THEREOF ON THE BULLETIN BOARD IN THE OFFICE OF THE BOARD OF CHOSEN FREEHOLDERS. FORMAL ACTION MAY BE TAKEN BY THE BOARD OF CHOSEN FREEHOLDERS AT THIS MEETING. PUBLIC PARTICIPATION IS ENCOURAGED. IN ORDER TO ASSURE FULL PUBLIC PARTICIPATION, THOSE INDIVIDUALS WITH DISABILITIES WHO WISH TO ATTEND THE MEETING SHOULD SUBMIT ANY REQUESTS FOR SPECIAL ACCOMMODATION ONE WEEK IN ADVANCE.

On motion by Mr. Gardner, seconded by Mr. Kern, the minutes of the Regular Session of November 26, 2019 were approved.

Mr. Sarnoski invited Warren County Community College President Dr. Will Austin to share his technical report on Economic Development and Warren County Land Use Boards, which had been presented to the Economic Development Committee at an earlier date. Dr. Austin promised this version would not be as detailed in the interest of time constraints. He explained that this was a research project that examined data with a three-pronged approach: review of the literature, contextual analyses of land use minutes, and contextual analyses of focus group responses. He emphasized this was not a case study of any one single project; the research was aggregate, and examined a timeline of March 2019 to November 2019.

Regarding the literature, Dr. Austin reported that there was not much available; that no one was an expert; and that this data was academic, not opinion. The study found the following literature-based impediments: absence of risk-taking culture; lack of business incentive; and excessive regulation and over-interpretation of regulations. A successful endeavor would require cross collaboration; leadership; and communication between politicians, economic development committees, business leaders, land use board members, and the overall community with regard to

economic development.

Collaboration impediments include political barriers (not necessarily republican vs. democrat, but all levels, including personal); lack of financial resources; lack of leadership capacity to maneuver the complexities of collaboration; and collaboration risk (lack of communication, competition, undermining, sabotage, and/or inability to see project through to completion).

#### To expand economic development, Dr. Austin presented the following list:

- 1. Focus on the end rather than the means (he noted there tends to be a focus on regulations rather than the goal)
- 2. Gather stakeholder input
- 3. Engage in continual review of policies and their outcomes
- 4. Time is money
- 5. Build relationships
- 6. Examine restrictive land development regulations
- 7. Check the regulator as well as the regulation (have the right people on board)
- 8. Government should practice what they preach

Key issues are leadership, collaboration, communication and to lead change through planning. To get where you want to go, you need a common vision.

Extensive objective review of land use board minutes for all Warren County municipalities revealed the following timeline of the 70 applications submitted for review: 16 (26%) took less than six months to review; 32 (46%) took approximately one year; and 22 (31%) took significantly longer than one year.

Other findings in the minutes revealed that there was no consistent minute format; almost no occurrence of inter-municipal collaboration or communication; evidence of over-interpretation and over-regulation (17 percent of applications that took significantly longer than one year currently appear to be in active litigation); and economic development in Warren County is almost non-existent.

Although more developed areas that remain in the Highlands planning area tended to process applications faster than those boards that were in more rural preservation zones, these boards in the planning area experienced an usual number of meeting cancellations that slowed down the economic development process. One board cancelled nine meetings in a single year, cancelling meetings for six consecutive months. Another board cancelled eight meetings in a year, five consecutively. Another appears to follow the practice of cancelling meetings every other month.

The following conclusions were reached after examining the minutes:

- · Regional communication and collaboration are non-existent
- No evidence of centralized leadership and a strategic plan for economic development
- Minutes should be examined by local municipal policy makers, as there is evidence of over

interpretation/enforcement of regulations

- No uniformity with regard to economic development priorities in minutes; only similarity was addressing COAH requirements
- Land use boards are passive reactors; no evidence of proactive initiatives for economic development in planning, leadership or collaboration

Dr. Austin then delved into the Focus Group component of the study, explaining the process and describing the eight participants representing six municipalities.

#### Focus Group findings:

- Growth is good, when it is where it belongs
- Some towns want no development
- Towns have infrastructure issues
- Lack of communication from policy makers
- Lack of collaboration
- No knowledge of Warren County Economic Development Committee
- Now known leadership
- Desire for communication, plans and leadership

#### Overall Focus Group conclusions:

- Need to focus on the issue itself, not how difficult the issue is
- Need for centralized leadership
- Need for planning, communication, or collaboration
- Volunteers need guidance and do not always have time

#### <u>Impediments to Economic Development:</u>

- Political barriers
- Over-regulation and over interpretation of regulations
- Lack of financial resources dedicated to economic development
- Lack of infrastructure

Dr. Austin's study concluded that economic development is an extremely competitive process, and the small number of applications in Warren County appear to correlate with the fact that processing applications on the municipal level are both arduous and expensive. Applicants go elsewhere.

A list of 10 detailed recommendations was presented, the first one being the suggestion that both the EDC and Freeholders would be well served by a full-time permanent and accountable administrator with the ability to coordinate, communicate and implement economic development policies, plans and communication strategies. Further recommendations centered on communication; the development of an Economic Development Master Plan linked to the County's current Land Use Master Plan; uniformed practices in taking minutes; land use board chairs to meet twice a year to collaborate; a training program for land use board members; comprehensive review of local ordinances and limitations addressed to match development goals;

and political leaders should develop consensus on economic development goals of Warren County and surrounding communities.

Dr. Austin's presentation now complete, Mr. Sarnoski expanded on the origins of the study and provided feedback. He said members of the Warren County Economic Development Committee (EDC) wondered what the barriers were to economic development in the county. There were a number of opinions; was it the NJ DEP, county regulations, state regulations? Hence the decision for the college to conduct an unbiased study. "There's a lot in here that I would say people don't want to hear," Mr. Sarnoski said, "From the county, from municipalities, it's not all rosy, that we're doing what we need to do."

He said we learned the process is reactive, not proactive. People want the county to take more of a leadership role in development, but there seems to be a lack of understanding that we're a home-rule state in which land use is determined by municipalities and limited by the state, in terms of the Highlands Act and things like that. "The county isn't a big driver of how economic development is done within the county," said Mr. Sarnoski, "But I think local municipalities are looking for more leadership out of the county." We do need to reexamine our own policies, and there needs to be better communication, but communication is a two-way street.

Mr. Sarnoski said he thought the Freeholders were taking a more proactive stance, noting the rural transportation study initiated by Mr. Kern and funded by the Highlands Council, and having initiated dialog with the mayors about infrastructure improvements. He said if we want to do real economic development, a significant investment is required, starting with a full-time employee to lead the endeavor, as well as investing money into examining rules and regulations and communicating with the towns. "At the end of the day, even if we do all that, it doesn't mean the towns have to take our advice, because it's still a home-rule state," said Mr. Sarnoski. Further, are we trying to solve a problem that we don't have? If we don't want to be an economic development county, why would we put resources into that? Mr. Sarnoski wondered. He said he didn't know where we should go from here, but the EDC is looking at it very strongly.

Mr. Gardner complimented Dr. Austin on a great presentation. He shared the perspective of having served on his local land use board for 17 years. He agreed communication and collaboration are ongoing issues not easily addressed, and that over-regulation was often detrimental to small businesses. He thought leadership from a Freeholder Director would yield better results than from a paid staffer. We should be working geographically and collaboratively, he said.

Mr. Kern praised the phenomenal research and found the data interesting. He said he would really like to see another aspect to the study, from the perspective of the applicants. "Zoning is local," he said, and in his experience local land use board meetings are actually run by the land use attorney, engineer and planner who see an advantage in dragging the process out in terms of billable hours. He said he thought the biggest obstacle is ourselves - the municipalities - and as long as the local government doesn't act to allow development, they will never allow it.

Mr. Kern spoke of a recent transportation study meeting, in essence a "red alert" for development that is occurring in Warren County. All municipalities were strongly encouraged to attend, and 14 of 22 municipalities were represented. "If that doesn't get municipalities to show up at a meeting, I don't know what makes them think just a normal quarterly meeting will," Mr. Kern said.

Mr. Sarnoski said the EDC was going to examine this study closely in the coming year. We have to ask of ourselves if we really want to invest resources in economic development in this county.

Mr. Sarnoski opened the topic up for public comment, and Sarah Hare from Hope said she was very emotional listening to this discussion, and was grateful to the Board for having it. "I'm so happy to hear you discussing this issue in this way," she said. A member of the Citizens for Sustainable Development organization, Ms. Hare said she would like to be involved in the endeavor. She was familiar with the individual working on economic development in Hunterdon County, and exciting things are happening there. Mr. Sarnoski and Mr. Kern were familiar with the Hunterdon County program and agreed the person was impressive, but Mr. Sarnoski estimated that Hunterdon invested about \$1 million in that program.

This portion of the meeting concluded at 7:49 p.m.

**WHEREAS,** Warren County is a partner in the effort to make our roadways safer by promoting awareness of the problems associated with driving under the influence; and

WHEREAS, community-based programs provide drug and alcohol education and treatment services as well as advocate for more effective laws and stronger police enforcement which have proven to be successful in reducing impaired driving; and

WHEREAS, organizations from every county are joining together to provide safe rides home for potential drunk drivers to improve our state's roadways and support sober driving programs and policies; and

NOW, THEREFORE, BE IT RESOLVED that the Warren County Board of Chosen Freeholders

does hereby proclaim December 2019 as National Impaired Driving Prevention Month in Warren County. The Board of Chosen Freeholders calls upon all citizens, agencies, business leaders, hospitals, schools, and public and private institutions in Warren County to support programs and policies to reduce the incidence of impaired driving, encourage more responsible driving and increase public safety during this December holiday season and throughout the year.

Mr. Gardner said the statistics are tragic. He supported the proclamation, but thought prevention should start in the home, as opposed to seeking help from law enforcement agencies.

Mr. Kern echoed Mr. Gardner's remarks, saying now is the time we are gathering with family and friends, and we have Uber and Lyft even here in Warren County. Think smart, do the right thing, don't put yourself and others in danger, he said.

Mr. Sarnoski thought the likelihood of marijuana becoming legal in our densely populated state added more complications to this serious issue. He said we should be working toward reducing negative impacts. He encouraged everyone to be a designated driver.

Human Services Director Shawn Buskirk accepted the proclamation on behalf of LACADA (Local Advisory Council on Alcohol and Drug Abuse) and the Human Services Advisory Council. She said with the holidays approaching, Thanksgiving Eve is still the number one holiday in terms of impaired driving violations. "Whatever decision you make after drinking is an impaired decision," said Ms. Buskirk, and urged all to be safe over the holidays.

#### **REPORTS AND COMMENTS**

County Counsel Joe Bell said he had a brief update for Executive Session regarding litigation (W.M. and Selective).

County Engineer Bill Gleba was absent.

County Planner Dave Dech reported on a very successful census committee meeting the prior day. They divided into two groups - interagency coordination and marketing – assigned some tasks, and plan to meet again in January.

Mr. Dech said a recent traffic meeting also went well. Mr. Sarnoski wondered what would be involved if the County took more of an active role in local land use and planning assistance, for consideration in the coming year. Mr. Dech said one very important endeavor for next year was obtaining money from the North Jersey Transportation Planning Authority for a transportation plan, something that has been in the works for two years, and closely related to land use. He expected to hire a consultant early next year to take on that task. Mr. Sarnoski then mentioned infrastructure matters, sewer line extensions and capacity, and internet technology availability. They are all interlinked.

County CFO Kim Francisco said the 2020 budget was coming together nicely, with a few items outstanding, but will be ready for January budget sessions.

County Administrator Alex Lazorisak had only the vacancy report. There was some discussion regarding personnel needs in the library system, with Civil Service difficulties in terms of waiting for tests to be conducted and lists to be generated. The economy is good, and there are not a lot of people seeking government jobs in general right now. On top of that, the state residency requirement took Pennsylvania residents out of the running. "It's getting tougher," Mr. Lazorisak said. Mr. Sarnoski said we should talk about our overall organizational plan in the coming year.

#### **FREEHOLDER COMMENTS**

Mr. Kern picked up on the transportation meeting mentioned by the County Planner earlier. He complimented Mr. Dech and the rest of the Planning Department for a tremendous job putting together that presentation. He said attendance turned out to be better than expected after some effort to generate more interest. He thought feedback from the municipalities was positive for the most part, and eye opening for some, in terms of some surprising neighboring zoning. Southern municipalities shared their concerns regarding warehouse traffic, and Lisa Plevin of the Highlands Council provided information about available grant opportunities.

The Transportation & Technology Task Force met the previous evening for two website development presentations. One company designed websites for Somerset and Mercer counties, the other for Cape May County, and he encouraged his colleagues to peruse those sites. The group is pursuing and aggressive timeline, hoping to debut a new website for next year's Farmers' Fair.

Mr. Kern and Mr. Gardner participated in a Christmas tree-cutting season kick-off in Blairstown the prior week, along with the NJ Secretary of Agriculture. He noted that as much as Warren County celebrates its rural character, it does not have a federal designation as being rural, leaving us in a bit of "limbo" in terms of the types of grants for which we are eligible. Mr. Kern said Secretary Fisher expressed willingness to continue to work on trying to get the designation changed. Mr. Gardner said we have a strong record of obtaining urban rural economic development grants, so it depends on what we are seeking.

Mr. Kern wished all Happy Holidays: Christmas, Hanukkah and New Year.

Mr. Gardner said NJAC's end of year summit was coming up, with the somber topic of suicide to be discussed. He wished everyone a Merry Christmas and Happy Hanukkah, and looked forward to seeing everyone in the New Year.

This being the last Freeholder meeting of the year, Mr. Sarnoski joined his colleagues in wishing all Happy Holidays, and hoped to see everyone at the annual reorganization meeting at noon on January 4 at the courthouse. "Thank you, everyone, for a great year, and I hope you have a safe an happy holiday," Mr. Sarnoski said.

There were no closing public comments. Mr. Sarnoski would address a question from the local radio station following the reading of the resolution to go into Executive Session.
