#### **Old Business:**

### Montalvena Farms, BL 5200 Lot 600 Hope Township discussion -

Mr. Tierney talked with the Board regarding the options for proceeding with the RTF hearing. Mr. Montalvo and his attorney are ready to come for the February meeting; they wanted to come in January, but another RTF hearing is already scheduled for this meeting. The Board would like Mr. Culton to write a letter stating that no further extensions on the RTF Hearing, that they have to re-notice for the RTF hearing, that they have to meet Certification requirements, and must provide health certificates that were requested at the last hearing meeting by Mr. Bodine. If the applicant does not show in February, then the RTF Hearing may be administratively dismissed. Mr. Tierney said that Mr. Culton will be present at the next meeting and it can be discussed further at that time.
