The Board of County Commissioners of the County of Warren met in Regular Session at a travel meeting located at Allamuchy Township, 292 Alphano Road, Allamuchy, New Jersey on Tuesday, April 23, 2024 at 6:00 p.m.

REPORTS AND COMMENTS

County Counsel Joe Bell was happy to advise this week no new lawsuits have been filed against the county.

County Engineer Bill Gleba had nothing new to report this evening.

Assistant County Planning Director Ryan Conklin had nothing new to report this evening.

County Public Works Director Emily Hammer was absent this evening.

County CFO Kim Francisco reported last week second payment had been received from FEMA in the amount of \$281,000. To date we have received two payments for a reimbursement total amount of \$515,000 for the July 2023 storm repairs.

County Administrator Alex Lazorisak had only the vacancy report, nothing out of the ordinary, backfill of a few positions. He commented we are continuing to slowly filling the positions.

COMMISSIONER COMMENTS

Ms. Ciesla announced there will be a meeting with the Bicentennial Cultural and Heritage Advisory Board and the Economic Development Advisory Council, tomorrow night, Wednesday, April 24, 2024 at 7:00 p.m. at the Wayne Dumont, Jr. Administration Building, Commissioners' Meeting Room. The meeting will be held in-person and virtual. Representative from the State of New Jersey to speak about Revolutionary New Jersey will be in attendance. As Warren County prepares for the celebration of the bicentennial in 2025, we are trying to get the municipalities and businesses involved to best promote our county. In 2026, we will celebrate the semiquincentennial of our nation, the state is planning for this celebration as well and trying to get the municipalities and counties to take part.

Next Ms. Ciesla announced the annual Health and Wellness Day will be held on Friday, May 3rd at Phillipsburg High School from 6:00 – 9:00 p.m. This event is open to all ages, there will be free food, games as well as the opportunity to learn how to take care of themselves mentally and physically. Ms. Ciesla invited the Environmental Commission to attend with their Conservation Challenge.

Ms. Ciesla thanked Mr. Kern for the moment of silence in remembrance of Victor Camporine. She had served on Lopatcong Council with Mr. Camporine, Ms. Ciesla stated, “He will be missed.”

Mr. Sarnoski reflected on how he knew Mr. Camporine, living around the block from him. “He was a great man.”

He extended his appreciation to the audience for coming out this evening and providing feedback and questions to the Board. Mr. Sarnoski also took this opportunity to thank Mayor Tuohy and the Township of Allamuchy for the warm welcome and hosting the Commissioners meeting and providing snacks. As well as thanked the Administrator and team for adapting to the travel meeting.

Mr. Sarnoski stated, Mayor Tuohy is doing a great job advocating for her town and he looks forward to continuing to work with her and the township on the road exchanges. County Administrator is looking at the plans and we will get through the challenges that need to be worked out.

Mr. Sarnoski reflected on his visits to Allamuchy, it reminds him of his good friend Betty Schultheis as we lost her recently and how much better she made Allamuchy.

Mr. Kern thanked Mayor Tuohy and Council for their hospitality. This allows the residents to see county government in action.

Mr. Kern expressed his thanks to the Allamuchy Environmental Committee and the Green Team with the work that they have done with the county environmental committee. This was very fitting with the ideas gathered at the county level has come from the township level, this speaks to the work done by the Clairanne, Charlie and everyone in Allamuchy does.

Mr. Kern announced he will be attending the Hope Green Fair on Saturday, April 27, in Hope Township. This event is organized by Monica Sabo, chairwoman of Hope Township’s Environmental Commission.

He also reported on a successful kickoff this past weekend of the Conservation Challenge at the Phillipsburg Farmers market.

At this time Mr. Kern welcomed Mayor Tuohy to make any comments. Mayor Tuohy took this opportunity to thank the County Commissioners for always being there to take her calls and also working with the township. Mayor Tuohy introduced the Township Council members. Present were Manny Quinoa and Edward Fabula, due to work commitments Deborah Bonanno and Suzanne Chamberlain, were unable to attend.

CLOSING PUBLIC COMMENTS

Aaron Hyndman, resident of Independence Township and Chair of the Mental Health Board, came before the Board to thank them for being at Allamuchy Township. Mr. Hyndman looks forward to seeing the Board at future meetings.

Mr. Hyndman presented his concerns regarding storm water management. With regards to the landscape changes due to the storms, puddles are now ponds; vernal ponds are now lakes. He had asked a couple of questions of the Board. First questions, How are we addressing run-off issues? Also second question, what is Warren County doing to combat this storm water issues?

Mr. Kern replied the storms last year, County government, administration, engineering, public works has been talking not just about rebuilding but resiliency planning. We are trying to make sure that as these storms become more frequent, County infrastructure will be able to withstand them. The GIS work the Planning Department is doing is allowing us to have a better understanding of where some of the deficiencies are in our infrastructure. As the State turns out their master plan, the County will be working on ours to determine what can we be doing differently, what can we be doing smarter. It's on our radar. If there is anything positive that has come out of the storm, it is the bringing awareness to this type of planning.

Mr. Sarnoski commented about the recent flooding on Spring Valley Road in Allamuchy. He is hoping that our State agencies, such as DEP will be friendlier with us in the future. As we address some of these issues and make improvements. Mr. Sarnoski thanked Mr. Hyndman for coming out this evening.

Concerned citizen, Melanie Taylor, came before the Board with concerns regarding theft that had taken place several times at Marshals in Hackettstown. Mr. Kern encouraged Ms. Taylor contact Hackettstown Mayor and the Chief of Police to discuss her concerns, being this is a municipal issue and Warren County does not have jurisdiction over law enforcement.

Sarah Hare, resident of Hope Township, spoke regarding the Highlands Council meeting of last Thursday, and the closing of the White Township property will be held on May 13, 2024, at the Highland Council Building.

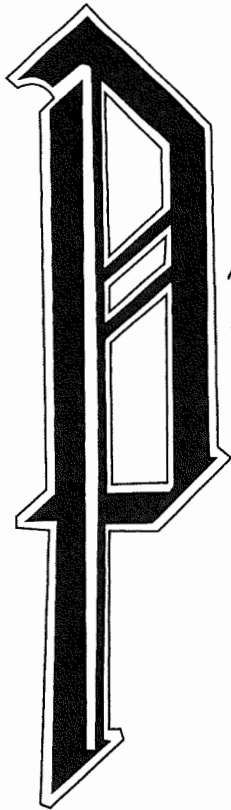

WHEREAS, Earth Day gives us the opportunity to celebrate our Planet and recommit to preserving and protecting it; and

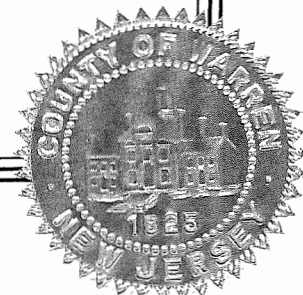
